1 AN ACT concerning crimes, punishment and criminal procedure;
2 increasing the penalties for the crimes of endangering a child and
3 aggravated endangering a child if the child is less than six years of age;
4 amending K.S.A. 2025 Supp. 21-5601 and repealing the existing
5 section.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 2025 Supp. 21-5601 is hereby amended to read as
9 follows: 21-5601. (a) Endangering a child is knowingly and unreasonably
10 causing or permitting a child under ~~the age of~~ 18 years *of age* to be placed
11 in a situation in which the child's life, body or health may be endangered.

12 (b) Aggravated endangering a child is:

13 (1) Recklessly causing or permitting a child under ~~the age of~~ 18 years
14 *of age* to be placed in a situation in which the child's life, body or health is
15 endangered;

16 (2) causing or permitting such child to be in an environment where
17 the person knows or reasonably should know that any person is
18 distributing, possessing with intent to distribute, manufacturing or
19 attempting to manufacture any methamphetamine or any fentanyl-related
20 controlled substance; or

21 (3) causing or permitting such child to be in an environment where
22 the person knows or reasonably should know that:

23 (A) Drug paraphernalia or volatile, toxic or flammable chemicals are
24 stored or used for the purpose of manufacturing or attempting to
25 manufacture any methamphetamine; or

26 (B) drug paraphernalia or toxic materials, compounds or mixtures are
27 stored or used for the purpose of manufacturing or attempting to
28 manufacture any fentanyl-related controlled substance.

29 (c) (1) Endangering a child is a:

30 (A) Class A person misdemeanor *if the child is at least six years of*
31 *age but less than 18 years of age; and*

32 (B) *severity level 9, person felony if the child is less than six years of*
33 *age.*

34 (2) *Except as provided in subsection (c)(3), aggravated endangering a*
35 *child is a:*

36 (A) Severity level 9, person felony ~~except as provided in subsection~~

1 ~~(e)(2)(B)~~ if the child is at least six years of age but less than 18 years of
2 age; and

3 (B) severity level 8, person felony if the child is less than six years of
4 age.

5 (3) Aggravated endangering a child when bodily harm is inflicted
6 upon the child is a:

7 (A) Severity level 6, person felony ~~when bodily harm is inflicted~~
8 ~~upon the child~~ if the child is at least six years of age but less than 18 years
9 of age; and

10 (B) severity level 5, person felony if the child is less than six years of
11 age.

12 ~~(3)(4)~~ The sentence for a violation of aggravated endangering a child
13 shall be served consecutively to any other term or terms of imprisonment
14 imposed. Such sentence shall not be considered a departure and shall not
15 be subject to appeal.

16 (d) Nothing in subsection (a) shall be construed to mean a child is
17 endangered for the sole reason *that* the child's parent or guardian, in good
18 faith, selects and depends upon spiritual means alone through prayer, in
19 accordance with the tenets and practice of a recognized church or religious
20 denomination, for the treatment or cure of disease or remedial care of such
21 child.

22 (e) As used in this section:

23 (1) "Drug paraphernalia," "fentanyl-related controlled substance" and
24 "manufacture" mean the same as defined in K.S.A. 21-5701, and
25 amendments thereto; and

26 (2) "methamphetamine" means any substance designated in K.S.A.
27 65-4107(d)(3) or (f)(1), and amendments thereto, or any analog thereof.

28 Sec. 2. K.S.A. 2025 Supp. 21-5601 is hereby repealed.
