HOUSE BILL No. 2513

By Joint Committee on Special Claims Against the State

AN ACT concerning certain claims against the state; making appropriations therefor; authorizing certain transfers; imposing certain restrictions and limitations; directing or authorizing certain disbursements, procedures and acts incidental to the foregoing.

Be it enacted by the Legislature of the State of Kansas:

Section 1. For the fiscal year ending June 30, ~~2026~~ **2027**, appropriations are hereby made, restrictions and limitations are hereby imposed, and transfers, disbursements, procedures and acts incidental to the foregoing are hereby directed or authorized as provided in this act.

22 Sec. 4. (a) Except as otherwise provided by this act, the director of
23 accounts and reports is hereby authorized and directed to draw warrants on
24 the state treasurer in favor of the claimants specified in this act, upon
25 vouchers duly executed by the state agencies directed to pay the amounts
26 specified in such sections to the claimants or their legal representatives or
27 duly authorized agents, as provided by law.

28 (b) The director of accounts and reports shall secure prior to the
29 payment of any amount to any claimant a written release and satisfaction
30 of all claims and rights against the state of Kansas and any agencies,
31 officers and employees of the state of Kansas regarding their respective
32 claims.
