1 AN ACT concerning courts; relating to municipal court assessments;
2 increasing certain municipal court fee assessments; crediting such
3 assessment increase to the Kansas commission on peace officers'
4 standards and training fund and the crime victims assistance fund;
5 amending K.S.A. 2025 Supp. 12-4117 and repealing the existing
6 section.

8 *Be it enacted by the Legislature of the State of Kansas:*

9 Section 1. K.S.A. 2025 Supp. 12-4117 is hereby amended to read as
10 follows: 12-4117.(a) In each case filed in municipal court other than a
11 nonmoving traffic violation, where there is a finding of guilty or a plea of
12 guilty, a plea of no contest, forfeiture of bond or a diversion, a sum in an
13 amount of ~~\$22.50~~ \$28 shall be assessed and such assessment shall be
14 credited as follows:

15 One dollar to the local law enforcement training reimbursement fund
16 established pursuant to K.S.A. 74-5620, and amendments thereto, \$11.50
17 to the state general fund, ~~\$5~~ \$10 to the Kansas commission on peace
18 officers' standards and training fund established by K.S.A. 74-5619, and
19 amendments thereto, \$2 to the juvenile alternatives to detention fund
20 established pursuant to K.S.A. 79-4803, and amendments thereto, to be
21 expended for operational costs of facilities for the detention of juveniles,
22 \$.50 to the protection from abuse fund established pursuant to K.S.A. 74-
23 7325, and amendments thereto, ~~\$.50~~ \$1 to the crime victims assistance
24 fund established pursuant to K.S.A. 74-7334, and amendments thereto, \$1
25 to the trauma fund established pursuant to K.S.A. 75-5670, and
26 amendments thereto, and \$1 to the department of corrections forensic
27 psychologist fund established pursuant to K.S.A. 75-52,151, and
28 amendments thereto.

29 (b) The judge or clerk of the municipal court shall remit the
30 appropriate assessments received pursuant to this section to the state
31 treasurer in accordance with the provisions of K.S.A. 75-4215, and
32 amendments thereto. Upon receipt of each such remittance, the state
33 treasurer shall deposit the entire amount in the state treasury to the credit
34 of the local law enforcement training reimbursement fund, the Kansas
35 commission on peace officers' standards and training fund, the juvenile

1 alternatives to detention fund, the crime victims assistance fund, the
2 trauma fund, the department of corrections forensic psychologist fund and
3 the state general fund as provided in this section.

4 (c) For the purpose of determining the amount to be assessed
5 according to this section, if more than one complaint is filed in the
6 municipal court against one individual arising out of the same incident, all
7 such complaints shall be considered as one case.

8 Sec. 2. K.S.A. 2025 Supp. 12-4117 is hereby repealed.

9 Sec. 3. This act shall take effect and be in force from and after its
10 publication in the statute book.
