1 AN ACT concerning the secretary of corrections; relating to the prison-
2 made goods act of Kansas; permitting certain contracts for the
3 production of manufactured or modular homes; amending K.S.A. 75-
4 5275a and repealing the existing section.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. K.S.A. 75-5275a is hereby amended to read as follows: 75-
8 5275a. (a) ~~Notwithstanding any provision of the prison-made goods act of~~
9 ~~Kansas to the contrary Except as provided in subsection (b),~~ the secretary
10 shall not establish or maintain a home building program—which
11 manufacturers that manufactures or produces housing units—which that
12 would compete with the:

13 (1) (A) Manufactured homes or modular homes manufactured,
14 assembled or sold by manufactured home manufacturers; or
15 (B) manufactured homes or modular homes sold by manufactured
16 home dealers; or
17 (2) (A) modular homes manufactured, assembled or sold by modular
18 home manufacturers; or
19 (B) modular homes sold by modular home dealers.

20 (b) *The provisions of this section shall not apply to:*

21 (1) *The vocational building program; or*
22 (2) *any contract authorized by K.S.A. 75-5275(c), and amendments*
23 *thereto.*

24 (c) As used in this section:

25 (1) ~~"Manufactured home," has the meaning ascribed to such term by~~
26 ~~"manufactured home dealer," "manufactured home manufacturer" and~~
27 ~~"modular home" mean the same as defined in K.S.A. 58-4202, and~~
28 ~~amendments thereto;~~

29 (2) ~~"manufactured home dealer" has the meaning ascribed to such~~
30 ~~term by K.S.A. 58-4202, and amendments thereto;~~

31 (3) ~~"manufactured home manufacturer" has the meaning ascribed to~~
32 ~~such term by K.S.A. 58-4202, and amendments thereto;~~

33 (4) ~~"modular home" has the meaning ascribed to such term by K.S.A.~~
34 ~~58-4202, and amendments thereto; and~~

35 (5) "secretary" means the secretary of corrections; and

36 (6)(3) "vocational building program" means the vocational building

1 program operated by the secretary to provide individual, freestanding
2 buildings, not to exceed 1,000 square feet in size, to state agencies for use
3 by such agencies.

4 ~~(e) The provisions of this section shall not apply to a vocational
5 building program.~~

6 (d) This section shall be a part of and supplemental to the prison-
7 made goods act of Kansas.

8 Sec. 2. K.S.A. 75-5275a is hereby repealed.

9 Sec. 3. This act shall take effect and be in force from and after its
10 publication in the Kansas register.
