AN ACT enacting the anesthesiologist assistant licensure act; providing for the powers, duties and functions of the state board of healing arts thereunder; amending K.S.A. 65-1163 and 65-28,127 and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

New Section 1. Sections 1 through 12, and amendments thereto, shall be known and may be cited as the anesthesiologist assistant licensure act.

New Sec. 2. As used in the anesthesiologist assistant licensure act:

(a) "Anesthesiologist" means a physician who has completed a residency in anesthesiology approved by the American board of anesthesiology or the osteopathic board of anesthesiology.

(b) "Anesthesiologist assistant" means a person who is licensed in accordance with the provisions of this act and who provides patient services under the direction and supervision of a supervising or designated anesthesiologist.

(c) "Applicant" means a person who submits an original application for, or reinstatement of, any license, registration, permit or certificate.

(d) "Board" means the state board of healing arts.

(e) "Designated anesthesiologist" means an anesthesiologist designated by the supervising anesthesiologist to ensure direction and supervision of the anesthesiologist assistant.

(f) "Direction and supervision" means the guidance, direction and coordination of the activities of an anesthesiologist assistant by such anesthesiologist assistant's supervising or designated anesthesiologist, whether written or verbal, whether immediate or by prior arrangement, in accordance with standards established by the board by rules and regulations, which standards shall be designed to ensure adequate direction and supervision by the supervising or designated anesthesiologist of the anesthesiologist assistant.

(g) "License" means any license or temporary license granted under the anesthesiologist assistant licensure act.

(h) "Licensee" means all persons issued a license or temporary license pursuant to the anesthesiologist assistant licensure act.

(i) "Physician" means any person licensed by the state board of healing arts to practice medicine and surgery.

1 (j) "Supervising anesthesiologist" means an anesthesiologist who has
2 accepted continuous and ultimate responsibility for the medical services
3 rendered by and actions of the anesthesiologist assistant while performing
4 under the direction and supervision of the designated anesthesiologist.

5 New Sec. 3. (a) There is hereby created a designation of active
6 license. The board shall issue an active license to an anesthesiologist
7 assistant who makes written application for such license on a form
8 provided by the board and remits the fee for an active license established
9 pursuant to subsection (g). As a condition of engaging in active practice as
10 an anesthesiologist assistant, each licensed anesthesiologist assistant shall
11 file a request to engage in active practice signed by the anesthesiologist
12 assistant and the supervising anesthesiologist who will be responsible for
13 supervising the anesthesiologist assistant. The request shall contain such
14 information as required by rules and regulations adopted by the board. The
15 board shall maintain a list of the names of anesthesiologist assistants who
16 may engage in active practice in this state.

17 (b) All licenses, except temporary licenses, shall expire on the date of
18 expiration established by rules and regulations of the board and may be
19 renewed as required by the board. The request for renewal shall be on a
20 form provided by the board and shall be accompanied by the renewal fee
21 established pursuant to this section, that shall be paid not later than the
22 expiration date of the license.

23 (c) At least 30 days before the expiration of the license of an
24 anesthesiologist assistant, except for a temporary license, the board shall
25 notify the licensee of the expiration in writing, which may include
26 electronic service. If the licensee fails to pay the renewal fee by the date of
27 expiration of the license, the licensee shall be given a second notice that
28 the licensee's license has expired and the license may be renewed only if
29 the renewal fee and the late renewal fee are received by the board within
30 the 30-day period following the date of expiration and that, if both fees are
31 not received within the 30-day period, the license shall be deemed
32 canceled by operation of law without further proceedings for failure to
33 renew and shall be reissued only after the license has been reinstated
34 pursuant to the provisions of subsection (d).

35 (d) Any license canceled for failure to renew may be reinstated upon
36 recommendation of the board and upon payment of the reinstatement fee
37 and upon submission of evidence of satisfactory completion of any
38 applicable continuing education requirements established by the board.
39 The board shall adopt rules and regulations establishing appropriate
40 continuing education requirements for reinstatement of licenses canceled
41 for failure to renew.

42 (e) There is hereby created the designation of inactive license. The
43 board shall issue an inactive license to any licensee who makes written

1 application for such license on a form provided by the board and remits the
2 fee for an inactive license established pursuant to subsection (f). The board
3 may issue an inactive license only to a person who meets all the
4 requirements for a license to practice as an anesthesiologist assistant but
5 who does not engage in active practice as an anesthesiologist assistant in
6 the state of Kansas. An inactive license shall not entitle the holder to
7 engage in active practice. The provisions of subsections (c) and (d) relating
8 to expiration, renewal and reinstatement of a license shall be applicable to
9 an inactive license issued under this subsection. Each inactive licensee
10 may apply to engage in active practice by presenting a request required by
11 subsection (a). The request shall be accompanied by the fee established
12 pursuant to subsection (g).

13 (f) (1) There is hereby created a license by endorsement. The board
14 shall issue a license by endorsement without examination to a person who
15 has been in active practice as an anesthesiologist assistant in some other
16 state, territory, the District of Columbia or other country upon certification
17 of the proper licensing authority of that state, territory, the District of
18 Columbia or other country certifying that the applicant is duly licensed,
19 that the applicant's license has never been limited, suspended or revoked,
20 that the licensee has never been censured or had other disciplinary action
21 taken and that, so far as the records of such authority are concerned, the
22 applicant is entitled to its endorsement. The applicant shall also present
23 proof satisfactory to the board:

24 (A) That the state, territory, the District of Columbia or country
25 where the applicant last practiced has and maintains standards at least
26 equal to those maintained by this state;

27 (B) that the applicant's original licensure was based upon an
28 examination at least equal in quality to the examination required in this
29 state and that the passing grade required to obtain such original license
30 was comparable to that required in this state;

31 (C) the date of the applicant's original and all endorsed licenses and
32 the date and place from which any license was attained;

33 (D) that the applicant has been actively engaged in practice under
34 such license or licenses since issuance. The board may adopt rules and
35 regulations establishing appropriate qualitative and quantitative practice
36 activities to qualify as active practice; and

37 (E) that the applicant has a reasonable ability to communicate in
38 English.

39 (2) An applicant for a license by endorsement shall not be granted
40 such license unless, as determined by the board, the applicant's
41 qualifications are substantially equivalent to Kansas requirements. In lieu
42 of any other requirement prescribed by law for satisfactory passage of any
43 examination for anesthesiologist assistants, the board may accept evidence

1 demonstrating that the applicant or licensee has satisfactorily passed an
2 equivalent examination given by a national board of examiners for
3 physician assistants.

4 (g) The following fees shall be fixed by rules and regulations adopted
5 by the board and shall be collected by the board:

6 (1) An application for any license as an anesthesiologist assistant, not
7 more than \$200;

8 (2) an applicant for temporary licensure as an anesthesiologist
9 assistant, not more than \$30;

10 (3) for the renewal of a license to practice as an anesthesiologist
11 assistant, not more than \$150;

12 (4) for the renewal of an inactive license, not more than \$75;

13 (5) for the late renewal of any license as an anesthesiologist assistant,
14 an additional fee shall be assessed, not more than \$100;

15 (6) for reinstatement of a license canceled for failure to renew, not
16 more than \$250;

17 (7) for a certified statement from the board that an anesthesiologist
18 assistant is licensed in this state, not more than \$30;

19 (8) for a copy of the licensure certificate of an anesthesiologist
20 assistant, not more than \$25; and

21 (9) for conversion of an inactive license to a license to actively
22 practice as an anesthesiologist assistant, not more than \$150.

23 (h) The board shall remit all moneys received from fees, charges or
24 penalties to the state treasurer in accordance with the provisions of K.S.A.
25 75-4215, and amendments thereto. Upon receipt of each such remittance,
26 the state treasurer shall deposit the entire amount in the state treasury to
27 the credit of the healing arts fee fund. All expenditures from such fund
28 shall be made in accordance with appropriation acts upon warrants of the
29 director of accounts and reports issued pursuant to vouchers approved by
30 the president of the board or by a person designated by the president of the
31 board.

32 (i) The board shall adopt all necessary rules and regulations for
33 carrying out the provisions of this act. The board may grant a temporary
34 variance from an identified rule or regulation when a literal application or
35 enforcement of the rule or regulation would result in serious hardship and
36 the relief granted would not result in any unreasonable risk to the public
37 interest, safety or welfare.

38 New Sec. 4. (a) No person shall be licensed as an anesthesiologist
39 assistant by the board unless such person has:

40 (1) Presented to the board proof that the applicant has successfully
41 completed a course of education and training approved by the board for
42 the education and training of an anesthesiologist assistant, or presented to
43 the board proof that the applicant has acquired experience while serving in

1 the armed forces of the United States, if such experience is equivalent to
2 the minimum experience requirements established by the board;

3 (2) passed an examination approved by the board covering topics
4 incidental to the education and training of an anesthesiologist assistant;
5 and

6 (3) submitted to the board any other information that the board deems
7 necessary through rules and regulations to evaluate the applicant's
8 qualifications.

9 (b) (1) As part of an original application for or reinstatement of any
10 license, registration, permit or certificate or in connection with any
11 investigation of any holder of a license, registration, permit or certificate,
12 pursuant to K.S.A. 2024 Supp. 22-4714, and amendments thereto, the
13 board may require an applicant or licensee to be fingerprinted and submit
14 to a state and national criminal history record check.

15 (2) The board may fix and collect a fee as may be required by the
16 board in an amount necessary to reimburse the board for the cost of
17 fingerprinting and the criminal history record check. Any moneys
18 collected under this subsection shall be deposited in the state treasury and
19 credited to the healing arts fee fund.

20 (c) The board may refuse to license a person as an anesthesiologist
21 assistant upon any of the grounds for which the board may revoke,
22 suspend, limit, publicly censure or place under probationary or monitoring
23 conditions such license.

24 (d) The board shall require every licensed anesthesiologist assistant to
25 submit with the renewal application evidence of satisfactory completion of
26 a program of continuing education required by the board. The board, shall
27 adopt rules and regulations, to establish the requirements for such program
28 of continuing education as soon as possible after January 5, 2026. In
29 establishing such requirements, the board shall consider any existing
30 programs of continuing education currently being offered to
31 anesthesiologist assistants.

32 New Sec. 5. A licensee's license may be revoked, suspended or
33 limited, or the licensee may be publicly censured, or placed under
34 probationary or monitoring conditions, fined or an application for a license
35 or for reinstatement of a license may be denied upon a finding that the
36 licensee:

37 (a) Committed an act of unprofessional conduct as defined by rules
38 and regulations adopted by the board;

39 (b) obtained a license by means of fraud, misrepresentation or
40 concealment of material facts;

41 (c) committed an act of professional incompetency as defined by
42 rules and regulations adopted by the board;

43 (d) has been convicted of a felony or class A misdemeanor, or

1 substantially similar offense in another jurisdiction, whether or not related
2 to the practice of the healing arts. The licensee has been convicted in a
3 special or general court-martial, whether or not related to the practice of
4 the healing arts. The board shall revoke a licensee's license following
5 conviction of a felony or substantially similar offense in another
6 jurisdiction, or following conviction in a general court-martial, unless a $\frac{2}{3}$
7 majority of the board members present and voting determine by clear and
8 convincing evidence that such licensee will not pose a threat to the public
9 in such person's capacity as a licensee and that such person has been
10 sufficiently rehabilitated to warrant the public trust. In the case of a person
11 who has been convicted of a felony or convicted in a general court-martial
12 and who applies for an original license or to reinstate a canceled license,
13 the application for a license shall be denied unless a $\frac{2}{3}$ majority of the
14 board members present and voting on such application determine by clear
15 and convincing evidence that such person will not pose a threat to the
16 public in such person's capacity as a licensee and that such person has been
17 sufficiently rehabilitated to warrant the public trust;

18 (e) violated any provision of this act;

19 (f) violated any lawful order or rule and regulation of the board;

20 (g) violated a federal law or regulation relating to controlled
21 substances;

22 (h) failed to report to the board any adverse action taken against the
23 licensee by another state or licensing jurisdiction, a peer review body, a
24 healthcare facility, a professional association or society, a governmental
25 agency, by a law enforcement agency or a court for acts or conduct similar
26 to acts or conduct that would constitute grounds for disciplinary action
27 under this section;

28 (i) surrendered a license or authorization to practice as an
29 anesthesiologist assistant in another state or jurisdiction, surrendered the
30 authority to utilize controlled substances issued by any state or federal
31 agency, agreed to a limitation to or restriction of privileges at any medical
32 care facility or surrendered the licensee's membership on any professional
33 staff or in any professional association or society while under investigation
34 for acts or conduct similar to acts or conduct that would constitute grounds
35 for disciplinary action under this section;

36 (j) failed to report to the board the surrender of the licensee's license
37 or authorization to practice as an anesthesiologist assistant in another state
38 or jurisdiction or the surrender of the licensee's membership on any
39 professional staff or in any professional association or society while under
40 investigation for acts or conduct similar to acts or conduct that would
41 constitute grounds for disciplinary action under this section;

42 (k) has an adverse judgment, award or settlement against the licensee
43 resulting from a medical liability claim related to acts or conduct similar to

1 acts or conduct that would constitute grounds for disciplinary action under
2 this section;

3 (l) failed to report to the board any adverse judgment, settlement or
4 award against the licensee resulting from a medical malpractice liability
5 claim related to acts or conduct similar to acts or conduct that would
6 constitute grounds for disciplinary action under this section;

7 (m) no longer has the ability to practice with reasonable skill and
8 safety by reason of physical or mental illness, or condition or use of
9 alcohol, drugs or controlled substances. All information, reports, findings
10 and other records relating to impairment shall be confidential and not
11 subject to discovery by or release to any person or entity outside of a board
12 proceeding;

13 (n) exceeded or acted outside the scope of authority given the
14 anesthesiologist assistant by the supervising anesthesiologist or by this act;

15 (o) has assisted suicide in violation of K.S.A. 21-3406, prior to its
16 repeal, or K.S.A. 2024 Supp. 21-5407, and amendments thereto, as
17 established by any of the following:

18 (1) A copy of the record of criminal conviction or plea of guilty for a
19 felony in violation of K.S.A. 21-3406, prior to its repeal, or K.S.A. 2024
20 Supp. 21-5407, and amendments thereto;

21 (2) a copy of the record of a judgment of contempt of court for
22 violating an injunction issued under K.S.A. 60-4404, and amendments
23 thereto; or

24 (3) a copy of the record of a judgment assessing damages under
25 K.S.A. 60-4405, and amendments thereto.

26 New Sec. 6. (a) It shall be unlawful for any person who is not
27 licensed under this act or whose license has been revoked or suspended
28 pursuant to this act to engage in practice as an anesthesiologist assistant.

29 (b) No person shall use any title, abbreviation, letters, figures, sign,
30 card or device to indicate that any person is a licensed anesthesiologist
31 assistant, nor shall any person represent oneself to be a licensed
32 anesthesiologist assistant, unless such person has been duly licensed as an
33 anesthesiologist assistant in accordance with the provisions of this act.

34 (c) The provisions of this act shall not be construed to include the
35 following persons:

36 (1) Persons rendering gratuitous services in the case of an emergency;

37 (2) persons gratuitously administering ordinary household remedies;

38 (3) individuals practicing religious beliefs that provide for reliance on
39 spiritual means alone for healing;

40 (4) students, while performing professional services in an approved
41 anesthesiologist assistant education and training program;

42 (5) persons whose professional services are performed under the
43 direct and personal supervision or by an order of a practitioner who is

1 licensed under the healing arts act;

2 (6) other healthcare providers who are licensed, registered, certified
3 or otherwise credentialed by agencies of the state of Kansas; or

4 (7) anesthesiologist assistants employed by the United States
5 government or any bureau, division or agency thereof, while in the
6 discharge of official duties.

7 (d) Any person violating the provisions of this section shall be guilty
8 of a class B misdemeanor.

9 New Sec. 7. (a) The board shall provide for the temporary licensure
10 of any anesthesiologist assistant who has made proper application for
11 licensure, has the required qualifications for licensure, except for
12 examination and has paid the prescribed license fee. Such temporary
13 license shall authorize the person so licensed to provide patient services
14 within the limits of the temporary license.

15 (b) A temporary license shall be valid:

16 (1) For one year from the date of issuance; or

17 (2) until the board makes a final determination on the applicant's
18 request for licensure.

19 The board may extend a temporary license, upon a majority vote of the
20 members of the board, for a period not to exceed one year.

21 New Sec. 8. (a) The practice of an anesthesiologist assistant shall
22 include assisting the supervising or designated anesthesiologist in
23 implementing an anesthesia care plan for a patient. In assisting the
24 supervising or designated anesthesiologist, an anesthesiologist assistant
25 shall have the authority to:

26 (1) Obtain a comprehensive patient history, perform relevant
27 elements of a physical exam and present the history to the supervising
28 anesthesiologist;

29 (2) pretest and calibrate anesthesia delivery systems and obtain and
30 interpret information from the systems and monitors, in consultation with
31 an anesthesiologist;

32 (3) assist the supervising anesthesiologist with the implementation of
33 medically accepted monitoring techniques;

34 (4) establish basic and advanced airway interventions, including
35 intubation of the trachea and performing ventilator support;

36 (5) administer intermittent vasoactive drugs and start and adjust
37 vasoactive infusions;

38 (6) administer anesthetic drugs, adjuvant drugs and accessory drugs;

39 (7) perform epidural anesthetic procedures, spinal anesthetic
40 procedures and other regional anesthetic techniques in coordination with
41 the supervising anesthesiologist;

42 (8) administer blood, blood products and supportive fluids;

43 (9) provide assistance to the cardiopulmonary resuscitation team in

1 response to a life-threatening situation;

2 (10) participate in administrative, research and clinical teaching
3 activities as authorized by the supervising anesthesiologist; and

4 (11) perform such other tasks as not prohibited by law under the
5 supervision of a licensed anesthesiologist that an anesthesiologist assistant
6 has been trained in and is proficient to perform.

7 (b) An anesthesiologist shall at all times accept and be responsible for
8 the oversight of the healthcare services rendered by the anesthesiologist
9 assistant.

10 (c) An anesthesiologist assistant shall practice only under the
11 supervision of an anesthesiologist who is physically present or
12 immediately available in the same physical facility where the
13 anesthesiologist assistant performs delegated medical acts and the
14 supervising anesthesiologist is available to provide direct supervision. A
15 supervising anesthesiologist or designated anesthesiologist shall be
16 allowed to supervise up to four anesthesiologist assistants at any one time.

17 (d) Anesthesiologist assistants shall not have the authority to:

18 (1) Prescribe medications or controlled substances;

19 (2) administer any drugs, medicines, devices or therapies that the
20 supervising anesthesiologist is not qualified or authorized to prescribe; or

21 (3) practice or attempt to practice without the supervision of a
22 licensed anesthesiologist or in any location where the supervising
23 anesthesiologist is not immediately available for consultation, assistance
24 and intervention.

25 New Sec. 9. (a) If a supervising anesthesiologist temporarily leaves
26 such anesthesiologist's customary location of practice, the supervising
27 anesthesiologist shall, by prior arrangement, name a designated
28 anesthesiologist who shall provide direction and supervision to the
29 anesthesiologist assistant of such supervising anesthesiologist.

30 (b) An anesthesiologist assistant shall not perform professional
31 services unless the name, address and signature of each supervising
32 anesthesiologist and the form required under section 3, and amendments
33 thereto, of this act have been provided to the board. A supervising
34 anesthesiologist shall notify the board when supervision and direction of
35 the anesthesiologist assistant has terminated. The board shall provide
36 forms for identifying each supervising anesthesiologist and for giving
37 notice that direction and supervision has terminated. These forms may
38 direct that additional information be provided, including a copy of any
39 written agreements, as required by rules and regulations adopted by the
40 board.

41 New Sec. 10. The board shall limit the number of anesthesiologist
42 assistants a supervising anesthesiologist may supervise at any one time to
43 four anesthesiologist assistants. An anesthesiologist, group of

1 anesthesiologists or medical care facility, as defined in K.S.A. 65- 425,
2 and amendments thereto, may employ more than four anesthesiologist
3 assistants, but an anesthesiologist may not provide direction and
4 supervision to more than four anesthesiologist assistants at any time.

5 New Sec. 11. (a) (1) There is hereby established an anesthesiologist
6 assistant council to advise the board in carrying out the provisions of the
7 anesthesiologist assistant licensure act. The council shall consist of five
8 members, all citizens and residents of the state of Kansas, appointed as
9 follows: One member shall be an anesthesiologist appointed by the board
10 who is a supervising anesthesiologist for an anesthesiologist assistant; one
11 member shall be president of the board or a person designated by the
12 president; and three members shall be licensed anesthesiologist assistants
13 appointed by the governor.

14 (2) The governor, insofar as possible, shall appoint persons from
15 different geographical areas and persons who represent various types of
16 practice settings. If a vacancy occurs on the council, the appointing
17 authority of the position that has become vacant shall appoint a person of
18 like qualifications to fill the vacant position for the unexpired term, if any.
19 The Kansas academy of anesthesiologist assistants shall recommend the
20 names of licensed anesthesiologist assistants to the governor in a number
21 equal to at least twice the positions or vacancies to be filled, and the
22 governor may appoint members to fill the positions or vacancies from the
23 submitted list.

24 (3) Members of the council appointed by the governor on and after
25 January 5, 2026, shall be appointed for terms of three years and until their
26 successors are appointed and qualified, except that of the members first
27 appointed by the governor on or after January 5, 2026, one shall be
28 appointed for a term of one year, one shall be appointed for a term of two
29 years and one shall be appointed for a term of three years, as designated by
30 the governor. The member appointed by the state board of healing arts
31 shall serve at the pleasure of the board. If the president of the board
32 designates a member to serve on the council in the president's stead, that
33 member shall serve at the pleasure of the president.

34 (b) Members of the anesthesiologist assistant council attending
35 meetings of the council or attending a subcommittee meeting thereof
36 authorized by the council shall be paid amounts provided in K.S.A. 75-
37 3223(e), and amendments thereto, from the healing arts fee fund.

38 New Sec. 12. (a) All administrative proceedings to revoke, suspend,
39 limit or deny a license or to censure a licensee, shall be conducted in
40 accordance with K.S.A 65-2838 and 65-2838a, and amendments thereto,
41 and the provisions of the Kansas administrative procedure act.

42 (b) When it appears to the board that any person is violating any of
43 the provisions of this act, the board may bring an action in the name of the

1 state of Kansas in a court of competent jurisdiction for an injunction
2 against such violation without regard to whether proceedings have been or
3 may be instituted before the board or whether criminal proceedings have
4 been or may be instituted.

5 Sec. 13. K.S.A. 65-1163 is hereby amended to read as follows: 65-
6 1163. Nothing in this act shall:

7 (a) Prohibit administration of a drug by a duly licensed professional
8 nurse, licensed practical nurse or other duly authorized person for the
9 alleviation of pain, including administration of local anesthetics;

10 (b) apply to the practice of anesthesia by a person licensed to practice
11 medicine and surgery, a licensed dentist or a licensed podiatrist;

12 (c) prohibit the practice of nurse anesthesia by students enrolled in
13 approved courses of study in the administration of anesthesia or analgesic
14 as a part of such course of study;

15 (d) apply to the administration of a pudendal block by a person who
16 holds a valid license as an advanced practice registered nurse in the role of
17 nurse-midwife;

18 (e) apply to the administration by a licensed professional nurse of an
19 anesthetic, other than general anesthesia, for a dental operation under the
20 direct supervision of a licensed dentist or for a dental operation under the
21 direct supervision of a person licensed to practice medicine and surgery;

22 (f) prohibit the practice by any registered nurse anesthetist who is
23 employed by the United States government or in any bureau, division or
24 agency thereof, while in the discharge of official duties; ~~or~~

25 (g) prohibit a registered professional nurse from administering
26 general anesthetic agents to a patient on ventilator maintenance in critical
27 care units when under the direction of a person licensed to practice
28 medicine and surgery or a person licensed to practice dentistry; *or*

29 *(h) prohibit the practice of anesthesia by anesthesiologist assistant*
30 *students enrolled in approved courses of study in the administration of*
31 *anesthesia or analgesic as a part of such course of study.*

32 Sec. 14. K.S.A. 2025 Supp. 22-4714 is hereby amended to read as
33 follows: 22-4714. (a) A governmental agency other than a criminal justice
34 agency as defined in K.S.A. 22-4701, and amendments thereto, identified
35 in subsection (b) may require a person to be fingerprinted and shall submit
36 such fingerprints to the Kansas bureau of investigation and the federal
37 bureau of investigation for a search of the state and federal database.
38 Fingerprints provided pursuant to this section may be used to identify a
39 person and to determine whether such person has a record of criminal
