Patrick Fucik of Sprint explained their proposed bill dealing with access rates. It is drafted in 9rs1297.

Kristen Kellems, Revisor of Statutes Office, reviewed the Senate Utilities Committee carry-over bills from the 2009 session - SB 47 - Local exchange carriers methods to satisfy carrier of last resort obligation; SB 217 - Retail electric suppliers act, state educational institutions authorized to enter into certain energy generation agreements; SB 265 - Energy conservation and electric generation , transmission and efficiency and air emissions; SB 284 - Third party administrator authorized for certain utilities energy efficiency and conservation programs; and SB 339 - Energy conservation and electric generation n, transmission, efficiency and air emissions; and the Senate carry-over bills in the House Committee on Energy and Utilities. # The Senate Committee on Utilities carry-over bills from the 2009 session are:

- SB 47. This bill would allow a local exchange carrier to satisfy its carrier of last resort obligation to provide basic voice service in an exchange by using alternative technology. Introduced to the Committee on Utilities. No hearing was held.
- **SB 217.** This bill would specify that a retail electric supplier would not include any person or organization that furnishes wind-generated electricity to state universities only. Introduced to Committee on Utilities; referred to Committee on Ways and Means; re-referred to Committee on Utilities; hearing on 3/02/2009.
- SB 265. This bill would establish a coordinated state regulatory initiative regarding emissions from stationary, mobile, and area sources not currently regulated by the United States Environmental Protection Agency. The bill includes requirements for the Department of Administration, the Kansas Corporation Commission, and the Kansas Department of Health and Environment. The bill also affects municipalities that own or operate electric utilities. Introduced to Committee on Ways and Means; referred to Committee on Utilities; hearings held on 2/18/2009, 2/19/2009 and 2/25/2009.
- **SB 284.** This bill would require the Kansas Corporation Commission to establish the Third Party Administrator Program as an independent, not-for-profit corporation. The purpose of the program would be to achieve reductions in energy use through increasing the level of cost effective energy efficiency, conservation, and education programs available to Kansans. Introduced to Ways and Means; referred to Committee on Utilities; hearings held on 3/11/2009 and 3/16/2009. Committee on Utilities recommended that the bill be referred to the Joint Committee on Energy and Environmental Policy for further study.
- **SB 339.** This is a comprehensive energy bill dealing with deregulating large electric cooperatives, renewable energy requirements, energy efficiency guidelines, net metering and air quality among other things. Introduced into the Committee on Federal and State Affairs; referred to Committee on Utilities. No hearing was held.

#### The Senate Utilities carry-over bills in the Committee on Energy and Utilities are:

- S Sub for SB 48. This bill would amend existing law regarding emergency wireless 911 services by extending for ten years the current method of funding which is set to sunset on July 1, 2010. Introduced to Committee on Utilities; Committee on Utilities recommended Senate Substitute for SB 48 bill be passed; substitute bill was amended on the floor and passed by the Senate Committee of the Whole; introduced to the House side and referred to Committee on Energy and Utilities; has not had a hearing.
- S Sub for SB 58. This bill would make technical changes to existing law concerning the Underground Utility Damage Prevention Act. Introduced to Committee on Utilities; Committee on Utilities recommended Senate Substitute for SB 58 bill be passed; substitute bill was amended on the floor and passed by the Senate Committee of the Whole; introduced to the House side and referred to Committee on Energy and Utilities; has not had a hearing.
- SB 298. This bill would require any person who operates or is responsible for certain types of wells to place a well identification sign on or near each well. The Kansas Corporation Commission would adopt rules and regulations specifying the size and location of the signs as well as the information to be included on the signs. Introduced to Committee on Utilities; Committee on Utilities recommended the bill be passed as amended; passed by the Senate Committee of the Whole; introduced to the House side and referred to Committee on Energy and Utilities; has not had a hearing.
- SB 299. This bill would amend current law regarding underground hydrocarbon storage wells by adding a definition for "company or operator." The bill would define company or operator as any form of legal organization including corporations, limited liability companies, and limited or general partnerships. Introduced to Committee on Ways and Means; referred to Committee on Judiciary; re-referred to Committee on Utilities; Committee on Utilities recommended the bill be passed; passed by the Senate Committee of the Whole; introduced to the House side and referred to Committee on Energy and Utilities; has not had a hearing.
