House Judiciary Committee Wednesday, February 15, 2012 Testimony in support of HB 2523

Rep. Kinzer and members of the Judiciary Committee,

It was the early 1990's, and as a new medical school graduate, I had ranked highly in the match for Obstetrics and Gynecology. Soon after entering residency, however, I encountered vigorous opposition to my values, from the very people who had previously found me very desirable. Some residents were moonlighting at Planned Parenthood, a more or less officially sanctioned paying position that competed for their limited hours; on the other hand, when I stated that I did not want to perform sterilization or prescribe intermittently abortifacient contraception, I found that I was blackballed from the only residency to which I was prepared to devote all my working hours.

Learning surgical technique is crucial to the Ob/Gyn resident; I soon found that, no matter whom the instructor, I was no longer being informed of when the cases were being performed. When I performed extra legwork to be at the case, the attending would not speak to me, nor show me how to perform the procedure. Senior residents would take me aside, and in a dismissive or heated manner, in hallway or call room, tell me that I could not avoid the practices that disturbed my conscience.

One upper-level resident in particular repeatedly castigated me over this issue; I remember on one occasion, he came at me in a threatening manner and repeatedly poked his finger into my chest. When I discussed my concerns with the residency director, he had no solution for me to continue education in the program - other than distancing myself from my convictions - and no interest in the behavior directed against me. This was despite my assurance that I would not force others to live my convictions.

With a new home mortgage signed for, the stress was so great that my wife went into premature labor one month before her due date. The staff attending, who had previously agreed to be her obstetrician, refused to come to the delivery. This left the delivering physician of our first child, in a high risk situation, to be one of the senior residents who had offered me such opposition. Luckily a more accepting attending was on call, and agreed to come to the delivery.

Much could be said about this experience, but I think it best to repeat what the director of the family practice residency, that eventually accepted my transfer, stated; "We don't necessarily agree with all of your convictions, but we know that if you stand by what you feel to be right in those situations, we can trust you in other ones." If at some point in the future I myself become incapacitated by illness, I hope that looking over me will be a physician, who despite the numerous, manifold, and increasing pressures of practicing medicine in today's world, will be accustomed to following his conscience in doing what's best for the patient.
