The hearing opened on HB 2666 Cities; experience requirements for plumbers, electricians and certain mechanical contractors. Mike Heim, revisor, explained HB 2666 is a technical bill. The bill, as amended, would require cities or counties—if they require the licensing of plumbers, electricians, or mechanical heating, ventilation and air conditioning (HVAC) contractors—to verify the applicant's respective documented proof of minimum necessary experience prior to issuing a journeyman or master certificate.
