Hearing on SB 351-Transferring moneys to the local ad valorem tax reduction fund

Scott Wells, Office of the Revisor of Statutes, briefed the committee on <u>SB 351</u>, which provides for a local ad valorem tax reduction fund (LAVTRF). All monies transferred or credited to such fund shall be apportioned and distributed as provided: no monies transferred from SGF to the LAVTRF for FY 2013, \$27 million for FY 2014, \$41.5 for FY 2015 and subsequent years. Sixty-five percent of the county distribution is based on population figures, while 35 percent is apportioned based on equalized assessed value of tangible property in the county. (Attachment 1)

Senator Vratil moved to delete the contents of SB 351 and to insert the provisions of SB 409 as amended by the Senate Tax Committee, which provides for transfers from the state general fund to the Local Ad Valorem Tax Reduction Fund and provides for a demand
