AN ACT concerning abortion; amending K.S.A. 65-6701 and repealing the 1 2 existing section. 3 4 Be it enacted by the Legislature of the State of Kansas: Section 1. K.S.A. 65-6701 is hereby amended to read as follows: 65-5 6 6701. As used in this act: 7 (a) "Abortion" means the use of any means to intentionally terminate a pregnancy except for the purpose of causing a live birth. Abortion does not 8 include: (1) The use of any drug or device that inhibits or prevents ovulation, 9 fertilization or the implantation of an embryo; or (2) disposition of the product 10 of in vitro fertilization prior to implantation. 11 12 "Bodily function" means physical functions. *(b)* The term "bodily function" does not include mental or emotional functions. 13 (b) (c) "Counselor" means a person who is: (1) Licensed to practice 14 medicine and surgery; (2) licensed to practice psychology; (3) licensed to 15 practice professional or practical nursing; (4) registered to practice 16 professional counseling; (5) licensed as a social worker; (6) the holder of a 17 master's or doctor's degree from an accredited graduate school of social work; 18 (7) registered to practice marriage and family therapy; (8) a licensed physician 19 assistant; or (9) a currently ordained member of the clergy or religious 20 authority of any religious denomination or society. Counselor does not include 21 the physician who performs or induces the abortion or a physician or other 22 23 person who assists in performing or inducing the abortion. 24 "Department" means the department of health and environment. (e) (d) (d) (e) "Gestational age" means the time that has elapsed since the first 25 day of the woman's last menstrual period. 26 "Medical emergency" means that condition which, on the basis of 27 <del>(e)</del> (f) the physician's good faith clinical judgment, so complicates the medical 28 condition of a pregnant woman as to necessitate the immediate abortion of her 29 30 pregnancy to avert her death or for which a delay will create serious risk of substantial and irreversible impairment of a major bodily function. 31 "Minor" means a person less than 18 years of age. 32  $\left( f\right) (g)$  $\frac{(g)}{(h)}$  "Physician" means a person licensed to practice medicine and 33 34 surgery in this state.

(h) (i) "Pregnant" or "pregnancy" means that female reproductive
condition of having a fetus in the mother's body.

(i) (j) "Qualified person" means an agent of the physician who is a
psychologist, licensed social worker, registered professional counselor,
registered nurse or physician.

- 4 (i) (k) "Unemancipated minor" means any minor who has never been: (1) 5 Married; or (2) freed, by court order or otherwise, from the care, custody and 6 control of the minor's parents.
- 7 (k) (l) "Viable" means that stage of gestation when, in the best medical 8 judgment of the attending physician, the fetus is capable of sustained survival 9 outside the uterus without the application of extraordinary medical means.
- 10 Sec. 2. K.S.A. 65-6701 is hereby repealed.
- 11 Sec. 3. This act shall take effect and be in force from and after its 12 publication in the statute book.
