1 AN ACT concerning school districts; relating to supplemental general
2 state aid; relating to consolidated or disorganized school districts;
3 amending K.S.A. 2010 Supp. 72-6434b and repealing the existing
4 section.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. K.S.A. 2010 Supp. 72-6434b is hereby amended to read
8 as follows: 72-6434b. (a) Unless the context otherwise requires, as used
9 in this section, "district" means: (1) Any school district formed by
10 consolidation in accordance with article 87 of chapter 72 of the Kansas
11 Statutes Annotated; or (2) any school district formed by disorganization
12 and attachment in accordance with article 73 of chapter 72 of the Kansas
13 Statutes Annotated, and amendments thereto, if all the territory which
14 comprised a disorganized district is attached to a single district.

15 (b) (1) For the purposes of determining the amount of supplemental
16 general state aid, the state board shall determine the ranking of each of
17 the former school districts of which the district is composed as required
18 by subsection (a)(2) of K.S.A. 72-6434, and amendments thereto, for the
19 school year prior to the effectuation of the consolidation or attachment.

20 (2) ~~For the school year in which the consolidation or attachment is~~
21 ~~effectuated and the next succeeding two school years~~ *The provisions of*
22 *this paragraph shall apply to any consolidation of school districts*
23 *completed prior to July 1, 2011. If any of the former school districts had*
24 *an enrollment of less than 150 pupils on September 20 of the school year*
25 *preceding the consolidation, the ranking of the district for the purposes of*
26 *subsection (a)(2) of K.S.A. 72-6434, and amendments thereto, for the*
27 *school year in which the consolidation or attachment is effectuated and*
28 *the next two succeeding school years, shall be the ranking of the district*
29 *receiving the highest amount of supplemental general state aid*
30 *determined under paragraph (1).*

31 (3) *The provisions of this paragraph shall apply to any*
32 *consolidation of school districts completed on or after July 1, 2011. If*
33 *any of the former school districts had an enrollment of less than 150*
34 *pupils on September 20 of the school year preceding the consolidation,*
35 *the ranking of the district for the purposes of subsection (a)(2) of K.S.A.*
36 *72-6434, and amendments thereto, for the school year in which the*

1 consolidation or attachment is effectuated and the next succeeding school
2 year, shall be the ranking of the district receiving the highest amount of
3 supplemental general state aid determined under paragraph (1).

4 (4) If all of the former school districts had an enrollment of at least
5 150 pupils, but any had less than 200 pupils on September 20 of the
6 school year preceding the consolidation, the ranking of the district for
7 the purposes of subsection (a)(2) of K.S.A. 72-6434, and amendments
8 thereto, for the school year in which the consolidation or attachment is
9 effectuated and the next three succeeding school years, shall be the
10 ranking of the district receiving the highest amount of supplemental
11 general state aid determined under paragraph (1).

12 (5) If all of the former school districts had an enrollment of at least
13 200 pupils on September 20 of the school year preceding the
14 consolidation, the ranking of the district for the purposes of subsection
15 (a)(2) of K.S.A. 72-6434, and amendments thereto, for the school year in
16 which the consolidation or attachment is effectuated and the next four
17 succeeding school years, shall be the ranking of the district receiving the
18 highest amount of supplemental general state aid determined under
19 paragraph (1).

20 (6) If the consolidation involved the consolidation of three or more
21 school districts, regardless of the number of pupils enrolled in such
22 districts, the ranking of the district for the purposes of subsection (a)(2)
23 of K.S.A. 72-6434, and amendments thereto, for the school year in which
24 the consolidation or attachment is effectuated and the next four
25 succeeding school years, shall be the ranking of the district receiving the
26 highest amount of supplemental general state aid determined under
27 paragraph (1).

28 (c) The provisions of this section shall apply to districts which have
29 consolidated or disorganized on and after July 1, ~~2004~~ 2008.

30 Sec. 2. K.S.A. 2010 Supp. 72-6434b is hereby repealed.

32 publication in the statute book.
