1 AN ACT concerning distinctive license plates; amending K.S.A. 8-1,148,
2 8-1,150 and 8-1,151 and K.S.A. 2011 Supp. 8-1,142, 8-1,153, 8-1,158,
3 8-1,161, 8-1,162 and 8-1,164 and repealing the existing sections.
4

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2011 Supp. 8-1,142 is hereby amended to read as
7 follows: 8-1,142. (a) As used in this section, "educational institution"
8 means:

9 (1) Any state educational institution under the control and supervision
10 of the state board of regents;

11 (2) any municipal university;

12 (3) any not-for-profit independent institution of higher education
13 which is accredited by the north central association of colleges and
14 secondary schools accrediting agency based on its requirements as of April
15 1, 1985, is operated independently and not controlled or administered by
16 the state or any agency or subdivision thereof, maintains open enrollment
17 and the main campus or principal place of operation of which is located in
18 Kansas;

19 (4) any community college organized and operating under the laws of
20 this state; and

21 (5) Haskell Indian Nations university.

22 (b) Any owner or lessee of one or more passenger vehicles or trucks
23 registered for a gross weight of not more than 20,000 pounds who is a
24 resident of Kansas, upon compliance with the provisions of this section,
25 may be issued one educational institution license plate for each such
26 passenger vehicle or truck. Such license plates shall be issued for the same
27 period of time as other license plates upon proper registration and payment
28 of the regular license fee as provided in K.S.A. 8-143, and amendments
29 thereto, plus the payment of an additional fee of \$5 for each plate, and the
30 presentation of the annual emblem use authorization statement provided
31 for in subsection (c). *Presentation of the annual emblem use authorization*
32 *statement shall not be required by the county treasurer if the emblem use*
33 *royalty payment is paid to the county treasurer.*

34 (c) Any educational institution may authorize through its officially
35 recognized alumni association or foundation the use of such institution's
36 official emblems to be affixed on license plates as provided by this section.

1 Any royalty payment to such alumni association ~~or~~, foundation *or county*
2 *treasurer* derived from this section, except reasonable administrative costs,
3 shall be used for recognition of academic achievement or excellence
4 subject to the approval of the chancellor or president of the educational
5 institution. Any motor vehicle owner or lessee may annually apply to the
6 alumni association ~~or~~, foundation *or county treasurer* for the use of the
7 institution's emblems. Upon annual application and payment to the alumni
8 association ~~or~~ foundation *or county treasurer* in an amount of not less than
9 \$25 nor more than \$100 as an emblem use royalty payment for each
10 educational institution license plate to be issued, the alumni association or
11 foundation shall issue to the motor vehicle owner or lessee, without further
12 charge, an emblem use authorization statement, which shall be presented
13 by the motor vehicle owner or lessee at the time of registration.
14 *Presentation of the annual emblem use authorization statement shall not*
15 *be required by the county treasurer if the emblem use royalty payment is*
16 *paid to the county treasurer.*

17 (d) Any applicant for an educational institution license plate may
18 make application for such plates not less than 60 days prior to such
19 person's renewal of registration date, on a form prescribed and furnished
20 by the director of vehicles, and any applicant for the educational institution
21 license plates shall provide the annual emblem use authorization statement
22 provided for in subsection (c). Application for registration of a passenger
23 vehicle or truck and issuance of the license plates under this section shall
24 be made by the owner or lessee in a manner prescribed by the director of
25 vehicles upon forms furnished by the director.

26 (e) No registration or educational institution license plate issued
27 under this section shall be transferable to any other person.

28 (f) *The director of vehicles may transfer educational institution*
29 *license plates from a leased vehicle to a purchased vehicle.*

30 (g) Renewals of registration under this section shall be made
31 annually, upon payment of the fee prescribed in subsection (b), in the
32 manner prescribed in subsection (b) of K.S.A. 8-132, and amendments
33 thereto. No renewal of registration shall be made to any applicant until
34 such applicant *either* provides the annual emblem use authorization
35 statement provided for in subsection (c) *or makes the annual emblem use*
36 *royalty payment directly to the county treasurer.* If such emblem use
37 authorization statement is not presented at the time of registration *or faxed*
38 *by the alumni association or foundation, or the annual emblem use royalty*
39 *payment is not made to the county treasurer,* the applicant shall be required
40 to comply with K.S.A. 8-143, and amendments thereto, and return the
41 educational institution license plates to the county treasurer of such
42 person's residence.

43 (~~g~~)(h) The director of vehicles shall not issue any educational

1 institution license plates for any educational institution, unless such
2 educational institution's alumni association or foundation guarantees the
3 initial issuance of at least 500 license plates.

4 ~~(h)~~(i) The director of vehicles shall discontinue the issuance of an
5 educational institution's license plate authorized under this section if:

6 (1) Less than 500 educational institution license plates, including
7 annual renewals, are issued for an educational institution by the end of the
8 second year of sales; and

9 (2) less than 250 educational institution license plates, including
10 annual renewals, are issued for an educational institution during any
11 subsequent two-year period.

12 ~~(i)~~(j) Each educational institution's alumni association or foundation
13 shall:

14 (1) Pay the initial cost of silk-screening for such educational license
15 plates; and

16 (2) provide to all county treasurers a toll-free telephone number
17 where applicants can call the alumni association or foundation for
18 information concerning the application process or the status of their
19 license plate application.

20 ~~(j)~~(k) Each educational institution's alumni association or foundation,
21 with the approval of the director of vehicles and subject to the availability
22 of materials and equipment, shall design a license plate to be issued under
23 the provisions of this section.

24 *(l) As a condition of receiving the educational institution license plate
25 and any subsequent registration renewal of such plate, the applicant must
26 provide consent to the division authorizing the division's release of motor
27 vehicle record information, including the applicant's name, address,
28 emblem use royalty payment amount, plate number and vehicle type to the
29 relevant educational institution.*

30 *(m) Annual royalty payments collected by county treasurers under
31 this section shall be remitted to the state treasurer in accordance with the
32 provisions of K.S.A. 75-4215, and amendments thereto. In the case of an
33 educational institution that is a state educational institution as defined by
34 K.S.A. 76-711, and amendments thereto, upon receipt of each such
35 remittance, the state treasurer shall deposit the entire amount in the state
36 treasury to the credit of the appropriate account of the restricted fees fund
37 of such state educational institution. In the case of an educational
38 institution which is not a state educational institution as defined by K.S.A.
39 76-711, and amendments thereto, upon receipt of each such remittance,
40 the state treasurer shall remit the entire amount to the educational
41 institutions emblem royalty fund, which is hereby created in the state
42 treasury and shall be administered by the state treasurer. All expenditures
43 from the educational institutions emblem royalty fund shall be made in*

1 *accordance with appropriation acts upon warrants of the director of*
2 *accounts and reports issued pursuant to vouchers approved by the state*
3 *treasurer or the state treasurer's designee. Payments from the educational*
4 *institutions emblem royalty fund to the respective educational institutions*
5 *shall be made on a monthly basis.*

11 plate for each such passenger vehicle or truck. Such license plates shall be

6 issued one Kansas foundation for agriculture in the classroom license plate
7 for each such passenger vehicle or truck. Such license plates shall be
8 issued for the same time as other license plates upon proper registration
9 and payment of the regular license fee as provided in K.S.A. 8-143, and
10 amendments thereto, and the presentation of the annual logo use
11 authorization statement provided for in subsection (b). *Presentation of the*
