1 AN ACT concerning school districts; relating to ~~transportation of certain~~
2 pupils ~~residing on the Leavenworth military reservation~~; **amending**
3 **K.S.A. 2010 Supp. 72-1046b and repealing the existing section.**

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. (a) The board of education of Fort Leavenworth, U.S.D.
7 No. 207 may provide transportation for any pupil in grades 10 through 12
8 who resides on Fort Leavenworth military reservation, but who is enrolled
9 in and attends high school in Leavenworth, U.S.D. No. 453.

10 (b) Solely for the purpose of computation of transportation weighting,
11 **as provided by this section**, any pupil provided transportation pursuant to
12 this section shall be counted as regularly enrolled in and attending school
13 in U.S.D. No. 207 **on September 20 of the current school year.**

14 **Sec. 2. K.S.A. 2010 Supp. 72-1046b is hereby amended to read as**
15 **follows: 72-1046b. (a) As used in this section:**

16 (1) "School district" means a school district organized and
17 operating under the laws of this state and no part of which is located
18 in Johnson county, Sedgwick county, Shawnee county, or Wyandotte
19 county.

20 (2) "Non-resident pupil" or "pupil" means a pupil who is
21 enrolled and in attendance at a school located in a district in which
22 such pupil is not a resident and who (A) lives ~~at~~ 2 1/2 or more miles
23 from the attendance center the pupil would attend in the district in
24 which the pupil resides *and is not a resident of Johnson county, Sedgwick*
25 *county, Shawnee county or Wyandotte county* or (B) is a member of the
26 family of a pupil meeting the condition prescribed in subpart (A).

27 (3) "Member of the family" means a brother or sister of the
28 whole or half blood or by adoption, a stepbrother or stepsister, and a
29 foster brother or foster sister.

30 (b) The board of education of any school district may allow any
31 pupil who is not a resident of the district to enroll in and attend school
32 in such district. The board of education of such district may furnish or
33 provide transportation to any non-resident pupil who is enrolled in
34 and attending school in the district pursuant to this section. If the
35 district agrees to furnish or provide transportation to a non-resident
36 pupil, such transportation shall be furnished or provided until the end

1 of the school year. Prior to providing or furnishing transportation to a
2 non-resident pupil, the district shall notify the board of education of
3 the district in which the pupil resides that transportation will be
4 furnished or provided.

5 (c) Pupils attending school in a school district in which the pupil
6 does not reside pursuant to this section shall be counted as regularly
7 enrolled in and attending school in the district where the pupil is
8 enrolled for the purpose of computations, except computation of
9 transportation weighting, under the school district finance and quality
10 performance act and for the purposes of the statutory provisions
11 contained in article 83 of chapter 72 of the Kansas Statutes Annotated,
12 *and amendments thereto*. Such non-resident pupil shall not be charged
13 for the costs of attendance at school.

14 **Sec. 3. K.S.A. 2010 Supp. 72-1046b is hereby repealed.**
