1 AN ACT concerning the Kansas law enforcement training act; amending
2 K.S.A. ~~19-801b, 31-157~~, 74-5601 and 74-5622 and K.S.A. 2011 Supp.
3 ~~12-1,120~~, 74-5602, 74-5603, 74-5605, 74-5607, 74-5607a, 74-5608a
4 and 74-5616 and repealing the existing sections; also repealing K.S.A.
5 74-5618.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 74-5601 is hereby amended to read as follows: 74-
9 5601. The provisions of ~~K.S.A. 74-5601 to 74-5611, inclusive, and~~
10 ~~amendments thereto, K.S.A. 74-5604a, 74-5607a, 74-5609a, 74-5611a, 74-~~
11 ~~5616 and 74-5617~~ *article 56 of chapter 74 of the Kansas Statutes*
12 *Annotated*, and amendments thereto, shall be known and be cited as the
13 Kansas law enforcement training act.

14 Sec. 2. K.S.A. 2011 Supp. 74-5602 is hereby amended to read as
15 follows: 74-5602. As used in the Kansas law enforcement training act:

16 (a) "Training center" means the law enforcement training center
17 within ~~the division of continuing education~~ of the university of Kansas,
18 created by K.S.A. 74-5603, and amendments thereto.

19 (b) "Commission" means the Kansas commission on peace officers'
20 standards and training, created by K.S.A. 74-5606, and amendments
21 thereto, *or the commission's designee*.

22 (c) "~~Dean~~ Chancellor" means the ~~dean of continuing education-~~
23 *chancellor* of the university of Kansas, *or the chancellor's designee*.

24 (d) "Director of police training" means the director of police training
25 at the law enforcement training center.

26 (e) "Director" means the executive director of the Kansas commission
27 on peace officers' standards and training.

28 (f) "Law enforcement" means the prevention or detection of crime
29 and the enforcement of the criminal or traffic laws of this state or of any
30 municipality thereof.

31 (g) "Police officer" or "law enforcement officer" means a full-time or
32 part-time salaried officer or employee of the state, a county or a city,
33 whose duties include the prevention or detection of crime and the
34 enforcement of the criminal or traffic laws of this state or of any

1 municipality thereof. Such terms shall include, but not be limited to, the
2 sheriff, undersheriff and full-time or part-time salaried deputies in the
3 sheriff's office in each county; deputy sheriffs deputized pursuant to
4 K.S.A. 19-2858, and amendments thereto; conservation officers of the
5 Kansas department of wildlife ~~and parks~~, *parks and tourism*; university
6 police officers, as defined in K.S.A. 22-2401a, and amendments thereto;
7 campus police officers, as defined in K.S.A. 22-2401a, and amendments
8 thereto; law enforcement agents of the director of alcoholic beverage
9 control; law enforcement agents designated by the secretary of revenue
10 pursuant to K.S.A. 2011 Supp. 75-5157, and amendments thereto; law
11 enforcement agents of the Kansas lottery; law enforcement agents of the
12 Kansas racing commission; deputies and assistants of the state fire marshal
13 having law enforcement authority; capitol police, existing under the
14 authority of K.S.A. 75-4503, and amendments thereto; and law
15 enforcement officers appointed by the adjutant general pursuant to K.S.A.
16 48-204, and amendments thereto. Such terms shall also include railroad
17 policemen appointed pursuant to K.S.A. 66-524, and amendments thereto;
18 school security officers designated as school law enforcement officers
19 pursuant to K.S.A. 72-8222, and amendments thereto; the manager and
20 employees of the horsethief reservoir benefit district pursuant to K.S.A.
21 2011 Supp. 82a-2212, and amendments thereto; and the director of the
22 Kansas commission on peace officers' standards and training and any other
23 employee of such commission designated by the director pursuant to
24 K.S.A. 74-5603, and amendments thereto, as a law enforcement officer.
25 Such terms shall not include any elected official, other than a sheriff,
26 serving in the capacity of a law enforcement or police officer solely by
27 virtue of such official's elected position; any attorney-at-law having
28 responsibility for law enforcement and discharging such responsibility
29 solely in the capacity of an attorney; any employee of the commissioner of
30 juvenile justice, the secretary of corrections or the secretary of social and
31 rehabilitation services; any deputy conservation officer of the Kansas
32 department of wildlife ~~and parks~~, *parks and tourism*; or any employee of a
33 city or county who is employed solely to perform correctional duties
34 related to jail inmates and the administration and operation of a jail; or any
35 full-time or part-time salaried officer or employee whose duties include the
36 issuance of a citation or notice to appear provided such officer or
37 employee is not vested by law with the authority to make an arrest for
38 violation of the laws of this state or any municipality thereof, and is not
39 authorized to carry firearms when discharging the duties of such person's
40 office or employment. Such term shall include any officer appointed or
41 elected on a provisional basis.

42 (h) "Full-time" means employment requiring at least 1,000 hours of
43 law enforcement related work per year.

1 (i) "Part-time" means employment on a regular schedule or
2 employment which requires a minimum number of hours each payroll
3 period, but in any case requiring less than 1,000 hours of law enforcement
4 related work per year.

5 (j) "Misdemeanor crime of domestic violence" means a violation of
6 domestic battery as provided by K.S.A. 21-3412a, prior to its repeal, or
7 K.S.A. 2011 Supp. 21-5414, and amendments thereto, or any other
8 misdemeanor under federal, municipal or state law that has as an element
9 the use or attempted use of physical force, or the threatened use of a
10 deadly weapon, committed by a current or former spouse, parent, or
11 guardian of the victim, by a person with whom the victim shares a child in
12 common, by a person who is cohabiting with or has cohabited with the
13 victim as a spouse, parent or guardian, or by a person similarly situated to
14 a spouse, parent or guardian of the victim.

15 (k) "Auxiliary personnel" means members of organized nonsalaried
16 groups ~~which~~ *who* operate as an adjunct to a police or sheriff's department,
17 including reserve officers, posses and search and rescue groups.

18 (l) "Active law enforcement certificate" means a certificate which
19 attests to the qualification of a person to perform the duties of a law
20 enforcement officer and which has not been suspended or revoked by
21 action of the Kansas commission on peace officers' standards and training
22 and has not lapsed by operation of law as provided in K.S.A. 74-5622, and
23 amendments thereto.

24 Sec. 3. K.S.A. 2011 Supp. 74-5603 is hereby amended to read as
25 follows: 74-5603. (a) There is hereby created within ~~continuing education~~
26 ~~of~~ the university of Kansas a law enforcement training center, to be located
27 at the former site of the U.S. naval air station in Reno county. The purpose
28 and function of such training center shall be the promotion and
29 development of improved law enforcement personnel and procedures
30 throughout the state, and the training center shall offer to qualified
31 applicants, as defined in K.S.A. 74-5605, and amendments thereto, such
32 programs and courses of instruction designed to fulfill this end. No person
33 shall enroll in a basic course of instruction at the Kansas law enforcement
34 training center unless the person holds a provisional law enforcement
35 certificate.

36 (b) The ~~dean~~ *chancellor*, upon consultation with and approval of the
37 commission, shall appoint a director of police training. The ~~dean~~
38 *chancellor* shall ~~also~~ appoint such additional personnel as deemed
39 necessary to carry out the law enforcement training programs of the
40 training center. Such personnel, whether administrative, instructional or
41 research, shall be in the unclassified service under the Kansas civil service
42 act.

43 (c) The director of police training shall be responsible for the

1 administration of the training center and for the operation of the programs
2 thereunder. The director of police training shall be responsible for
3 determining the curriculum of the program, subject to such changes and
4 modification as are directed by the commission. In consultation with the
5 commission, the director of police training may prescribe a code of
6 conduct applicable to all trainees at the Kansas law enforcement training
7 center. Upon consultation with and approval of the commission, the
8 director of police training is authorized to adopt such rules and regulations
9 *and policies* as are necessary for the effective ~~operation~~ *administration* of
10 the law enforcement training program.

11 (d) Kansas commission on peace officers' standards and training shall
12 appoint a director who shall be in the unclassified service under the
13 Kansas civil service act.

14 (1) The director shall serve at the pleasure of the Kansas commission
15 on peace officers' standards and training and shall be subject to removal by
16 vote of 3/4 of the entire commission membership.

17 (2) The director shall enter into contracts necessary to administer the
18 provisions of the Kansas law enforcement training act.

19 (3) The director may appoint employees, agents and consultants as
20 the director considers necessary and prescribe their duties.

21 (4) The director shall be a law enforcement officer. The director may
22 designate any other employee of the Kansas commission on peace officers'
23 standards and training as a law enforcement officer. The director and any
24 employee designated as a law enforcement officer by the director shall
25 possess all powers and privileges which are now or may hereafter be given
26 to an agent of the Kansas bureau of investigation and may exercise such
27 powers and privileges throughout the state.

28 Sec. 4. K.S.A. 2011 Supp. 74-5605 is hereby amended to read as
29 follows: 74-5605. (a) Every applicant for certification shall be an
30 employee of a state, county or city law enforcement agency, a municipal
31 university police officer, a railroad policeman appointed pursuant to
32 K.S.A. 66-524, and amendments thereto; an employee of the tribal law
33 enforcement agency of an Indian nation that has entered into a tribal-state
34 gaming compact with this state; a manager or employee of the horsethief
35 reservoir benefit district pursuant to K.S.A. 2011 Supp. 82a-2212, and
36 amendments thereto; or a school security officer designated as a school
37 law enforcement officer pursuant to K.S.A. 72-8222, and amendments
38 thereto.

39 (b) Prior to admission to a course conducted at the training center or
40 at a certified state or local law enforcement agency, the ~~applicant~~
41 *applicant's appointing authority or agency head* shall furnish to the
42 director of police training *and to the commission* a statement ~~from the~~
43 ~~applicant's appointing authority or agency head certifying the applicant's~~

1 fulfillment of the following requirements. ~~The applicant certifying that the~~
2 ~~applicant has been found to meet the minimum requirements of~~
3 ~~certification established by this subsection. The commission may rely upon~~
4 ~~the statement of the appointing authority or agency head as evidence that~~
5 ~~the applicant meets the minimum requirements for certification to issue a~~
6 ~~provisional certification. Each applicant for certification shall meet the~~
7 ~~following minimum requirements:~~

8 ~~(a) (1) Is Be a United States citizen;~~

9 ~~(b) (2) has have been fingerprinted and a search of local, state and~~
10 ~~national fingerprint files has been made to determine whether the applicant~~
11 ~~has a criminal record;~~

12 ~~(c) (3) has not have been convicted, does not have an expunged~~
13 ~~conviction, and on and after July 1, 1995, has not been placed on diversion~~
14 ~~by any state or the federal government for a crime which is a felony or its~~
15 ~~equivalent under the uniform code of military justice of a crime that would~~
16 ~~constitute a felony under the laws of this state, a misdemeanor crime of~~
17 ~~domestic violence or a misdemeanor offense that the commission~~
18 ~~determines reflects on the honesty, trustworthiness, integrity or~~
19 ~~competence of the applicant as defined by rules and regulations of the~~
20 ~~commission;~~

21 ~~(d) has not been convicted, does not have an expunged conviction,~~
22 ~~has not been placed on diversion by any state or the federal government~~
23 ~~for a misdemeanor crime of domestic violence or its equivalent under the~~
24 ~~uniform code of military justice, when such misdemeanor crime of~~
25 ~~domestic violence was committed on or after the effective date of this act;~~

26 ~~(e) is the holder of a high school diploma or furnishes evidence of~~
27 ~~successful completion of an examination indicating an equivalent~~
28 ~~achievement;~~

29 ~~(4) have graduated from a high school accredited by the Kansas state~~
30 ~~board of education or the appropriate accrediting agency of another state~~
31 ~~jurisdiction or have obtained the equivalent of a high school education as~~
32 ~~defined by rules and regulations of the commission;~~

33 ~~(f) (5) is of be of sufficient~~ **sufficient** ~~good moral character~~ **sufficient** ~~to warrant~~
34 ~~the public trust in the applicant as a police officer or law enforcement~~
35 ~~officer;~~

36 ~~(g) (6) has completed a psychological test~~ ~~have completed an~~
37 ~~assessment, including psychological testing approved by the commission,~~
38 ~~to determine that the applicant does not have a mental or personality~~
39 ~~disorder that would adversely affect the ability to perform the essential~~
40 ~~functions of a police officer or law enforcement officer with reasonable~~
41 ~~skill, safety and judgment;~~

42 ~~(h) (7) is be free of any physical or mental condition which might~~
43 ~~adversely affect the applicant's performance of a police officer's or law~~

1 ~~enforcement officer's duties~~ adversely affects the ability to perform the
2 essential functions of a police officer or law enforcement officer with
3 reasonable skill, safety and judgment; and

4 ~~(†) (8) is be~~ at least 21 years of age.

5 (c) The commission may deny a provisional or other certification
6 upon a finding that the applicant has engaged in conduct for which a
7 certificate may be revoked, suspended or otherwise disciplined as
8 provided in K.S.A. 74-5616, and amendments thereto. When it appears
9 that grounds for denial of a certification exist under this subsection, after
10 a conditional offer of employment has been made to an applicant seeking
11 appointment as a police officer or law enforcement officer, the applicant's
12 appointing authority or agency head may request an order from the
13 commission to determine whether a provisional certification will be issued
14 to that applicant.

15 (d) As used in this section, "conviction" includes rendering of
16 judgment by a military court martial pursuant to the uniform code of
17 military justice, by a court of the United States or by a court of competent
18 jurisdiction in any state, whether or not expunged; **and** any diversion
19 agreement entered into for a misdemeanor crime of domestic violence and
20 any diversion agreement entered into on or after July 1, 1995, for a
21 felony; ~~and any felony juvenile adjudication or diversion after July 1,~~
22 ~~2012.~~

23 Sec. 5. K.S.A. 2011 Supp. 74-5607 is hereby amended to read as
24 follows: 74-5607. (a) In addition to other powers and duties prescribed by
25 law, the commission shall adopt, in accordance with the provisions of
26 K.S.A. 77-415 et seq., and amendments thereto, rules and regulations
27 necessary to carry out the provisions of ~~subsection (e) of K.S.A. 74-5616,~~
28 ~~and amendments thereto, and such other rules and regulations as necessary~~
29 ~~and to administer this the Kansas law enforcement training act.~~ The
30 commission may also adopt such rules of procedure or guidance
31 documents as are necessary for conducting the business of the commission.

32 (b) The commission or a designated committee or member of the
33 commission may conduct investigations and proceedings necessary to
34 carry out the provisions of the Kansas law enforcement training act. In all
35 investigations, hearings or other matters pending before the commission,
36 the commission or any person acting as a presiding officer for the
37 commission shall have the power to:

38 (1) Administer oaths and take testimony;

39 (2) issue subpoenas, compel the attendance of witnesses and the
40 production of any papers, books, accounts, documents and testimony, and
41 to cause the deposition of witnesses, either residing within or without the
42 state, to be taken in the manner prescribed by law for taking depositions in
43 civil actions in the district courts. In case of the failure of any person to

1 comply with any subpoena issued on behalf of the commission, or on the
2 refusal of any witness to testify to any matters regarding which the witness
3 may be lawfully ~~interrogated~~ *questioned*, the district court of any county,
4 on application of a member of the commission, may require compliance by
5 proceedings for contempt, as in the case of failure to comply with a
6 subpoena issued from such court or a refusal to testify in such court. Each
7 witness who appears before the commission by its order or subpoena,
8 other than a state officer or employee, shall receive for such attendance the
9 fees and mileage provided for witnesses in civil cases in courts of record
10 which shall be audited and paid upon presentation of proper vouchers
11 sworn to by such witnesses and approved by the chairperson of the
12 commission or by a person or persons designated by the chairperson;

13 (3) enter into contracts necessary to administer the provisions of ~~this~~
14 *the Kansas law enforcement training act* and the certification of law
15 enforcement officers; and

16 (4) assess the costs of such matters pending before the commission
17 under this section against the governmental entity employing the police
18 officer or law enforcement officer.

19 (c) Members of the commission attending meetings of the
20 commission, or attending a ~~subcommittee~~ *committee* meeting authorized
21 by the commission, shall be paid amounts provided for in subsection (e) of
22 K.S.A. 75-3223, and amendments thereto. The ~~director~~ *commission* shall
23 be responsible for approving all expense vouchers of members.

24 (d) The commission shall meet at least once each year at the training
25 center and may hold other meetings whenever they are called by the
26 chairperson.

27 (e) The commission shall adopt the rules and regulations that are
28 necessary to ensure that law enforcement officers are adequately trained
29 and to enforce the provisions of ~~this~~ *the Kansas law enforcement training*
30 *act*. Such rules and regulations shall include, but are not limited to, the
31 establishment of a course of fire as a standard qualification for active law
32 enforcement officers to carry firearms that may also be used for qualified
33 retired officers to carry firearms pursuant to federal law. The *director of*
34 *police training* shall provide qualification opportunities for qualified
35 retired officers ~~at least twice a year~~ at the times and places the director
36 determines to be necessary. The training center shall charge and collect a
37 fee from retired state, local and federal officers for the qualification
38 opportunities, but these fees shall be limited to the actual costs of
39 presenting the standard qualifications course.

40 (f) *On and after July 1, 2012, the commission shall require*
41 *fingerprinting of each applicant for certification under the Kansas law*
42 *enforcement training act, and may require fingerprinting of a person who*
43 *has received a certificate under the Kansas law enforcement training act*

1 *prior to July 1, 2012, if such person's conduct is investigated pursuant to*
2 *this section. The commission shall appoint an employee of the commission*
3 *whose official duty includes seeking and maintaining confidential*
4 *information as provided by this subsection. The appointed employee shall*
5 *submit fingerprints to the Kansas bureau of investigation and to the*
6 *federal bureau of investigation for the purpose of verifying the identity of*
7 *such applicant or certificate holder and for obtaining records of that*
8 *person's criminal arrests and convictions. Upon the request of the*
9 *appointed employee, the Kansas bureau of investigation and other*
10 *criminal justice agencies shall provide to the appointed employee all*
11 *background investigation information including criminal history record*
12 *information, arrest and nonconviction data and criminal intelligence*
13 *information. Such information, other than conviction data, shall be*
14 *confidential and shall not be disclosed by the appointed employee, except*
15 *for a purpose stated in this section. In addition to any other penalty*
16 *provided by law, unauthorized disclosure of such information shall be*
17 *grounds for removal from office or termination of employment.*

18 Sec. 6. K.S.A. 2011 Supp. 74-5607a is hereby amended to read as
19 follows: 74-5607a. (a) The commission shall not issue a certification as a
20 full-time police officer or law enforcement officer unless such officer has
21 been awarded a certificate attesting to satisfactory completion of a full-
22 time officer basic course of accredited instruction at the training center or
23 at a certified state or local law enforcement training school or has been
24 awarded such a certificate for not less than the number of hours of
25 instruction required by the Kansas law enforcement training act at the time
26 such certificate was issued or received a permanent appointment as a full-
27 time police officer or law enforcement officer prior to July 1, 1969, or was
28 appointed a railroad policeman pursuant to K.S.A. 66-524, and
29 amendments thereto, on or before January 1, 1982. No person shall receive
30 certification as a part-time police officer or law enforcement officer unless
31 such officer has been awarded a certificate attesting to the satisfactory
32 completion of a part-time officer basic course of instruction in law
33 enforcement at the training center or at a certified state or local law
34 enforcement training school.

35 (b) Beginning the second year after certification, every full-time
36 police officer or law enforcement officer shall complete annually 40 hours
37 of *continuing* law enforcement education or training in subjects relating
38 directly to law enforcement. Failure to complete such training shall be
39 grounds for suspension ~~from work without pay~~ *of a certificate issued*
40 *under the Kansas law enforcement training act* until such training is
41 completed, *except that the commission may stay any such suspension upon*
42 *a showing of hardship upon the employing law enforcement agency. The*
43 ~~director with the approval of the commission, in consultation with the~~

1 *director of police training*, shall adopt rules and regulations regarding such
2 education or training. Such education or training may include procedures
3 for law enforcement to follow when responding to an allegation of
4 stalking. Every city, county and state agency shall send to the director
5 certified reports of the completion of such education or training. The
6 ~~director~~ *commission* shall maintain a record of the reports in the central
7 registry.

8 (c) Subject to the provisions of subsection (d):

9 (1) Any person who is appointed or elected as a police officer or law
10 enforcement officer and who does not hold a certificate as required by
11 subsection (a) may be issued a provisional certificate for a period of one
12 year. The ~~director~~ *commission* may extend the one-year period for the
13 provisional certificate if in the ~~director's~~ *commission's* determination the
14 extension would not constitute an intentional avoidance of the
15 requirements of subsection (a). If a person's provisional certificate expires
16 or is revoked, the person shall not be issued another provisional certificate
17 within one year of the expiration or revocation. A provisional certificate
18 shall be revoked upon dismissal from any basic training program
19 authorized by K.S.A. 74-5604a, and amendments thereto. A provisional
20 certificate may be revoked upon voluntary withdrawal from any basic
21 training program authorized by K.S.A. 74-5604a, and amendments thereto.

22 (2) Any police officer or law enforcement officer who does not
23 complete the education or training required by subsection (b) by the date
24 such education or training is required to have been completed shall be
25 subject to revocation or suspension of certification and loss of the officer's
26 office or position.

27 (d) The ~~director~~ *commission* may extend, waive or modify the annual
28 continuing education requirement, when it is shown that the failure to
29 comply with the requirements of subsection (a) or (b) was not due to the
30 intentional avoidance of the law.

31 Sec. 7. K.S.A. 2011 Supp. 74-5608a is hereby amended to read as
32 follows: 74-5608a. (a) The ~~director~~ *commission* may, in the exercise of
33 discretion, award a certificate to any person who has been duly certified
34 under the laws of another state or territory if, in the opinion of the director
35 *of police training*, the requirements for certification in such other
36 jurisdiction equal or exceed the qualifications required to complete
37 satisfactorily the basic course of instruction at the training center.

38 (b) The ~~director~~ *commission* may waive any number of the hours or
39 courses required to complete the basic course of instruction at the training
40 center, part-time school, reciprocity school or for the hours required for
41 annual continuing education for any person who, in the opinion of the
42 director *of police training*, has received sufficient training or experience
43 that such hours of instruction ~~at the training center~~ would be, unless

1 waived, unduly burdensome or ~~duplicitous~~ *duplicative*.

2 Sec. 8. K.S.A. 2011 Supp. 74-5616 is hereby amended to read as
3 follows: 74-5616. (a) No person shall be appointed as a full-time law
4 enforcement officer unless the person holds a full-time active law
5 enforcement certificate or a provisional law enforcement certificate. No
6 person shall be appointed as a part-time officer unless the person holds a
7 full-time active law enforcement certificate, a part-time active law
8 enforcement certificate or a provisional certificate. ~~The commission's~~
9 ~~certification shall be awarded to persons who:~~

10 (1) ~~Received a permanent appointment as a police officer or law~~
11 ~~enforcement officer prior to July 1, 1969; or~~

12 (2) ~~hold a permanent appointment as a police officer or law~~
13 ~~enforcement officer on July 1, 1983.~~

14 (b) The commission may suspend, ~~revoke, reprimand, censure~~
15 ~~condition or revoke the certification of a police officer or law enforcement~~
16 ~~officer; reprimand or censure a police officer or law enforcement officer; or~~
17 deny the certification of a police officer or law enforcement officer who:

18 (1) Fails to meet *and maintain* the requirements of K.S.A. 74-5605 or
19 74-5607a, and amendments thereto, ~~or has met such requirements by~~
20 ~~falsifying documents or failing to disclose information required for~~
21 ~~certification;~~

22 (2) ~~fails to meet and maintain the minimum standards for certification~~
