Brief*

SB 102 would increase certain fees credited to the Governmental Ethics Commission Fee Fund.

Background

The executive director of the Governmental Ethics Commission testified in support of the bill. No neutral or opposition testimony was offered.

These fees are deposited into the Governmental Ethics Commission Fee Fund, and the balance of moneys needed to run the agency has come from the State General Fund. Other moneys that are deposited into the Fee Fund are civil penalties for failing to file reports properly and civil fines imposed for violations of the Campaign Finance Act and the State Governmental Ethics Law. The fees that would be increased in the bill were last increased in 2000.

The term "political committee" in Section 2 of the bill is defined in KSA 2010 Supp. 25-4143(k), as "any combination of two or more individuals or any person other than an individual, a major purpose of which is to expressly advocate the nomination, election, or defeat of a clearly identified candidate for state or local office or make contributions to or expenditures for the nomination, election or defeat of a clearly identified candidate for state or local office."

According to the fiscal note prepared by the Division of the Budget, the Governmental Ethics Commission estimated the bill would increase revenue to the Fee Fund by \$251,230 in fiscal year 2012 and by \$259,690 in fiscal year 2013. The Governor's proposed budget for fiscal year 2012 does anticipate a higher level of fee income, to allow for lower levels of State General Fund support.
