1	AN ACT concerning the emergency medical services board; imposition of
2	fines; investigation authority; issuance of subpoenas; amending K.S.A.
3	65-6130 and K.S.A2014 2015 Supp. 65-6111 and repealing the
4	existing sections.

6	Be it enacted by the Legislature of the State of Kansas:
7	Section 1. K.S.A2014 2015 Supp. 65-6111 is hereby amended to
8	read as follows: 65-6111. (a) The emergency medical services board shall:
9	(1) Adopt any rules and regulations necessary to carry out the
10	provisions of this act;
11	(2) review and approve the allocation and expenditure of moneys
12	appropriated for emergency medical services;
13	(3) conduct hearings for all regulatory matters concerning ambulance
14	services, attendants, instructor-coordinators, training officers and providers
15	of training;
16	(4) submit a budget to the legislature for the operation of the board;
17	(5) develop a state plan for the delivery of emergency medical
18	services;
19	(6) enter into contracts as may be necessary to carry out the duties
20	and functions of the board under this act;
21	(7) review and approve all requests for state and federal funding
22	involving emergency medical services projects in the state or delegate such
23	duties to the administrator executive director;
24	(8) approve all training programs for attendants, instructor-
25	coordinators and training officers and prescribe certification application
26	fees by rules and regulations;
27	(9) approve methods of examination for certification of attendants,
28	training officers and instructor-coordinators and prescribe examination
29	fees by rules and regulations;
30	(10) appoint a medical advisory council of not less than six members,
31	including-two one board-members, one of whom member who shall be a
32	physician and not less than-four five other physicians who are active and
33	knowledgeable in the field of emergency medical services who are not
34	members of the board to advise and assist the board in medical standards
35	and practices as determined by the board. The medical advisory council
36	shall elect a chairperson from among its membership and shall meet upon

1 the call of the chairperson; and

2 (11) approve providers of training by prescribing standards and 3 requirements by rules and regulations and withdraw or modify such 4 approval in accordance with the Kansas administrative procedures act and 5 the rules and regulations of the board.

6 (b) The emergency medical services board may grant a temporary 7 variance from an identified rule or regulation when a literal application or 8 enforcement of the rule or regulation would result in serious hardship and 9 the relief granted would not result in any unreasonable risk to the public 10 interest, safety or welfare.

11 (c) (1) In addition to or in lieu of any other administrative, civil or 12 criminal remedy provided by law, the board, in accordance with the 13 Kansas administrative procedure act, upon the finding of a violation of a 14 provision of this act or the provisions of article 61 of chapter 65 of the 15 Kansas Statutes Annotated, and amendments thereto, or rules and 16 regulations adopted pursuant to such provisions:

17 *(A)* May impose a fine on any person granted a certificate by the 18 board in an amount not to exceed \$500 for each violation; or

(B) may impose a fine on an ambulance service which holds a permit
to operate in this state or on a sponsoring organization in an amount not
to exceed \$2,500 for each violation.

(2) All fines assessed and collected under this section shall be
remitted to the state treasurer in accordance with the provisions of K.S.A.
75-4215, and amendments thereto. Upon receipt of each such remittance,
the state treasurer shall deposit the entire amount in the state treasury to
the credit of the state general fund.

27 (d) (1) In connection with any investigation by the board, the board or its duly authorized agents or employees shall at all reasonable times 28 29 have access to, for the purpose of examination and the right to copy any document, report, record or other physical evidence of any person being 30 31 investigated, or any document, report, record or other evidence 32 maintained by and in possession of any clinic, laboratory, pharmacy, 33 medical care facility or other public or private agency, if such document, 34 report, record or evidence relates to professional competence, 35 unprofessional conduct or the mental or physical ability of the person to 36 perform activities the person is authorized to perform.

37 (2) For the purpose of all investigations and proceedings conducted38 by the board:

39 (A) The board may issue subpoenas compelling the attendance and 40 testimony of witnesses or the production for examination or copying of 41 documents or any other physical evidence if such evidence relates to 42 professional competence, unprofessional conduct or the mental or 43 physical ability of a person being investigated to perform activities the 3

1 person is authorized to perform. Within five days after the service of the

2 subpoena on any person requiring the production of any evidence in the person's possession or under the person's control, such person may 3 petition the board to revoke, limit or modify the subpoena. The board shall 4 5 revoke, limit or modify such subpoena if in its opinion the evidence 6 required does not relate to practices which may be grounds for 7 disciplinary action, is not relevant to the charge which is the subject 8 matter of the proceeding or investigation, or does not describe with sufficient particularity the physical evidence which is required to be 9 produced. Any member of the board, or any agent designated by the 10 board, may administer oaths or affirmations, examine witnesses and 11 12 receive such evidence.

13 *(B)* Any person appearing before the board shall have the right to be 14 represented by counsel.

15 (*C*) The district court, upon application by the board or by the person 16 subpoenaed, shall have jurisdiction to issue an order:

(i) Requiring such person to appear before the board or the board's
duly authorized agent to produce evidence relating to the matter under
investigation; or

(ii) revoking, limiting or modifying the subpoena if in the court's
opinion the evidence demanded does not relate to practices which may be
grounds for disciplinary action, is not relevant to the charge which is the
subject matter of the hearing or investigation or does not describe with
sufficient particularity the evidence which is required to be produced.

25 (3) Disclosure or use of any such information received by the board or of any record containing such information, for any purpose other than 26 that provided by this subsection is a class A misdemeanor and shall 27 28 constitute grounds for removal from office, termination of employment or 29 denial, revocation or suspension of any certificate or permit issued under article 61 of chapter 65 of the Kansas Statutes Annotated, and 30 31 amendments thereto. Nothing in this subsection shall be construed to make 32 unlawful the disclosure of any such information by the board in a hearing 33 held pursuant to this act.

(4) Patient records, including clinical records, medical reports,
laboratory statements and reports, files, films, other reports or oral
statements relating to diagnostic findings or treatment of patients,
information from which a patient or a patient's family might be identified,
peer review or risk management records or information received and
records kept by the board as a result of the investigation procedure
outlined in this subsection shall be confidential and shall not be disclosed.

(5) Nothing in this subsection or any other provision of law making
 communications between a physician and the physician's patient a
 privileged communication shall apply to investigations or proceedings

conducted pursuant to this subsection. The board and its employees,
 agents and representatives shall keep in confidence the names of any
 patients whose records are reviewed during the course of investigations
 and proceedings pursuant to this subsection.

5 (e) The emergency medical services board shall prepare an annual 6 report on or before January 15 of each year on the number, amount and 7 reasons for the fines imposed by the board and the number of and reasons 8 for subpoenas issued by the board during the previous calendar year. The 9 report shall be provided to the senate committee on federal and state 10 affairs and the house committee on federal and state affairs.

Sec. 2. K.S.A. 65-6130 is hereby amended to read as follows: 65-6130. (*a*) The board may inquire into the operation of ambulance services and the conduct of attendants, and may conduct periodic inspections of facilities, communications services, materials and equipment at any time without notice.

16 (b) The board may issue subpoen in accordance with the provisions 17 of K.S.A. 65-6111(d), and amendments thereto, to compel an operator holding a permit to make access to or for the production of records 18 19 regarding services performed and to furnish such other information as the 20 board may require to carry out the provisions of this act to the same extent 21 and subject to the same limitations as would apply if the subpoenas were 22 issued or served in aid of a civil action in the district court. A copy of such 23 records shall be kept in the operator's files for a period of not less than 24 three years.

(c) The board also may require operators to submit lists of personnel
 employed and to notify the board of any changes in personnel or in
 ownership of the ambulance service.

Sec. 3. K.S.A. 65-6130 and K.S.A. <u>2014</u> 2015 Supp. 65-6111 are
hereby repealed.
