Testimony in Support of House Bill 2545

February 12, 2018

Chairman Barker and members of the House Federal and State Affairs Committee, thank you for the opportunity to testify on a topic that is very near to me. In fact, Camptown Greyhound Park in Frontenac is basically across the street from my home place. You have heard much testimony about the economic impacts to the state. The number of jobs created both in the industry and the restoration of the facilities. You have the numbers in front of you. We can all dispute the actual dollars and cents, but what we can't dispute is the current situation. Other than a small portion of property tax paid, local and state government gets zero. We in the Legislature have an opportunity to change that. All we need to do is tweak the percentages, and these tracks will be up and running again. Today you have heard about tax parity and the fact that we are not expanding gaming. Current laws allow these facilities to operate, however, for any business to be open, it has to be profitable. These changes will allow that.

We make and alter laws every year in this building. When something doesn't work for our constituents we change it. Don't let anyone convince you that we can't make changes to the law. We can. The Legislature did it as recent as four years ago. When we lowered the minimum investment and privilege fee to allow the Kansas Crossing to exist. I championed that legislation and I advocate for racing today. I know the two can co-exist. Oklahoma is proof of that. The addition of these facilities will create a destination region, not just another casino. This will be an enhancement to all the state- owned facilities. More people more money.

As you know, I represent Southeast Kansas. I have lived there my whole life. I am a member of just about every group we have. I know what 650 new jobs will mean to Crawford County. Currently the county receives \$17,314.80 in property taxes. When operational, the county will receive \$1.4 million in property taxes just from the track. That is not to mention the additional tax money that will

be received from the people who will work there. This is huge for our school district, our city, and our county. It is not just our community, it is all the communities at home. Our biggest employers are the Hospital and Pittsburg State University. These will be real private sector jobs, good paying jobs that we need.

In closing, I just want to remind you this is not expanding gaming. These places currently exist. It simply levels the playing field. It is all Mr. Ruffin's money, no state funds. It is money to this huge deficit that we can use to teach kids and pave roads. As Jethro said, naught from naught is naught. We currently get nothing.
