My name is Erika Swafford. I'm a resident of Clearwater, KS, and I suffer from Epilepsy. I was thrilled when CBD oil became available, as I was able to attempt to treat my disease naturally, and stop my seizure medication; thus stopping the torture that the medications' side effects cause. While being medicated with numerous prescriptions, I was suffering migraines, teeth decay, memory loss, brain fog, and most of all seizures! With CBD oil, I have stopped having most of these issues, except I still have seizures. The reason for that is because CBD oil alone isnt enough to treat my epilepsy. I need access to the whole plant, and all of its life saving benefits! There are three main reasons I want Marijuana legalized and free to heal in Kansas, here they are:

1. I lost my father to prescription pills and the side effects from those medications. My dad was injured at work in 2001. He was burned over most of his body, with sulfuric acid. He suffered pain that was unimagineable. His injuries sistained and pain endured, led to a string of prescription drugs. Oxycontin, Dillata, Loritab, the list goes on and on. It got to the point that they prescribed him two scripts of loritabs, simply for breakthrough pain from his other medications, because they and I quote, "didnt have anything else to give him." He was patched up and pilled out, almost a walking zombie. I'm 100% sure, my dad would still be here, and would be functioning and enjoying that life, if he wouldve been afforded the opportunity to treat his pain with marijuana. His organs wouldnt have shriveled up and died at the hands of his medication, like they did. The 8 years he lived medicated, were not happy years. He simply existed, most of the time spent in and out of hospice. He could no longer drive to the store, he couldnt go to work, he couldnt be left unsupervised, becuase of the sheer amount of medication he was on. That was not a life. I wish he could've lived to see his 50th birthday. I wish he couldve treated his [ain with marijuana, instead of synthetic heroine. I wish he could've lived long enough, to see his baby girl finally be able to live seizure free, and able to treat her disease with marijuana.

2. I lost my father in law to SUDEP, Sudden death due to Epilepsy. He spent his entire life suffering seizures. He went through a handfull of medications and finally settled with dilantin, which still never stopped his seizures. He suffered his entire life battling this disease. He was so careful about taking his medications on time. Most people dont realize the importance of taking your medication right on time, and the detremental effects that could happen if you dont. Thats like being a prisoner to your medication. He was always on top of it though, down to the minute! I wish his caeful following of his doctors orders, wouldve been enough. He sadly lost his battle, and had a seizure and fell into the bathtub. My mother in law wasnt strong enough to pull him out in time, and when the ambulance got there he was gone. I think that my father in law could still be here with us today if he was allowed the opportunity to treat his disease with marijuana. He shouldve been afforded the rights to access to the entire plant. Whatever it may take to cure him, he shouldve been given the chance to try.

3. I dont want my son to suffer in the same way i have. I dont want him to lose a parent because of something that could have been avoided. I dont want him to have to care for me when ive had a seizure. It breaks my heart that he knows so well how to nurse an epileptic person. Thats a scary thing to have to watch a stranger go through, and he has had to watch his own mother have countless seizutres. No child should have to watch that. I dont want his mother to be another stastic.

I'm sincerely asking you to take into consideration my words. I have suffered greatly from Epilepsy. I take CBD oil regularly, and while it has helped more than the prescriptions ever did, it isnt enough! I understand what's happening when i have a seizure. There are babies and toddlers having seizures left and right, and they dont get it. How hard that must be to face everyday as a parent. I cannot begin to imagine. I have managed to stay put this long, and as a born and raised proud Kansan, I hope to keep it that way. I dont want to have to uproot my life and my family, because I can't safely take care of my disease. Think of all the heroine users that all started out taking pain pills, and then became addicted and desperate. If we focus on CBD only, people will still rely on prescriptions for pain relief. That would'nt be happening with marijuana. Stop the opiate overdoses. Its medically impossible to overdose on marijuana. You would be saving lives.
