HB 2579, as amended, seeks to provide compensation for a person who was wrongfully convicted and imprisoned by creating a civil cause of action.

Subsection (a) - A "claimant" is a person convicted and subsequently imprisoned for one or more crimes that such person did not commit	Subsection (a) Same

Subsection (c) - Claimant is required to establish four facts by a preponderance of evidence: (1) The claimant was convicted of a felony crime and subsequently imprisoned; (2) the claimant's judgment of conviction was reversed or vacated and either the charges were dismissed or on retrial the claimant was found to be not guilty; (3) the claimant did not commit the crime or crimes for which the claimant was convicted and was not an accessory or accomplice to the acts that were the basis of the conviction; and (4) the claimant did not commit or suborn perjury, fabricate evidence, or by the claimant's own conduct cause or bring about the conviction	Subsection (c) Same
