MADAM PRESIDENT:

I move to amend **Senate Substitute for HB 2002**, on page 15, following line 29, by inserting:

"Sec. 47. No expenditures shall be made from any moneys appropriated for the fiscal year ending June 30, 2018, from the state general fund or any special revenue fund or funds by 2017 Substitute for Senate Bill No. 189, this or other appropriation act of the 2017 regular session of the legislature, by any state agency for any out-of-state travel for any state employee for the fiscal year ending June 30, 2018, unless specifically authorized by the governor or the secretary of administration for any state agency within the executive branch, by the chief justice for any agency within the judicial branch, or by the president of the senate or the speaker of the house of representatives for any agency within the legislative branch: Provided, That, if an employee is specifically authorized to travel, the employee must report their name, their destination, and whether the travel is out-of-state or international to the director of the budget: Provided further, That the amount equal to the aggregate of any savings from this section from each account of the state general fund of each state agency for the fiscal year ending June 30, 2018, as determined and certified by the director of the budget to the director of accounts and reports, is hereby lapsed: Provided further, That, on or before June 30, 2018, the director of the budget shall certify each amount appropriated from each special revenue fund, which is certified by the director the of budget pursuant to this section to be for out-of-state travel, to the director of accounts and reports and, upon receipt of such certification, the amount so certified is hereby transferred to the state general fund: Provided further, That, at the same time that each certification is made by the director of the budget to the director of accounts and reports under this subsection, the director of the budget shall deliver a copy of such certification and travel authorization

information to the director of legislative research: *And provided further*, That the provisions of this section shall not apply to any federal funds that are not authorized to be transferred pursuant to federal law or guidelines.

Sec. 48. No expenditures shall be made from any moneys appropriated for the fiscal year ending June 30, 2019, from the state general fund or any special revenue fund or funds by 2017 Substitute for Senate Bill No. 189, this or other appropriation act of the 2017 or 2018 regular session of the legislature, by any state agency for any out-of-state travel for any state employee for the fiscal year ending June 30, 2019, unless specifically authorized by the governor or the secretary of administration for any state agency within the executive branch, by the chief justice for any agency within the judicial branch, or by the president of the senate or the speaker of the house of representatives for any agency within the legislative branch: *Provided*, That, if an employee is specifically authorized to travel, the employee must report their name, their destination, and whether the travel is out-of-state or international to the director of the budget: Provided further, That the amount equal to the aggregate of any savings from this section from each account of the state general fund of each state agency for the fiscal year ending June 30, 2019, as determined and certified by the director of the budget to the director of accounts and reports, is hereby lapsed: Provided further, That, on or before June 30, 2019, the director of the budget shall certify each amount appropriated from each special revenue fund, which is certified by the director of the budget pursuant to this section to be for out-of-state travel, to the director of accounts and reports and, upon receipt of such certification, the amount so certified is hereby transferred to the state general fund: Provided further, That, at the same time that each certification is made by the director of the budget to the director of accounts and reports under this subsection, the director of the budget shall deliver a copy of such certification and travel authorization information to the director of legislative research: And provided further, That the provisions of this section shall not apply to any federal funds that are not authorized to be transferred pursuant to federal
