AN ACT concerning motor vehicles; relating to registration, decals for
 persons with disabilities; distinctive license plates; decals for certain
 military medals or badges; amending K.S.A. 8-1,126 and K.S.A. 2016
 Supp. 8-1,125 and 8-1,156 and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

7 New Section 1. (a) On and after January 1, 2018, any owner or lessee 8 of one or more passenger vehicles or trucks registered for a gross weight 9 of 20,000 pounds or less, who is a resident of Kansas, upon compliance 10 with the provisions of this section, may be issued one autism awareness 11 license plate for each such passenger vehicle or truck. Such license plates 12 shall be issued for the same time as other license plates upon proper 13 registration and payment of the regular license fee as provided in K.S.A. 8-14 143, and amendments thereto, and either the payment to the county treasurer of the logo use royalty payment established by autism hope for 15 16 families, inc., or the presentation of the annual logo use authorization 17 statement provided for in subsection (b).

18 (b) The board of directors of autism hope for families, inc., may 19 authorize the use of their logo to be affixed on license plates as provided 20 by this section. Any royalty payment received pursuant to this section shall 21 be used to support autism hope for families, inc. Any motor vehicle owner 22 or lessee annually may apply to autism hope for families, inc., for use of 23 such logo. Upon annual application and payment to either: (1) Autism 24 hope for families, inc., in an amount of not less than \$25 nor more than 25 \$100 as a logo use royalty payment for each such license plate to be 26 issued, autism hope for families, inc., shall issue to the motor vehicle 27 owner or lessee, without further charge, a logo use authorization statement, 28 which shall be presented by the motor vehicle owner or lessee at the time 29 of registration; or (2) the county treasurer of the logo use royalty payment 30 for each license plate to be issued.

(c) Any applicant for a license plate authorized by this section may make application for such plates not less than 60 days prior to such person's renewal of registration date, on a form prescribed and furnished by the director of vehicles, and any applicant for such license plates shall either provide the annual logo use authorization statement provided for in subsection (b) or pay to the county treasurer the logo use royalty payment 1 established by autism hope for families, inc. Application for registration of 2 a passenger vehicle or truck and issuance of the license plate under this 3 section shall be made by the owner or lessee in a manner prescribed by the 4 director of vehicles upon forms furnished by the director.

(d) No registration or license plate issued under this section shall be 6 transferable to any other person.

7 (e) The director of vehicles may transfer autism awareness license 8 plates from a leased motor vehicle to a purchased motor vehicle.

9 (f) Renewals of registration under this section shall be made annually, 10 upon payment of the fee prescribed in subsection (a), in the manner prescribed in K.S.A. 8-132(b), and amendments thereto. No renewal of 11 registration shall be made to any applicant until such applicant provides to 12 13 the county treasurer either the annual logo use authorization statement provided for in subsection (b) or the payment of the annual royalty 14 payment established by autism hope for families, inc. If such statement is 15 16 not presented at the time of registration or faxed by autism hope for 17 families, inc., or the annual royalty payment is not made to the county 18 treasurer, the applicant shall be required to comply with the provisions of 19 K.S.A. 8-143, and amendments thereto, and return the license plate to the 20 county treasurer of such person's residence.

21 (g) Autism hope for families, inc., shall provide to all county 22 treasurers a toll-free telephone number where applicants can call autism 23 hope for families, inc., for information concerning the application process 24 or the status of such applicant's license plate application.

25 (h) As a condition of receiving the autism awareness license plate and any subsequent registration renewal of such plate, the applicant must 26 27 provide consent to the division authorizing the division's release of motor 28 vehicle record information, including the applicant's name, address, 29 royalty payment amount, plate number and vehicle type to autism hope for 30 families, inc., and the state treasurer.

31 (i) Annual royalty payments collected by county treasurers under this 32 section shall be remitted to the state treasurer in accordance with the 33 provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of 34 each such remittance the state treasurer shall deposit the entire amount in 35 the state treasury to the credit of the autism awareness royalty fund, which 36 is hereby created in the state treasury and shall be administered by the state 37 treasurer. All expenditures from the autism awareness royalty fund shall be 38 made in accordance with appropriation acts upon warrants of the director 39 of accounts and reports issued pursuant to vouchers approved by the state treasurer or the state treasurer's designee. Payments from the autism 40 awareness royalty fund to the appropriate designee of autism hope for 41 families, inc., shall be made on a monthly basis. 42

43 New Sec. 2. (a) On and after January 1, 2018, any owner or lessee of

1 one or more passenger vehicles or trucks registered for a gross weight of 2 20,000 pounds or less, who is a resident of Kansas, upon compliance with 3 the provisions of this section, may be issued one Kansas 4-H foundation 4 license plate for each such passenger vehicle or truck. Such license plates 5 shall be issued for the same time as other license plates upon proper 6 registration and payment of the regular license fee as provided in K.S.A. 8-7 143, and amendments thereto, and either the payment to the county 8 treasurer of the logo use royalty payment established by the Kansas 4-H 9 foundation, inc. or the presentation of the annual logo use authorization 10 statement provided for in subsection (b).

(b) The Kansas 4-H foundation, inc. may authorize the use of the 11 12 organization's logo to be affixed on license plates as provided by this 13 section. Any royalty payment received pursuant to this section shall be used to support the Kansas 4-H foundation, inc. Any motor vehicle owner 14 15 or lessee annually may apply to the Kansas 4-H foundation, inc. for use of 16 such logo. Upon annual application and payment to either: (1) The Kansas 17 4-H foundation, inc. in an amount of not less than \$25 nor more than \$100 18 as a logo use royalty payment for each such license plate to be issued, the 19 Kansas 4-H foundation, inc. shall issue to the motor vehicle owner or 20 lessee, without further charge, a logo use authorization statement that shall 21 be presented by the motor vehicle owner or lessee at the time of 22 registration; or (2) the county treasurer of the logo use royalty payment for 23 each license plate to be issued.

24 (c) Any applicant for a license plate authorized by this section may 25 make application for such license plate not less than 60 days prior to such 26 person's renewal of registration date, on a form prescribed and furnished 27 by the director of vehicles, and any applicant for such license plate shall 28 either provide the annual logo use authorization statement provided for in 29 subsection (b) or pay to the county treasurer the logo use royalty payment 30 established by the Kansas 4-H foundation, inc. Application for registration 31 of a passenger vehicle or truck and issuance of the license plate under this 32 section shall be made by the owner or lessee in a manner prescribed by the 33 director of vehicles upon forms furnished by the director.

34 (d) No registration or license plate issued under this section shall be35 transferable to any other person.

(e) The director of vehicles may transfer Kansas 4-H foundation
 license plates from a leased vehicle to a purchased vehicle.

(f) Renewals of registration under this section shall be made annually, upon payment of the fee prescribed in subsection (a), in the manner prescribed in K.S.A. 8-132(b), and amendments thereto. No renewal of registration shall be made to any applicant until such applicant provides to the county treasurer either the annual logo use authorization statement provided for in subsection (b) or the payment of the annual royalty payment established by the Kansas 4-H foundation, inc. If such statement is not presented at the time of registration or faxed by the Kansas 4-H foundation, inc., or the annual royalty payment is not made to the county treasurer, the applicant shall be required to comply with the provisions of K.S.A. 8-143, and amendments thereto, and return the license plate to the county treasurer of such person's residence.

7 (g) The Kansas 4-H foundation, inc. shall provide to all county 8 treasurers an electronic mail address where applicants can contact the 9 Kansas 4-H foundation, inc. for information concerning the application 10 process or the status of such applicant's license plate application.

(h) As a condition of receiving the Kansas 4-H foundation license
plate and any subsequent registration renewal of such license plate, the
applicant must provide consent to the division authorizing the division's
release of motor vehicle record information, including the applicant's
name, address, royalty payment amount, plate number and vehicle type to
the Kansas 4-H foundation, inc. and the state treasurer.

17 (i) Annual royalty payments collected by county treasurers under this 18 section shall be remitted to the state treasurer in accordance with the 19 provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of 20 each such remittance the state treasurer shall deposit the entire amount in 21 the state treasury to the credit of the Kansas 4-H foundation royalty fund, 22 which is hereby created in the state treasury and shall be administered by 23 the state treasurer. All expenditures from the Kansas 4-H foundation 24 royalty fund shall be made in accordance with appropriation acts upon 25 warrants of the director of accounts and reports issued pursuant to 26 vouchers approved by the state treasurer or the state treasurer's designee. 27 Payments from the Kansas 4-H foundation royalty fund to the appropriate 28 designee of the Kansas 4-H foundation, inc. shall be made on a monthly 29 basis.

30 Sec. 3. On and after January 1, 2018, K.S.A. 2016 Supp. 8-1,125 is 31 hereby amended to read as follows: 8-1,125. (a) Any Kansas resident who 32 submits satisfactory proof to the director of vehicles, on a form provided 33 by the director, that such person is a person with a disability or is 34 responsible for the transportation of a person with a disability shall be 35 issued a special license plate or a permanent placard for any motor vehicle 36 owned by such person or shall be issued a temporary placard. Satisfactory 37 proof of disability, condition or impairment shall include a statement from 38 a person licensed to practice the healing arts in any state, a licensed 39 optometrist, an advanced practice registered nurse licensed under K.S.A. 40 65-1131, and amendments thereto, a licensed physician assistant or a 41 Christian Science practitioner listed in The Christian Science Journal 42 certifying that such person is a person with a disability. The placard shall 43 be suspended immediately below the rear view mirror of any motor on of a ne

1 vehicle used for the transportation of a person with a disability so as to be 2 maximally visible from outside the vehicle. In addition to the special 3 license plate or permanent placard, the director of vehicles shall issue to 4 the person with a disability an individual identification card which must be 5 carried by the person with a disability when the motor vehicle being 6 operated by or used for the transportation of such person is parked in 7 accordance with the provisions of K.S.A. 8-1,126, and amendments 8 thereto. In addition to the temporary placard, a person issued such temporary placard shall carry the state or county receipt showing the name 9 10 of the person who is issued such temporary placard. A person submitting satisfactory proof that such person's disability, condition or impairment is 11 12 permanent in nature, and upon such person's request and payment of the fees prescribed in subsection (b), shall be issued an individual 13 14 identification card and: (1) A permanent placard-or; (2) a permanent placard and a special license plate and an individual identification eard; or 15 (3) a permanent placard and a wheelchair emblem decal to be affixed to a 16 17 distinctive license plate. Upon proper request, one additional permanent placard shall be issued to the applicant who has not requested and received 18 19 a special license plate. Upon proper request, one additional temporary 20 placard shall be issued to the applicant certified as temporarily disabled. 21 Temporary placards shall have an expiration date of not longer than six 22 months from the date of issuance. The special license plates, decals and 23 placards shall display the international symbol of access to the physically 24 disabled.

25 Special license plates issued pursuant to this section shall be (b) issued for the same period of time as other license plates are issued or for 26 27 the remainder of such period if an existing license plate is to be exchanged 28 for the special license plate. There shall be no fee for such special license 29 plates in addition to the regular registration fee. No person shall be issued more than one special license plate, except that agencies or businesses 30 31 which provide transportation for persons with a disability as a service, may 32 obtain additional special license plates for vehicles which are utilized in 33 the provision of that service. Special license plates may be personalized 34 license plates subject to the provisions of K.S.A. 8-132, and amendments 35 thereto, including the payment of the additional fee.

(c) Placards and individual identification cards issued pursuant to this
section shall be valid as long as the person or a person responsible for the
transportation of a person with a disability is eligible for a special license
plate or permanent placard. The secretary of revenue shall promulgate the
rules and regulations necessary to remain compliant with 23 C.F.R. §
1235.4.

42 (d) The color of the permanent placard shall be white on a blue 43 background and the temporary placard shall be white on a red background. 1 (e) In addition to such other information contained on individual 2 identification cards, cards shall have the date of birth and the sex of the 3 person to whom the card is issued.

4 (f) Permanent placards and individual identification cards shall be 5 returned to the department of revenue upon the death of the person with a 6 disability. Temporary placards shall be returned to the department of 7 revenue upon the expiration of the placard or upon the death of the person 8 with a disability. Special license plates shall be returned to the county 9 treasurer to be exchanged for another license plate upon the death of the person with a disability. The individual identification cards issued with the 10 special license plates shall be returned to the department of revenue upon 11 12 the death of the person with a disability.

13 (g) Violation of subsection (f) is an unclassified misdemeanor punishable by a fine of not more than \$50. 14

15 Sec. 4. On and after January 1, 2018, K.S.A. 8-1,126 is hereby 16 amended to read as follows: 8-1,126. When a motor vehicle which bears a special license plate-or, placard or decal issued pursuant to K.S.A. 8-17 18 1,125, and amendments thereto, is being operated by or used for the transportation of a person with a disability, such motor vehicle: 19

20 (a) May be parked in any parking space, whether on public or private 21 property, which is clearly marked as being reserved for the use of persons 22 with a disability or persons responsible for the transportation of a person 23 with a disability, except a parking space on private property which is 24 clearly marked as being reserved for the use of a specified person with a 25 disability;

26 (b) may be parked for a period of time not to exceed 24 hours in any 27 parking zone which is restricted as to the length of parking time permitted, 28 except where stopping, standing or parking is prohibited to all vehicles, 29 where parking is reserved for special types of vehicles or where parking 30 would clearly present a traffic hazard; and

31 (c) shall be exempt from any parking meter fees of the state or any 32 city, county or other political subdivision.

33 Sec. 5. K.S.A. 2016 Supp. 8-1,156 is hereby amended to read as 34 follows: 8-1,156. (a) Any person issued a distinctive military license plate, 35 upon submitting satisfactory proof to the director of vehicles in accordance 36 with rules and regulations adopted by the secretary that such person was 37 awarded a silver star or bronze star medal by the United States 38 government, may request a decal for each license plate indicating the 39 person was a recipient of a silver star or bronze star medal.

40 (b) Any person issued a distinctive military license plate, upon 41 submitting satisfactory proof to the director of vehicles in accordance with rules and regulations adopted by the secretary that such person was 42 43 awarded a combat medical badge, combat infantry badge, combat action

badge, navy/marine corps combat action ribbon, army distinguished 1 service cross, navy cross, air force cross-or, distinguished flying cross, 2 army of occupation medal or navy occupation service medal by the United 3 States government, may request a decal for each license plate indicating 4 5 the person was a recipient of a combat medical badge, combat infantry 6 badge, combat action badge, navy/marine corps combat action ribbon, 7 army distinguished service cross, navy cross, air force cross-or, 8 distinguished flying cross, army of occupation medal or navy occupation 9 service medal.

10 (c) A fee of \$2 shall be paid for each decal issued. The director of 11 vehicles shall design such decals. Such decals shall be affixed to the 12 license plate in the location required by the director. Not more than two 13 decals authorized by this section shall be affixed to any one license plate.

(d) As used in this section, "distinctive military license plate" means
any distinctive license plate for which a person is required to submit proof
of military service to the director of vehicles.
