AN ACT-concerning relating to mental health care; medical student and 1 2 resident loan assistance; relating to medical student loan agreements; practice commitment agreements; providing for agreements for the 3 practice of psychiatry; establishing the psychiatry medical loan 4 5 repayment fund and the rural health bridging psychiatry fund; {concerning mental healthcare facilities;} amending K.S.A. 76-387 6 {and 76-12a07} and K.S.A. 2016 Supp. {75-3373,} 76-381, 76-382, 7 8 76-383-and, 76-384 and 76-385 and repealing the existing sections.

10 Be it enacted by the Legislature of the State of Kansas:

11 Section 1. K.S.A. 2016 Supp. 76-381 is hereby amended to read as 12 follows: 76-381. As used in K.S.A. 76-380 through 76-386, and 13 amendments thereto:

(a) "Act" means the medical student loan act;

(b) "approved postgraduate residency training program" means a
residency training program in general pediatrics, general internal
medicine, family medicine, family practice, emergency medicine, *general psychiatry, child psychiatry* or fellowship training in geriatric medicine;

19 (c) "service commitment area" means: (1) Any community within any county in Kansas other than Douglas, Johnson, Sedgwick, Shawnee or 20 Wyandotte county; (2) any state medical care facility or institution; (3) any 21 22 medical center operated by the veterans administration of the United 23 States; (4) the full-time faculty of the university of Kansas school of medicine in family medicine-or, family practice, general psychiatry or 24 25 child psychiatry; or (5) any community within Wyandotte county for purposes of any practice obligation under an agreement entered into by a 26 27 person who is enrolled for the first time after July 1, 2004, in a course of 28 study leading to the medical degree; and

(d) "state medical care facility or institution" includes, but is not limited to, the Kansas state school for the visually handicapped, the Kansas state school for the deaf, any institution under the secretary for aging and disability services, as defined by-subsection (b) of K.S.A. 761 12a01, and amendments thereto, any institution under the commissioner of juvenile justice as defined by K.S.A. 2016 Supp. 38-2302, and 2 amendments thereto, the Kansas soldiers' home, the Kansas veterans' home 3 and any correctional institution under the secretary of corrections, as 4 defined by subsection (d) of K.S.A. 75-5202, and amendments thereto, but 5 6 shall not include any state educational institution under the state board of 7 regents, as defined by-subsection (a) of K.S.A. 76-711, and amendments 8 thereto, except as specifically provided by statute.

9 Sec. 2. K.S.A. 2016 Supp. 76-382 is hereby amended to read as 10 follows: 76-382. (a) There is hereby established the medical student loan 11 program at the university of Kansas school of medicine.

12 (b) Subject to the provisions of appropriation acts, the university of Kansas school of medicine may make medical student loans in 13 accordance with the provisions of this act to undergraduate students 14 enrolled in or admitted to the university of Kansas school of medicine in 15 16 a course of instruction leading to the degree of doctor of medicine who 17 enter into a written medical student loan agreement with the university 18 of Kansas school of medicine in accordance with K.S.A. 76-383, and 19 amendments thereto.

20 (c) Each medical student loan agreement under this act shall 21 provide to the person receiving the loan the payment of all tuition and a 22 stipend for living expenses in an amount of up to \$2,000 per month for 23 each month enrolled in such school during a year. Subject to the 24 maximum amount, the amount of the monthly stipend shall be 25 determined on an annual basis by the student receiving the loan.

26 (d) Subject to the provisions of appropriation acts, medical student loan agreements under this act may be entered into on an annual basis 27 28 and shall provide the payment of the amounts specified under subsection 29 (c) for one year unless otherwise terminated before such period of time. Subject to the provisions of appropriation acts, an undergraduate 30 student enrolled in or admitted to the university of Kansas school of 31 32 medicine in a course of instruction leading to the degree of doctor of 33 medicine may receive a separate loan under this act for each separate year the student enters into a written medical student loan agreement 34 35 with the university of Kansas school of medicine in accordance with 36 K.S.A. 76-383, and amendments thereto. Loans may be awarded 37 retroactively for any academic year that a student has completed 38 successfully at the university of Kansas medical school, but for which a 39 loan had not previously been awarded. Retroactive loans shall be in an amount equal to the amount of tuition paid by the student, plus a stipend 40 41 in an amount not to exceed the maximum amount of the stipend for such academic year multiplied by the number of months for which the 42 43 student was enrolled at the medical school during such year. For each

separate year a student receives a loan under this act, the student shall
 engage in the full-time practice of medicine and surgery in an
 appropriate service commitment area for a period of 12 months unless
 such obligation is otherwise satisfied as provided in K.S.A. 76-386, and
 amendments thereto.

6 (e) Medical student loans shall be awarded on a priority basis as 7 follows, first to qualified applicants who are Kansas residents at the time 8 of entry into the university of Kansas school of medicine, and second, to 9 qualified applicants who are not Kansas residents at the time of entry 10 into the university of Kansas school of medicine. As used in this 11 subsection, "Kansas residents" means persons who meet the residence 12 requirements established in K.S.A. 76-729, and amendments thereto.

13 (f) Subject to appropriations, the university of Kansas school of medicine shall enter into medical student loan agreements with six 14 individuals who commit to satisfy obligations to engage in the full-time 15 16 practice of medicine and surgery in a service commitment area by: (1) 17 Serving as a full-time faculty member of the university of Kansas school of 18 medicine in general psychiatry or child psychiatry pursuant to K.S.A. 76-19 384(c), and amendments thereto; or (2) performing at least 100 hours per 20 month of on-site mental health care pursuant to K.S.A. 76-384(d), and 21 amendments thereto.

Sec.-2: 3. K.S.A. 2016 Supp. 76-383 is hereby amended to read as follows: 76-383. A medical student loan agreement entered into by the university of Kansas school of medicine and an undergraduate student enrolled in or admitted to the university of Kansas school of medicine in a course of instruction leading to the degree of doctor of medicine for the purpose of receiving a medical student loan under this act shall require that the person receiving the loan:

(a) Complete the required course of instruction and receive the degree
 of doctor of medicine and apply for, enter and complete an approved
 postgraduate residency training program;

(b) apply for and obtain a license to practice medicine and surgery inKansas;

(c) engage in the full-time practice of medicine and surgery for a
period of 12 months within a service commitment area, except as
otherwise provided in-subsection (e) of K.S.A. 76-384(c), and amendments
thereto, for service as a full-time faculty member of the university of
Kansas school of medicine in family medicine-or, family practice, general *psychiatry or child psychiatry*;

(d) commence such full-time practice of medicine and surgery within
nine months after completion of an approved postgraduate residency
training program and licensure in a service commitment area and continue
such full-time practice in such service commitment area for a consecutive

period of months equal to the total number of months required under the
 agreement;

3 (e) agree that the service commitment for each agreement entered into 4 under this act is in addition to the service commitment contained in any 5 other agreement which has been or may be entered into under this act for 6 the purpose of obtaining a medical student loan or under other agreements 7 for the purpose of obtaining scholarship aid;

8 (f) maintain records and make reports to the university of Kansas 9 school of medicine to document the satisfaction of the obligation under 10 such agreement to engage in the full-time practice of medicine and surgery 11 within a service commitment area and to continue such full-time practice 12 in such service commitment area for a consecutive period of months equal 13 to the total number of months required under the agreement; and

(g) upon failure to satisfy an agreement to engage in the full-time
practice of medicine and surgery within a service commitment area for the
required period of time under any such agreement, the person receiving a
medical student loan under this act shall repay amounts to the university of
Kansas school of medicine as provided in K.S.A. 76-385, and amendments
thereto.

Sec. -3: 4. K.S.A. 2016 Supp. 76-384 is hereby amended to read as follows: 76-384. (a) Upon the selection of a service commitment area for the purposes of satisfying a service obligation under a medical student loan agreement entered into under this act, the person so selecting shall inform the university of Kansas school of medicine of the service commitment area selected.

26 (b) A person serving in a service commitment area pursuant to any 27 agreement under this act may serve all or part of any commitment in the 28 service commitment area initially selected by such person. If such person 29 moves from one service commitment area to another service commitment area, such person shall notify the university of Kansas school of medicine 30 31 of such person's change of service commitment area. Service in any such 32 service commitment area shall be deemed to be continuous for the purpose of satisfying any agreement entered into under this act. 33

34 (c) A person receiving a medical student loan under this act, may 35 satisfy the obligation to engage in the full-time practice of medicine and 36 surgery in a service commitment area if the person serves as a full-time 37 faculty member of the university of Kansas school of medicine in general 38 internal medicine, general pediatrics, family medicine-or, family practice, 39 general psychiatry or child psychiatry and serves two years for each one 40 year of such obligation, or the equivalent thereof on a two-for-one basis, except that, at the time any person commences satisfying such service 41 42 obligation as a full-time faculty member pursuant to this subsection, the 43 number of persons satisfying service commitments or service obligations,

pursuant to agreements under the medical student loan act, as full-time
 faculty members pursuant to this subsection shall not exceed the number
 equal to 25% of the total number of full-time faculty members of the
 university of Kansas school of medicine in general internal medicine,
 general pediatrics, family medicine-or, family practice, *general psychiatry* or child psychiatry.

7 (d) A person may satisfy the obligation to engage in the full-time 8 practice of medicine and surgery in a service commitment area by 9 performing at least 100 hours per month of on-site primary care or mental health care at a medical facility-or community mental health center-10 operated by a local health department-or mental health department or 11 12 nonprofit organization in this state serving medically indigent persons or at a community mental health center {or at Larned state hospital, 13 Osawatomie state hospital or any facility that provides mental health 14 15 services and that is operated by a state agency?. As used in this subsection, "medically indigent" means a person: (1) Who is unable to 16 17 secure health care because of inability to pay for all or a part of the costs 18 thereof due to inadequate personal resources, being uninsured, being 19 underinsured, being ineligible for governmental health benefits; or (2) who is eligible for governmental benefits but is unable to obtain medical 20 21 services; and "primary care" means general pediatrics, general internal 22 medicine, family medicine and family practice.

23 Sec. 5. K.S.A. 2016 Supp. 76-385 is hereby amended to read as 24 follows: 76-385. (a) (1) Except as otherwise provided in paragraphs (2), 25 (3), (4) and (5)-of this subsection (a) or in K.S.A. 76-386, and amendments thereto, upon the failure of any person to satisfy the 26 27 obligation to engage in the full-time practice of medicine and surgery within a service commitment area of this state for the required period of 28 29 time under any medical student loan agreement entered into under this 30 act, such person shall repay to the university of Kansas school of medicine in accordance with subsection (b) an amount equal to the total 31 32 of: (A) The amount of money received by such person pursuant to such 33 agreement, or the amount of money determined under rules and regulations of the university of Kansas; plus (B) annual interest at a rate 34 35 of 15% from the date such money was received.

36 (2) Any person who fails to apply for and enter an approved 37 postgraduate residency training program shall be required to repay all 38 moneys received pursuant to an agreement entered into for any such 39 medical student loan, plus accumulated interest at an annual rate of 15% and shall commence such repayment in accordance with subsection 40 41 (b) within 90 days of graduation from the school of medicine or upon 42 termination or completion of a residency training program which does 43 not comply with the provisions of this act, whichever is later.

(3) If at any time a person is failing to satisfy an obligation to 1 engage in the full-time practice of medicine and surgery in Kansas for 2 the required period of time under an agreement entered into under this 3 act because such person is engaged in the full-time practice of medicine 4 and surgery in a state other than Kansas, or within Kansas in an area 5 6 that is not a service commitment area or in the practice of medicine and 7 surgery which does not otherwise comply with the agreement entered 8 into under this act, and if such person is subject to or currently making repayments under this section and if such person subsequently 9 commences the practice of medicine and surgery in this state which is in 10 a service commitment area or which otherwise complies with the 11 agreement entered into under this act, the balance of the repayment 12 amount, including interest thereon, from the time of such 13 commencement of practice until the obligation of such person is 14 satisfied, or until the time such person again becomes subject to 15 16 repayments, shall be waived. All repayment amounts due prior to such 17 commencement of practice, including interest thereon, shall continue to be payable as provided in this section. If subsequent to such 18 19 commencement of practice, the person fails to satisfy such obligation, 20 the person again shall be subject to repayments, including interest 21 thereon, as otherwise provided in this section.

22 (4) If, during the time a person is satisfying the service requirement 23 of an agreement entered into under this act, such person desires to engage in less than the full-time practice of medicine and surgery within 24 a service commitment area of the state and remain in satisfaction of 25 such service requirement, such person may make application to the 26 chancellor of the university of Kansas or the designee of the chancellor 27 28 for permission to engage in less than such full-time practice of medicine and surgery. Upon a finding of exceptional circumstances made by the 29 chancellor of the university of Kansas, or the designee of the chancellor, 30 such person may be authorized to engage in less than the full-time 31 practice of medicine and surgery within a service commitment area of 32 the state for the remaining required period of time under such 33 agreement and for an additional period of time which shall be equal to 34 the length of the originally required period of time multiplied by the 35 decimal fraction which is equal to the reduction of the full-time practice 36 37 of medicine and surgery to be authorized hereunder, multiplied by two. 38 In any such determination of the period required to be engaged in the 39 less than full-time practice of medicine and surgery, the decimal fraction utilized shall not exceed 0.5 and any person granted permission to 40 engage in less than the full-time practice of medicine and surgery in 41 accordance with the provisions of this paragraph (4) shall be required to 42 43 engage in at least the half-time practice of medicine and surgery.

(5) Any person who enters but fails to complete an approved 1 2 postgraduate residency training program, or who enters and completes an approved postgraduate residency training program but fails to satisfy 3 the obligation to engage in the full-time practice of medicine and 4 surgery within a service commitment area of this state for the required 5 6 period of time shall be required to repay all money received pursuant to 7 an agreement entered into under this act a medical student loan, plus accumulated interest at an annual rate of 15% and shall commence 8 such repayment in accordance with subsection (b) within 90 days of 9 failure to complete an approved postgraduate residency training 10 program or 90 days of failure to commence qualifying practice, 11 12 whichever occurs first.

(b) For any repayment requirement under this section, the person
shall repay an amount totaling the entire amount to be repaid under all
such agreements for which such obligations are not satisfied, including
all amounts of interest at the rate prescribed. The repayment shall be
made in not more than 10 equal annual installment payments.

18 (c) All installment payments under this section shall commence six months after the date of the action or circumstance that causes the 19 20 failure of the person to satisfy the obligations of such agreements, as 21 determined by the university of Kansas school of medicine based upon 22 the circumstances of each individual case. In all cases, if an installment 23 payment becomes 91 days overdue, the entire amount outstanding shall become immediately due and payable, including all amounts of interest 24 25 at the rate prescribed.

26 (d) The total repayment obligation imposed under all agreements 27 entered into under this act may be satisfied by the person who entered 28 into the agreements at any time prior to graduation from the university 29 of Kansas school of medicine by making a single lump-sum payment equal to the total of: (1) The entire amount to be repaid under all such 30 31 agreements upon failure to satisfy the obligations under such 32 agreements to practice in Kansas; plus (2) all amounts of interest 33 thereon at the rate prescribed to the date of payment.

(e) The university of Kansas school of medicine shall remit all
moneys received under this section to the state treasurer in accordance
with the provisions of K.S.A. 75-4215, and amendments thereto. Upon
receipt of each such remittance, the state treasurer shall deposit the
entire amount in the state treasury to the credit of the medical loan
repayment fund.

40 *(f)* There is hereby created in the state treasury the medical loan 41 repayment fund. All expenditures from the medical loan repayment fund 42 shall be for medical student loans under the medical student loan act 43 and for the expenses of administration of the medical student loan act 1 and shall be made in accordance with appropriation acts upon warrants

of the director of accounts and reports issued pursuant to vouchers 2 approved by the chancellor of the university of Kansas or by a person 3 designated by the chancellor, except that expenditures shall not be made 4 from the medical loan repayment fund for medical student loans for 5 general psychiatry or child psychiatry. On the effective date of this act, 6 7 the director of accounts and reports shall transfer all moneys in the 8 medical scholarship and loan repayment fund to the medical loan 9 repayment fund. On the effective date of this act, all liabilities of the medical scholarship and loan repayment fund are hereby imposed on the 10 medical loan repayment fund and the medical scholarship and loan 11 repayment fund is hereby abolished. Whenever the medical scholarship 12 and loan repayment fund, or words of like effect, is referred to or 13 14 designated by any statute, contract or other document, such reference or 15 designation shall be deemed to apply to the medical loan repayment 16 fund.

17 There is hereby established in the state treasury the psychiatry (g) 18 medical loan repayment fund. All moneys credited to the psychiatry 19 medical loan repayment fund shall be expended only for medical student loans for general psychiatry or child psychiatry students under the 20 21 medical student loan act and for the expenses of administration of the 22 medical student loan act associated with such students. All expenditures 23 from the psychiatry medical loan repayment fund shall be made in 24 accordance with appropriation acts upon warrants of the director of accounts and reports issued pursuant to vouchers approved by the 25 chancellor of the university of Kansas or the chancellor's designee. 26

{(h) Notwithstanding any other provision of law to the contrary, no
moneys shall be transferred from the comprehensive grant program
account of the state board of regents to the medical loan repayment fund
or the psychiatry medical loan repayment fund or expended for any
purposes related thereto.}

32 Sec.-4. 6. K.S.A. 76-387 is hereby amended to read as follows: 76-33 387. (a) There is hereby established the Kansas medical residency bridging program at the university of Kansas school of medicine which shall be 34 developed and implemented in order to provide encouragement, 35 36 opportunities and incentives for persons in primary care or mental health 37 care residency training programs in general pediatrics, general internal 38 medicine, family medicine-or, family practice, which general psychiatry 39 or child psychiatry that are operated by or affiliated with the university of Kansas school of medicine or other such primary care or mental health 40 41 care residency training program-which that is operated in Kansas and approved by the state board of healing arts and a person under subsection 42 43 (i) to locate their medical practice in rural Kansas communities upon completion of such residency training. The Kansas medical residency
 bridging program shall be administered by the institute for rural health
 care of the university of Kansas school of medicine.

4 (b) Subject to the provisions of appropriation acts, the university of 5 Kansas school of medicine may enter into residency bridging loan agreements, in accordance with the provisions of this section;: (A) With 6 7 any person who has completed the first year of a primary care or mental 8 health care residency training program in general pediatrics, general internal medicine, family medicine-or, family practice, which general 9 psychiatry or child psychiatry that is operated by or affiliated with the 10 university of Kansas school of medicine or other such primary care or 11 12 mental health care residency training program-which that is operated in Kansas and approved by the state board of healing arts; and (B) with a 13 person under subsection (i). 14

15 (c) Subject to the provisions of appropriation acts, each person entering into a residency bridging loan agreement under this section shall 16 receive a payment of \$5,000 each year of primary care or mental health 17 18 *care* residency training, or any part of a year of such training, after the date 19 that the residency bridging loan agreement is entered into by the resident 20 and the university of Kansas school of medicine and, upon completion of 21 the primary care or mental health care residency training program, a 22 payment of \$6,000.

23 (d) Each residency bridging loan agreement shall require that the24 person receiving the loan:

(1) Complete the primary care *or mental health care* residencytraining program;

(2) engage in the full-time practice of medicine and surgery in any
county in Kansas other than Douglas, Johnson, Sedgwick, Shawnee or
Wyandotte for three years under a practice commitment agreement;

30 (3) commence such full-time practice of medicine and surgery within
31 90 days after completing the primary care *or mental health care* residency
32 training program; and

33 (4) upon failure to satisfy the obligation to engage in the full-time 34 practice of medicine and surgery in accordance with the provisions of the 35 residency bridging loan agreement and this section, the person receiving 36 the loan under this section shall repay to the university of Kansas school of 37 medicine, within 90 days of such failure, the amount equal to the amount 38 of money received by such person from the university of Kansas school of 39 medicine, less credits earned, under such agreement plus interest at the 40 annual rate of 15% from the date such money was received.

41 (e) An obligation to engage in the practice of medicine and surgery in
42 accordance with the provisions of a residency bridging loan agreement and
43 this section shall be postponed during: (1) Any period of temporary

1 medical disability during which the person obligated is unable to practice 2 medicine and surgery because of such medical disability;; or (2) any other 3 period of postponement agreed to or determined in accordance with 4 criteria agreed to in the practice commitment agreement.

5 (f) An obligation to engage in the practice of medicine and surgery in 6 accordance with the provisions of a residency bridging loan agreement and 7 this section shall be satisfied: (1) If the obligation to engage in the practice 8 of medicine and surgery in accordance with such agreement has been 9 completed; (2) if the person obligated dies; or (3) if, because of 10 permanent physical disability, the person obligated is unable to practice 11 medicine and surgery.

12 (g) The university of Kansas school of medicine may adopt additional 13 provisions, requirements or conditions for participation in the Kansas medical residency bridging program as are practicable and appropriate to 14 accomplish the purposes of the program or as may be required for the 15 16 implementation or administration of the program and, in any case, as are 17 not inconsistent with the provisions of this section or the provisions of 18 appropriation acts.

19 (h) As used in this section, "practice commitment agreement" means 20 an agreement to commence the full-time practice of medicine and surgery 21 in a city located in any county in Kansas other than Douglas, Johnson, 22 Sedgwick, Shawnee or Wvandotte county, which that:

23 (1) Was entered into: (A) By a person in a primary care or mental 24 health care residency training program in general pediatrics, general 25 internal medicine, family medicine-or, family practice, general psychiatry or child psychiatry, that is operated by or affiliated with the university of 26 27 Kansas school of medicine or other such primary care or mental health 28 care residency training program-which that is operated in Kansas and 29 approved by the state board of healing arts; or (B) by a person under subsection (i) with the city where such practice is to commence or another 30 31 contracting entity other than the university of Kansas school of medicine 32 that is representative of the interests of such city.: and

33 (2) provides benefits to such person that have an aggregate monetary 34 value equal to or greater than the aggregate amount of payments to such 35 person from the university of Kansas school of medicine under a residency 36 bridging loan agreement under this section.

37 (i) A person who graduated from the university of Kansas school of 38 medicine prior to July 1, 1992, who has completed the first year of a 39 primary care residency training program in family practice which is 40 operated outside the state of Kansas and who has entered into a practice 41 commitment agreement with the north central Kansas health care 42 foundation is eligible to enter into a residency bridging loan agreement 43 under this section.

1 (j) Notwithstanding any other provision of law to the contrary, no 2 moneys appropriated for the Kansas medical residency bridging 3 program at the university of Kansas school of medicine, except moneys 4 appropriated to the rural health bridging psychiatry fund, shall be 5 expended for residency bridging loan agreements for medical residents 6 training in general psychiatry or child psychiatry.

7 (k) Subject to appropriations, the university of Kansas school of 8 medicine shall enter into residency bridging loan agreements with three 9 medical residents training in general psychiatry or child psychiatry.

There is hereby established in the state treasury the rural health 10 *(*1) bridging psychiatry fund. All moneys credited to the rural health 11 bridging psychiatry fund shall be used only for purposes related to 12 residency bridging loan agreements for medical residents training in 13 general psychiatry or child psychiatry pursuant to K.S.A. 76-387, and 14 amendments thereto. All expenditures from the rural health bridging 15 16 psychiatry fund shall be made in accordance with appropriation acts 17 upon warrants of the director of accounts and reports issued pursuant to vouchers approved by the chancellor of the university of Kansas or the 18 19 chancellor's designee.

20 {(m) Notwithstanding any other provision of law to the contrary, no 21 moneys shall be transferred from the comprehensive grant program 22 account of the state board of regents to the rural health bridging 23 psychiatry fund or expended for any purposes related to the Kansas 24 medical residency bridging program.

Sec. 7. K.S.A. 2016 Supp. 75-3373 is hereby amended to read as 25 follows: 75-3373. (a) Notwithstanding any other provision of law, the 26 Kansas department for aging and disability services, solely or in-27 consultation or cooperation with any other state agency, no state agency 28 shall-not enter into any agreement or take any action to outsource or 29 privatize any operations or facilities of the Larned state hospital-or, the 30 Osawatomie state hospital or any facility that provides mental health 31 services and that is operated by a state agency without prior specific 32 authorization by an act of the legislature or an appropriation act of the 33 legislature. The restriction imposed by this subsection applies to any 34 action to outsource or privatize all or any part of any operation or facility 35 of the Larned state hospital, the Osawatomie state hospital or any facility 36 37 that provides mental health services and that is operated by a state 38 agency, including, but not limited to, any action to transfer all or any part 39 of the rated bed capacity at the Larned state hospital or the Osawatomie state hospital, in effect on the effective date of this act, to another facility. 40 41 (b) Nothing in this section shall prevent the Kansas department for
