### SUPPLEMENTAL NOTE ON HOUSE BILL NO. 2011

## As Amended by House Committee on Elections

## **Brief\***

HB 2011, as amended, would revise existing law regarding contribution limits and the regulation thereof. The bill would increase the aggregate amount that could be contributed to a candidate and the candidate's committee by any political committee or any person except a party committee, the candidate, or the candidate's spouse, as follows:

The bill would also increase the aggregate amount that could be contributed to a party committee\* as follows:

# **Background**

The bill was introduced by Representative Esau. As introduced, the bill is identical to 2015 HB 2213, which passed out of the House Committee on Elections but did not proceed further. Testifying as a proponent before the House Committee on Elections was a representative of the Republican Party of Kansas who stated the bill is part of a nationwide movement seeking to counter the sizable growth of special interest group money in elections. No other testimony was received.

The House Committee amended the bill by removing a provision that would have allowed the receipt (but not expenditure) of contributions for a candidate's general election during the primary election.

According to the fiscal note prepared by the Division of the Budget on the original bill, enactment of the bill would have no fiscal effect on the Kansas Governmental Ethics Commission or the state budget.
