Dear Representative Steven Huebert,

Thank you for taking the time to listen to the stories of families, mothers, practitioners, and all whom are concerned for the health and well being of our children and their children and future generations.

I am writing to express my support for House Bill 2601, making the great state of Kansas a leader in our country who is not afraid to stand for medical freedom when the health of our children and communities depend on it.

I remember, as I'm sure many of you do as well, when I was a kid, we were not near as sick as our children are today. I remember when we were sick we would be fed broth, healthy food and water. I remember we played outside, we laughed in the sun, we took risks and our imaginations ran wild. I don't remember too many kids wearing glasses, having ADD or ADHD or depression or behavioral disorders or autism. I don't remember the flu coming around only six months out of the year that wiped entire communities out. I don't remember not being able to play with my friends for nearly half the year because someone was always sick. I don't remember kids taking so many pharmaceutical drugs with such harmful affects. And I certainly don't remember getting 72 vaccines throughout my childhood.

Even though, yes, I was vaccinated, I had less than a dozen vaccines in my entire life and so did my friends. Entire generations of children survived with just a small amount of vaccines. And my great grandfather, whom is almost 90 years old has never had a vaccine in his life. He is healthy for his age.

But today, we witness a different story. My heart grieves for the blind trying to lead the blind with vaccine mandates. Because we all know how much power and greed pharmaceutical companies have over our nation and world. We know of the corruption and abuse of power. Yet some states are willing to make decisions as lawmakers to sacrifice and compromise the health of future generations, for money and power...knowing full well that our children are some of the sickest in the world despite our wealth.

Why is it remotely necessary to inject our children with so many vaccines that have never been properly tested? These vaccines contain toxic ingredients that are making our kids sicker and sicker every year. I know more than 12 families who have personally been victims of vaccine injuries in my town alone. The injuries range from developing anaphylactic shock to eating peanuts and eggs (vaccine ingredients), to developing behavioral disorders, learning and speech delays, chronic diseases, seizures, and even death labeled as SIDS.

Some of these families refuse to face the connection that a vaccine could cause their child to have to carry an epi pen around with him at all times. Some refuse to believe speech delay or behavioral disorders could come from a vaccine. Others however, do make the connection. And unfortunately some of these parents have lost their babies to death. I can't imagine waking one day to find my baby not breathing. Did you know

that in nearly all cases of reported SIDS, the children had received their vaccines within 3 days prior?

I don't remember this happening when I was growing up. My parents were still trying to quit smoking, telling me stories of about how smoking was harming people, not sitting around the dinner table talking about families in community losing their children to death by some crazy unknown thing like SIDS.

I'm not an eloquent writer. I'm not an activist. I didn't like debate in school. But I have a heart. I love people and I listen to their stories. Stories are what makes our world keep going. Stories of hope and love and trying to make this world a better place. Surely each of you were impassioned to public service for this very reason. To give your children and theirs something to hope for. With all due respect, I don't believe that injecting our children with such toxic ingredients is the answer to a better future.

We need imaginative, confident kids, not kids who are on the brink of suicide because they have so many heavy metals and formaldehyde pumping through their brains.

We need a better way. We need to demand that private peer reviewed studies be done on vaccines to determine their safety. And what if they have been a big farce and not effective this entire time? What then? What if there is really no such thing as herd immunity? What if the ancient civilizations whom survived great disease with wisdom. With what is right here on planet earth before Modern medicine came in with power and money 70 years ago?

Do we stand for what is right? Or do we save face and act as the blind leading the blind?

What if we were the ones in the state of Kansas who said enough is enough. We cannot stand idly by and continue to let our children be harmed by unnecessary toxic ingredients.
