## <u>Review and Discussion of State of Disaster Emergencies (KSA 48-924), Emergency Orders and</u> <u>Proclamations (KSA 48-925), and Other Related Issues</u>

Since Governor Kelly first invoked the authority on March 12, 2020, Attorney General Derek Schmidt and his office has had the opportunity to look closely at provisions of the Kansas Emergency Management Act. A.G. Schmidt covered nine points that he feels deserves the committee's attention. He explained each point in detail. He later offered a written document with an outline of the nine points. (Attachment 3)

Will Lawrence discussed three points which he had been asked to address. (Attachment 4)

- What is the current status of the Governor's emergency declaration?
- Under current law, what happens moving forward with the current declaration and what happens once the current declaration expires? How does this impact federal funding and emergency orders?
- Any recommended changes to current law and/or concerns with making changes? (Short-term only. A more comprehensive review would need to be done in a future legislative session).

Representative Garber asked if he could have a definition of "at risk". Mr. Lawrence indicated he would email the current definition from KHDE to the membership.

Representative Humphries asked if he could address additional leniency that local officials could have in their specific counties due to minimal COVID-19 cases being identified. Mr. Lawrence indicated that he would check into that and get back with the committee.

Chairperson Patton suggested the membership listen to the Senate Judiciary Committee that would be meeting tomorrow.
