SUBJECT: Corrected Fiscal Note for HB 2045 by House Committee on Corrections and Juvenile Justice

In accordance with KSA 75-3715a, the following corrected fiscal note concerning HB 2045 is respectfully submitted to your committee.

HB 2045 would expand the 2003 SB 123 Substance Abuse Treatment Program by allowing the court ordered placement of offenders who have been convicted of a felony violation of drug severity level 4 crimes of unlawful cultivation or distribution of controlled substances in certified drug abuse treatment programs. The bill would take effect and be in force from and after its publication in the *Kansas Register*.

The Kansas Sentencing Commission estimates HB 2045 would increase annual expenditures for substance abuse treatment from the State General Fund by a minimum of \$1.1 million for 284 offenders beginning in FY 2020. The estimate assumes 30.0 percent (or 23 prison beds) of drug severity level 4 offenders sentenced to prison and 70.0 percent sentenced to probation would be sentenced to drug treatment. However, the Commission estimates the bill could increase annual expenditures for substance abuse treatment from the State General Fund by up to \$1.4 million for 365 offenders beginning in FY 2020 assuming 80.0 percent (or 62 prison beds) of drug severity level 4 offenders sentenced to prison and 90.0 percent sentenced to probation were sentenced to drug treatment.

The Department of Corrections estimates a reduction of 23 prison beds would produce savings of approximately \$41,676 and a reduction of 62 prison beds would produce savings of approximately \$112,344 in FY 2020. By FY 2029, a 30.0 percent reduction in prison beds would produce savings of \$65,232 and an 80.0 percent reduction in prison beds would produce savings of \$179,388.

The Office of Judicial Administration indicates HB 2045 would increase Judicial Branch expenditures from additional court time needed to determine and set forth with particularity the reasons for finding that public safety would not be jeopardized by placing the offender in a drug abuse treatment program, but a precise fiscal effect cannot be estimated. It was originally reported that funding for HB 2045 is not included in the Governor's budget recommendation. However, the Kansas Sentencing Commission has since clarified that this bill does not further expand the 2003 SB 123 Substance Abuse Treatment Program. HB 2045 merely makes technical corrections to legislation that was enacted during the 2018 Legislative Session. The fiscal effect associated with HB 2045 is currently reflected in *The FY 2020 Governor's Budget Report*.
