1 AN ACT concerning the hospital provider assessment; relating to
2 assessment and use; rate; base; membership on the healthcare access
3 improvement panel; amending K.S.A. 65-6208 and 65-6218 and
4 repealing the existing sections.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. K.S.A. 65-6208 is hereby amended to read as follows: 65-
8 6208. (a) Subject to the provisions of K.S.A. 65-6209, and amendments
9 thereto, an annual assessment on ~~inpatient~~ services is imposed on each
10 hospital provider in an amount equal to ~~1.83~~ 3% of each hospital's net
11 inpatient *and outpatient* operating revenue for the hospital's fiscal year
12 ~~2010~~ *three years prior to the assessment year*. In the event that a hospital
13 does not have a complete twelve-month ~~2010~~ fiscal year *in such third*
14 *prior fiscal year*, the assessment under this section shall be \$200,000 until
15 such date that such hospital has completed the hospital's first twelve-
16 month fiscal year. Upon completing such first twelve-month fiscal year,
17 such hospital's assessment under this section shall be the amount equal to
18 ~~1.83~~ 3% of such hospital's net operating revenue for such first completed
19 twelve-month fiscal year.

20 (b) Nothing in this act shall be construed to authorize any home rule
21 unit or other unit of local government to license for revenue or impose a
22 tax or assessment upon hospital providers or a tax or assessment measured
23 by the income or earnings of a hospital provider.

14 Sec. 2. K.S.A. 65-6218 is hereby amended to read as follows: 65-
15 6218. (a) (1) Assessment revenues generated from the hospital provider
16 assessments shall be disbursed as follows:

17 ~~(A)~~ (A) Not less than 80% of assessment revenues shall be disbursed to
18 hospital providers through a combination of medicaid access improvement
19 payments and increased medicaid rates on designated diagnostic related
20 groupings, procedures or codes;

21 ~~(B)~~ (B) not more than 20% of assessment revenues shall be disbursed
22 to providers who are persons licensed to practice medicine and surgery or
23 dentistry through increased medicaid rates on designated procedures and
24 codes; and

25 ~~(C)~~ (C) not more than 3.2% of hospital provider assessment revenues
26 shall be used to fund healthcare access improvement programs in
27 undergraduate, graduate or continuing medical education, including the
28 medical student loan act.

29 ~~(2) Any increased medicaid rates implemented in accordance with~~
30 ~~this subsection after the effective date of the amendments made to this~~
31 ~~subsection by this act shall not be subsequently reduced. If, during any~~
32 ~~subsequent fiscal year, revenues from the hospital provider assessment are~~
33 ~~insufficient to fund such increased rates, the department of health and~~
34 ~~environment shall fund such increased rates using moneys appropriated to~~
35 ~~the department of health and environment from the state general fund or in~~
36 ~~any appropriate special revenue fund or funds during such fiscal year.~~

37 ~~(b) Assessment revenues generated from the health maintenance~~
38 ~~organization assessment shall be disbursed as follows:~~

39 ~~(1) Not less than 53% of health maintenance organization assessment~~
40 ~~revenues shall be disbursed to health maintenance organizations that have~~
41 ~~a contract with the department through increased medicaid capitation~~
42 ~~payments;~~

43 ~~(2) not more than 30% of health maintenance organization~~

1 assessment revenues shall be disbursed to fund activities to increase access
2 to dental care, primary care safety net clinics, increased medicaid rates on
3 designated procedures and codes for providers who are persons licensed to
4 practice dentistry, and home and community-based services;

5 ~~(3) not more than 17% of health maintenance organization~~
6 ~~assessment revenues shall be disbursed to pharmacy providers through~~
7 ~~increased medicaid rates.~~

8 ***(2) On July 1 of each year, the department of health and***
9 ***environment, with approval of the healthcare access improvement panel,***
10 ***shall make adjustments to the disbursement of moneys in accordance***
11 ***with this subsection to cause such disbursements to be paid solely from***
12 ***moneys appropriated from the healthcare access improvement fund. The***
13 ***healthcare access improvement fund shall not be supplemented by***
14 ***appropriations from the state general fund for the purpose of making***
15 ***disbursements under this subsection.***

16 ***(e)(b)*** For the purposes of administering and selecting the
17 disbursements described in subsections (a) and (b) ~~of this section~~, the
18 healthcare access improvement panel is hereby established. The panel shall
19 consist of the following: Three members appointed by the Kansas hospital
20 association, two members who are persons licensed to practice medicine
21 and surgery appointed by the Kansas medical society, one member
22 appointed by each health maintenance organization that has a medicaid
23 managed care contract with the Kansas department for aging and disability
24 services of health and environment, one member appointed by the
25 community care network of Kansas ~~association for the medically~~
26 ~~underserved~~, ***one member appointed by the president of the senate, one***
27 ***member appointed by the speaker of the house of representatives, one***
28 ***member from the office of the medicaid inspector general appointed by***
29 ***the attorney general*** and one representative of the department of health
30 and environment appointed by the governor. The panel shall meet as soon
31 as possible subsequent to the effective date of this act and shall elect a
32 chairperson from among the members appointed by the Kansas hospital
33 association. A representative of the panel shall be required to make an
34 annual report to the legislature regarding the collection and distribution of
35 all funds received and distributed under this act, ***and such report shall***
36 ***include analysis demonstrating that disbursements made in accordance***
37 ***with subsection (a) are budget neutral to the state general fund.***

38 ~~*(d) The healthcare access improvement panel shall submit a report to*~~
39 ~~*the house of representatives standing committee on appropriations and the*~~
40 ~~*senate standing committee on ways and means on or before January 10,*~~
41 ~~*2022, and on or before the first day of each third regular session of the*~~
42 ~~*legislature thereafter, that includes the expenditures needed to maintain*~~
