

**SENATE BILL No. 456**

1 AN ACT concerning the sale of alcoholic liquor in retail liquor stores;  
2 relating to the start time for Sunday sales; amending K.S.A. 2019 Supp.  
3 41-712 and repealing the existing section.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2019 Supp. 41-712 is hereby amended to read as  
7 follows: 41-712. (a) Within any city where the days of sale at retail of  
8 alcoholic liquor in the original package have not been expanded as  
9 provided by K.S.A. 2019 Supp. 41-2911, and amendments thereto, or have  
10 been so expanded and subsequently restricted as provided by K.S.A. 2019  
11 Supp. 41-2911, and amendments thereto, and within any township where  
12 the days of sale at retail of alcoholic liquor in the original package have  
13 not been expanded as provided by K.S.A. 2019 Supp 41-2911, and  
14 amendments thereto, or have been so expanded and subsequently restricted  
15 as provided by K.S.A. 2019 Supp. 41-2911, and amendments thereto, no  
16 person shall sell at retail any alcoholic liquor in the original package: (1)  
17 On Sunday; (2) on Memorial Day, Independence Day, Labor Day,  
18 Thanksgiving Day or Christmas Day; or (3) before 9 a.m. or after 11 p.m.  
19 on any day when the sale is permitted. The governing body of any city by  
20 ordinance may require the closing of premises prior to 11 p.m., but such  
21 ordinance shall not require closing prior to 8 p.m.

22 (b) Within any city where the days of sale at retail of alcoholic liquor  
23 in the original package have been expanded as provided by K.S.A. 2019  
24 Supp. 41-2911, and amendments thereto, and have not been subsequently  
25 restricted as provided by K.S.A. 2019 Supp. 41-2911, and amendments  
26 thereto, and within any township where the days of sale at retail of  
27 alcoholic liquor in the original package have been expanded as provided  
28 by K.S.A. 2019 Supp. 41-2911, and amendments thereto, and have not  
29 been subsequently restricted as provided by K.S.A. 2019 Supp. 41-2911,  
30 and amendments thereto, no person shall sell at retail alcoholic liquor in  
31 the original package: (1) On Sunday before ~~12 noon~~ 9 a.m. or after 8 p.m.;  
32 (2) on Easter Sunday, Thanksgiving Day or Christmas Day; or (3) before 9  
33 a.m. or after 11 p.m. on any day when the sale is permitted. The governing  
34 body of any city by ordinance may require the closing of premises prior to  
35 11 p.m., but such ordinance shall not require closing prior to 8 p.m.

36 Sec. 2. K.S.A. 2019 Supp. 41-712 is hereby repealed.
