Chairman Patton and members of the committee,

Today, we write to you to urge strong opposition to the Kansas Chamber's attempt to absolve negligent businesses' liability. This is an agenda that does not protect the more than 500,000 Kansas workers.

This bill uses the COVID-19 pandemic to shove through a law to strip away a citizen's right to seek remedies from a negligent business in taking appropriate precautions to protect employees and customers. Instead, this effort would give companies immunity and reward them for not protecting the people they owe their success to – their employees and customers. This is in addition to the fact that today Kansas workers have no protection when it comes to workers' compensation.

SB 283 extends cover from liability to businesses against COVID-19 claims. Anything dealing with workers' or individuals' protections from COVID-19 is set to expire **on April 1, 2021**. This bill instead places businesses ahead of individuals by extending protections for them. Instead of providing workers' compensation protections, extending unemployment benefits, or anything else centered around individuals, the Legislature is extending benefits for business and providing nothing for everyone else.

This is not a game. This is a life-and-death situation. Instead, the dangerous Chamber agenda is all about saving a buck on the corporate balance sheet. We demand Kansas government put its citizens' safety first and ignore this attempt to use a horrible pandemic to extend liability protection for businesses. At the same time, it does nothing to protect its citizens.

Without amendments to this bill that would support Kansas workers' protections, we must stand in strong opposition to this underlying bill. We ask the committee to consider amending this bill to provide additional protections to Kansas workers.
