

TESTIMONY OF MIKE FONKERT
JUST CAMPAIGN DIRECTOR
KANSAS APPLESEED CENTER FOR LAW AND JUSTICE

Members of the House Committee on Transportation:

My name is Mike Fonkert; I am the Just Campaign Manager for the Kansas Appleseed Center for Law and Justice, a nonprofit, nonpartisan organization dedicated to the belief that Kansans, working together, can build a state full of thriving, inclusive, and just communities.

Kansas Appleseed is neutral on HB 2193.

This bill aims to address the vicious cycle that traps so many Kansas driver's in a no-win situation. More than 213,000 Kansans have suspended driver's licenses.¹ In 2020, Kansas had the sixth highest suspension rate in the country.² Research indicates that nearly 75 percent of suspended drivers continue to drive, because they have no choice if they want to provide for their families.³ Driving a car is often necessary for important life tasks: like maintaining employment, buying groceries, or taking kids to doctor's appointments and school activities.⁴

This bill does not solve our state's driver's license suspension problem. While it does propose important steps by reducing the additional 90-day suspension extension for charges of driving on a revoked or suspended license to 30 days, removing the onerous application fees for applying for restricted driving privileges, and changing the additional reinstatement fee from \$100 per charge to \$100 per case while making the reinstatement fee only applicable to those eligible for reinstatement -- we know that much more must be done. For this bill to make a significant impact on this issue, it will need to be amended to include additional changes.

Fortunately, leaders from the Senate and House - along with law enforcement, judges, advocates, attorneys -- in cooperation with groups like the Justice Action Network, Americans for Prosperity, various Chambers of Commerce and more -- have been working together to find agreement on how to

safely make further changes. Together, a great deal of common ground has been identified as it relates to ensuring that individuals facing suspension have full access to payment plans that would allow them to avoid a suspension as long as they remain in good standing with their payment plan. This would be a big step forward towards making sure that being too poor to pay a large fine or fee all at once does lead to a driver's license suspension.

Please support strengthening this bill through adopting relevant amendments that limit the unnecessary burden of fines and fees. There is no empirical evidence which indicates that suspending a person's driving privilege for social non-conformance reasons is effective in gaining compliance.⁵ During the current pandemic, it is more important than ever that we help people out from onerous governmental burdens that impede their ability to access employment.
