STATEMENT OF BRAD SMOOT House Transportation Committee Regarding 2021 SB 26 March 10, 2021 Oral Proponent

Chairman Proehl and Committee members:

I appear today to urge your support for the passage of 2021 Senate Bill 26, naming a section of Kansas Highway 7 the "Senator Bud Burke Memorial Highway." This legislation was presented last year and passed the Senate with 39 votes. See 2020 SB 377. It was set for hearing in this committee the day the Legislature closed for COVID reasons. It again passed the Senate this year with 39 votes.

Former Kansas Senate President Burke gave much of his life in service to our state and nation. Those of us who had the fortune to work with him in this Capitol are all the better for having known him. For those who didn't have the opportunity to know and work with Senator Burke, a brief legislative bio may be useful. Bud was elected to the Kansas House in 1972 and then appointed to the Senate in '75; then elected in '76 and re-elected for the next 20 years. While in the Senate he served as Chair of Assessment & Taxation Committee, Majority Leader for 4 years and 8 years as Senate President before retirement. During those years he would be involved with two major highway bills, constitutional amendments on liquor by the drink, state lottery and parimutuel racing, property classification and reappraisal and the overhaul of higher ed finance and welfare reform. Just to name a few. Bud's service wasn't limited to Kansas. He was a U.S. Air Force fighter pilot and later a carrier-trained Naval aviator, Captain in the Naval Reserves and Commander of NATO fighter squadron.

Senator Burke was a man of honor, courage and dedication. We hope his leadership skills, demeanor and joyful zest for life will be emulated under this same Capitol dome. It is suitable that from time to time you can recognize the talents, efforts and years of public service for one of your own. No one knows better than you that being an elected official occasionally can be a thankless job. SB 26 gives you a chance to recognize a man who gave decades of his life in the service of Kansans from the very same corridors where you now serve.
