Re: Prison Bed Impact Assessment, HB 2001 - Creating the crime of sexual extortion and

requiring an offender to register under the Kansas offender registration act.

## **IMPACT ASSESSMENT**

### **SUMMARY OF THE BILL**

**New Section 1** creates a new crime of sexual extortion. It is defined as:

- (a) sexual extortion is communication by any means a threat to injure the property or reputation of a person, or threat to distribute an image or video of a person that is a sexual nature or depicts such person in a state of nudity:
  - (1) with the intent to coerce such person to:
    - (A) Engage in sexual contact, sexual intercourse or conduct that is of a sexual nature; or
    - (B) produce, provide or distribute an image, video or other recording of a person in a state of nudity or engaging in conduct that is of sexual nature; or
  - (2) that causes such person to:
    - (A) Engage in sexual contact, sexual intercourse or conduct that is of a sexual nature; or
    - (B) produce, provide or distribute an image, video or other recording of a person in a state of nudity or engaging in conduct that is of sexual nature.

The criminal penalties for sexual extortion is:

- (1) A severity level 7, person felony, if the violation of subsection (a)(1); and
- (2) A severity level 4, nonperson felony, if the violation of subsection (a)(2).

**Section 2** amends the Kansas Offender Registration Act to add the conviction of sexual extortion to the sex offender registration requirement under K.S.A. 22-4902.

#### **FINDINGS**

- No data exists for the crime of sexual extortion.
- In FY 2019, there was one conviction for blackmail, under K.S.A. 21-5428
  - o The one conviction was a severity level 7, nonperson felony, who received probation.
- In FY 2019, **354** offenders were **required** to register by the court due to sex offender status.
- In FY 2019, **87** offenders were admitted to KDOC due to violation of sex offender registration.
  - $\circ$  5 severity level 3
  - $\circ$  **16** severity level 5
  - **51** severity level 6
  - $\circ$  6 severity level 7
  - **8** severity level 8
  - $\circ$  1 severity level 9
