Dear County Commissioners,

To date 45 boards of county commissioners have passed resolutions opposing the 49 County Kansas Nebraska National Heritage Area (NHA) (23 of 26 in Kansas and 22 of 23 in Nebraska). Nebraska Governor Pete Ricketts issued a letter of opposition as well. It was heartening to see such a remarkable response affirming local sovereignty and private property rights. By the end of April 2021, four Kansas Nebraska Heritage Area Partnership (KNHAP) board members resigned while one retired and a National Park Service employee retired in September.

In spite of overwhelming opposition, Prof. Kim Wilson, Executive Director of KNHAP, continues to pursue this NHA, directly through Congress if necessary. This attitude reflects disrespect toward the residents and local jurisdictions who oppose this designation.

Freedom of Information Act (FOIA) documents received by Angel Cushing of Allen, Lyon County, Kansas were disseminated to 49 County Clerks in July 2021. From this FOIA, KNHAP was going to assign students to perform KNHAP work in a Fall 2021 class by Prof. Kristin Malek. Is a nonprofit allowed to use student assignments to perform its work? KNHAP was going to claim student assignments or student directed work as in-kind contributions to KNHAP nonprofit status. Was KNHAP operating as such under the 501c3 umbrella of the Willa Cather Foundation or another organization? Did Prof. Kim Wilson direct her students in the School of Landscape Architecture to undertake a study to implement a personal agenda of a NHA designation to be achieved by 2026? Has KNHAP provided inaccurate or misleading information to the National Park Service in connection with the NHA feasibility study?

These issues were directed to the University of Nebraska, Lincoln, Board of Regents, Internal Audit and Advisory Services, Chancellor Green, Dean of Architecture, and Dean of Engineering through a September 2, 2021 mailing of FOIA documents and copies of the resolutions. County Attorneys may want to inquire into UNL's response to these issues.

For myself, I had a wonderful experience during public meetings getting acquainted with the hardworking folks of the Kansas Nebraska Heartland.

#### Dear Commissioners,

Thank you for your service to the landowners in your communities. The Kansas Nebraska Heritage Area Partnership drew a federal boundary around 49 counties in the state of Nebraska and Kansas and began lobbying federal legislators for a National Heritage Area. They hoped that the federal government would be granted jurisdiction before any resident in the counties had an opportunity to question the need for this federal designation. Because of actions taken by 45 of the 49 counties, that NHA pursuit was interrupted and the Kansas Legislature took notice. The 45 resolutions passed by County Commissioners resulted in the call for a Special Committee Hearing at the Kansas State Capitol.

Unfortunately, the date of the Special Committee Hearing has not yet been set. Part of the reason is the many pressing issues that our state is facing. Those issues are keeping our legislators busy. Another reason is the extreme amount of lobbying being done by the organizations that profit off of converting private property into public lands. Those lobbying organizations have successfully convinced many of our state and federal legislators to delay our cries and ignore our concerns. Those lobbying efforts have encouraged the Kansas Nebraska Heritage Area Partnership to continue their pursuit of a National Heritage Area.

Once again, I must call upon residents and their county governments to take action. Some of the additional steps that you can take are: to pass a resolution against  $30 \times 30$  if you have not done so already. Your county can order the Kansas and Nebraska Heritage Area Partnership to cease and desist their pursuit of a National Heritage Area in your county. You may offer testimony, written or oral, to the Kansas legislature, even if you are in Nebraska. If you are in Nebraska, you may compel your state legislature to pursue laws that I am asking Kansas to adopt. Such as;

- Requiring a state legislative vote on any National Heritage Area or federal land expansion and/or creation. And to deny state funding to any acquisition or program that is instituted without that approving vote.
- Restrict the use of eminent domain for recreational purposes.

- Create laws similar to Nebraska's that allows County Commissioners to have a say in whether or not a perpetual conservation easement should be added to that county.
- Restrict Form-Based Zoning to development projects, discouraging administrative participation in regulatory takings.

There are likely additional laws or Amendments that our states should consider. If you have ideas, please share it with your state legislators and those appointed to the Special Committee. The Legislative Committee Assistant is Mr. Gary Deeter: <u>Gary.Deeter@House.ks.gov</u> The Committee Chair is Representative Ken Rajhes: <u>ken.rahjes@house.ks.gov</u>

As with state legislation, there may be other actions that your county can take that I have not considered. I ask that you explore those options.

In preparing communication for my state legislators on the Kansas Special Committee, I pulled up three different maps of the United States. One was a map showing all of the federal and state lands in preservation and conservation. Another was a map of lands in Conservation Easements. And a third map was of lands enrolled in CRP. While each map is shocking, it does not compare to laying all three maps on top of each other. Only then, did I fully grasp the threats facing property rights and food production. It is important that we stop the growth of federal jurisdiction on our properties.

Dear Board of County Commissioners,

Since writing to you early this year, I have had the privilege of working with Dr. Kincaide as we have traveled the 49 counties targeted by the Kansas Nebraska Heritage Area Partnership (KNHAP) to establish a National Heritage Area. An NHA would ultimately have a negative impact upon our private property rights and our freedom to enjoy our property. I have personally had the pleasure of visiting with a number of you in person during that time as well.

Thankfully, the majority of Boards saw through the empty promises that an NHA would make 49 targeted counties "tourism meccas" with tens of thousands of people paying to view the scenic landscape and to stay in hundreds of new hotels. And – they promised the money was just going to roll in. Nobody offers money without strings and compromise. All were cleverly crafted messages to disguise the "sleight of hand" maneuvers which would give others control over your private property.

Professor Kim Wilson, the National Park Service and other involved bureaucrats have not given up. It is critical that each of you remain vigilant. These individuals believe only Government can truly protect the environment and responsibly control property...and they will continue to work toward that end.

When Angel Cushing received the documents requested through her FOIA, I personally found it interesting that the University of Nebraska was planning to use students as "free labor" in completing much of the work and compiling the documents and surveys required to pursue approval of the NHA by the National Park Service and Congress. These same students pay tuition for an education, but instead they are paying to "work" for the University and professors working to secure grants from bureaucracies. Something smells rotten here. So, there is more information needed.

In the meantime, thank you for working to protect our freedoms by passing resolutions opposing the NHA designation and the 30x30 land grab by the current administration. As inscribed over the main entrance of the Nebraska Capitol, "*The salvation of the state is watchfulness in the citizen*." Thank you for remaining watchful!

It causes great concern that Professor Kim Wilson, Executive Director of Kansas Nebraska Heritage Area Partnership (KNHAP) and the remaining board members continue to pursue an agenda to push a 49-county National Heritage Area (NHA) upon the people of South Central Nebraska and North Central Kansas when 45 of those counties (22 of 23 in Nebraska and 23 of 26 in Kansas) have passed opposition resolutions, stating the People do not want this designation!

Freedom of Information Act (FOIA) documents show that Professor Wilson used her position at the University of Nebraska to have work performed by students as in-kind contributions for the 501c3 nonprofit. My greatest concern about the National Heritage Areas (NHA) is the National Environmental Protection Act manual for the National Heritage Areas. On Forward page ii the manual states that "they" are **pleased** to release this policy guide formulated specifically for the NHA's by National Park Service (NPS) environmental coordinators and NHA program coordinators. Not one agricultural representative is mentioned even though when created, the NHA program applies to every inch of the boundary they have drawn. Once this draft planning framework is drawn it is submitted to the NPS who then determines which NEPA pathway to follow for the specific NHA that is being created.

On page 1, paragraph 1.2 the manual states: "Since NHA management plans are approved by the Sec. of the Interior, the approval is considered a Federal action and, therefore, federal environmental laws including NEPA and other laws, such as Section 106 of the National Historic Preservation Act (NHPA) and Section 7 of the Endangered Species Act (ESA), **must** be followed. "The new Waters of The U.S. Act (WOTUS) may be pulled in as well.

The EPA already runs roughshod over the farmers and ranchers without a federal boundary created around them. They have EPA rules and regulations governing the way they take care of livestock, farming methods, chemical applications and just about everything else they do on their private property. I thought that was what the U.S. Department of Agriculture's Department of Natural Resources and Conservation Services was supposed to do. Creating an NHA on top of the farmers just doubles up on the same type of regulations already governed in farm programs.

The administrators for the NHA's do not include any agricultural involvement in creating the boundaries, rather they try to hide what they are doing. The requirements for submitting the application to the Sec. of Interior for creation of an NHA are supposed to include local grassroots involvement however, as we had meetings throughout these 3 states only a handful of people even knew they were included in an NHA.

Governor Pete Ricketts has been our champion in the state of Nebraska on fighting the creation of the Kansas Nebraska NHA because of the NEPA regulations that come with that designation. I have included a copy of his letter stating that fact.

County Commissioners should be able to vote whether to become part of an NHA, as the state legislature should. If we do nothing, I fear the federal government may at one point decide to declare the whole state of Kansas an NHA as has been done to the state of Tennessee. If you combine the Freedom's Frontier NHA with the proposed Kansas Nebraska NHA, over half of the state of Kansas will be an NHA.

We are asking for County Commissioners to pass a resolution to state that you do not accept inclusion in a National Heritage Area to protect land owners private property rights. We have 45 out of 49 Counties in the Kansas Nebraska NHA who have passed a resolution to opt out to protect the farmers and ranchers in their counties.

Dear Ms. Olson:

We write to follow up on the recent briefings provided to the Governor's Office and state agencies, and to express opposition to the Willa Cather Foundation's plans to seek a National Heritage Area designation for portions of South Central and Southwestern Nebraska.

While we appreciate the important contributions of Willa Cather and her writings to that area and the State of Nebraska as a whole, this designation poses the risk of federal overreach in our communities. The designation of a National Heritage Area in our state requires federal approvals from the National Park Service and the U.S. Congress. Federal designations come with unquantifiable and unknowable risks for the future. Conditions and requirements for federal management can change at any time without vital input from the states, eroding state and local control of decision-making regarding our land and communities. A federal agency and new administration can unilaterally issue new regulations or orders governing areas with a federal designation.

Furthermore, a designation such as this would require a National Environment Policy Act (NEPA) plan. NEPA is one of the most significant bureaucratic barriers to infrastructure and other important projects in our country. Extending NEPA's reach in our state could hinder growth and development in the communities and surrounding areas.

It is also worth noting that over the past few months the State has been contacted by Nebraskans voicing their opposition to this designation. Those constituents feel as though our state can adequately promote our own regional tourism without any federal intervention, a sentiment that we share.

We appreciate the efforts of the Willa Cather Foundation to further Nebraska tourism and local development but strongly oppose this designation given the unintended consequences that are associated with it. We will continue to look for ways to promote Nebraska heritage and tourism while also keeping authority and control where it belongs - at the state and local level with Nebraskans.

### **Operation Blindside**

Operation Blindside was developed in January 2021 by Kathy Wilmot, Beaver City, NE and Norman Kincaide, Rocky Ford, CO, initiated February 26, 2021, by mailing National Heritage Area (NHA) Information Packets and copies of *SCAMMED? Canyons & Plains National Heritage Area Initiative for Southeastern Colorado* to Boards of County Commissioners in the Kansas Nebraska NHA targeted region. The purpose was to expose Kansas Nebraska Heritage Area Partnership (KNHAP) to public scrutiny and notify the counties of this NHA initiative.

Indicia of Success: Forced KNHAP to explain their activities to County Commissioners. Altered KNHAP behavior from lock step procedure towards a feasibility study into damage control on their Facebook page and exposure of the NHA scheme in print and other media.

## **Operation Broadside**

Operation Broadside was developed in March 2021 by Kathy Wilmot, Angel Cushing, Allen, Lyon County, KS, Beth O'Dell Salmans, Mary Powell, ShurrieDenah Jensen, Lisa Arnoldy, Trent Loos, and many others. The first presentation was in Mankato, Jewell County, Kansas, March 27, 2021, followed by presentations in nine meetings from April 7-15, 2021. Trent Loos emceed two of these, namely, in Red Cloud and Hebron, Nebraska.

Acknowledgement of venues: Red Cloud Community Center, Red Cloud, NE; Stastny Community Center, Hebron, NE; Frontier Stage, Hill City, KS; Midtown Ramada Inn, for the Eagle Forum, Grand Island, NE; Vesper Community Center, Lincoln, KS; The Hitching Post, Abilene, KS; St. Peters & Paul Catholic Church, Clay Center, KS; Fair Grounds Commercial Building, WaKeeney, KS; Bullseye Event Center, Norton, KS.

Indicia of Success: All venues were well attended as a result of excellent advertising through print flyers, newspaper ads and social media postings more than 2500 people attending, with more than 500 at the meeting in WaKeeney, Trego County, Kansas on April 14, 2021. Radio, television and live streaming on social media reached far more. As a result of the growing opposition to this designation, KNHAP to suspended operations on their

Facebook page as of April 24, 2021, stating they had a prescheduled break for the summer and would return in the fall. As of October 20, 2021, there have been only two posts.

Executive director of KNHAP, Kim Wilson, stated their board members were worn out and KNHAP lacked capacity to address growing opposition head-on. As a result of this growing opposition to the Kansas Nebraska NHA, four KNHAP board members resigned and one retired by April 26, 2021.

Boards of County Commissioners and private organizations were encouraged to pass resolutions opposing the NHA initiative. Governor Pete Ricketts declared his opposition to this designation in a published letter.

### **Operation Echo**

Operation Echo was developed toward the end of April 2021, implemented on May 12, 2021 and concluded on May 19, 2021, six public meetings with more than 500 attending. Acknowledgements for this include Larry LeDuc of Cloud County, Debra & Richard Hubert, of Cloud County, KS, Clark Nelson for the Holdrege venue. Venues: Cloud County Fairgrounds 4H Commercial Building, Concordia, KS; Marshal County Fairgrounds 4H Commercial Building, KS; Senior Center, Talmage, Dickinson County, KS; Tumbleweed, Salina, KS; Saint Aloysuis Parish Hall, Osborne, KS; AG Building Fairgrounds, Holdrege, NE.

### **Operation American Patrol**

Operation American Patrol was undertaken by Kathy Wilmot of Beaver City, NE, Angel Cushing of Allen, KS, and Beth O'Dell Salmans of Marysville, KS, initiated in June 2021 to follow up with Boards of County Commissioners that had yet to pass resolutions opposing the 49 County Kansas Nebraska NHA and continued well into September 2021.

### **Operation Notify**

Operation Notify was developed in July 2021 and initiated on July 23, 2021. Angel Cushing of Allen, Lyon County, Kansas sent a Freedom of Information Act (FOIA) request to the National Park Service Midwest Region in April 2021 with a document cut-off date of April 28, 2021. Angel Cushing received the FOIA document dump, totaling more than 400 pages in Pdf. form on July 14, 2021. This Pdf was delivered via email on July 23, 2021 to all County Clerks of the 49 Kansas Nebraska Counties targeted for the NHA, to be disseminated to the respective Boards of County Commissioners.

### **Operation Thresher**

Through Operation Thresher, Freedom of Information Act documents were posted to the Western Region Property Rights Coalition Facebook page between July 27 and August 2, 2021, for perusal by the general public.

### **Operation Upper Echelon**

Operation Upper Echelon was initiated on Thursday, September 2, 2021, when five NHA Information Packets were sent to five different addresses on the University of Nebraska, Lincoln (UNL) campus: Board of Regents; Chancellor Green; Dean of Architecture; Dean of Engineering; and Internal Audit and Advisory Services to notify UNL of possible irregularities in the use of University time, resources and student assignments for the benefit of a nonprofit. These packets were delivered via USPS on or before September 8, 2021.

### **Operation Bookend**

Operation Bookend was initiated on November 29, 2021, when National Heritage Area Information Packets were mailed to 49 Boards of County Commissioners in the Kansas Nebraska National Heritage Area targeted region. The information in these packets is the same captured in this PDF.

### **Summary**

In the Spring of 2017 four people, Ashley Olson, Executive Director, The Willa Cather Foundation, Joe Black, Executive Director, Stuhr Museum of the Prairie Pioneer, Kim Wilson, Professor, UNL, Landscape Architecture Program, and Mark Engler, Superintendent, Homestead National Monument, formed a steering committee to pursue NHA designation covering 49 counties where they don't live, work, own property, pay taxes, or represent any significant constituency. This steering committee was going to use all property in the targeted region for the benefit of a nonprofit in partnership with National Park Service.

KNHAP couldn't handle the adversity of opposition. If they couldn't handle this, how was this partnership to manage a 49 county, 2 state NHA with attendant management plan developed and approved by the NPS and the Department of Interior? Furthermore, the funding is so little when spread over 49 counties, who was to receive immediate tangible benefit from this designation?

KNHAP insists on pursuing this designation, in the face of 45 resolutions opposing. Kansas Nebraska Heritage Area Partnership covet the use of something that doesn't belong to them, 49 sovereign counties in the Heartland of the United States.

Angel Cushing of Allen, Lyon County, Kansas sent a Freedom of Information Act (FOIA) request to the National Park Service Midwest Region in April 2021 with a document cutoff date of April 28, 2021 (no documents after that date would be captured in the FOIA). Angel Cushing received the FOIA document dump in Pdf. form on July 14, 2021, containing more than 400 pages relating to the activities of the Kansas Nebraska Heritage Area Partnership (KNHAP) in relation to the National Park Service.

On July 23, 2021 this Pdf. was distributed via email to 49 county clerks within the targeted Kansas Nebraska National Heritage Area region to be further distributed to the respective boards of county commissioners. In the public interest, these documents were posted on the Western Region Property Rights Coalition Facebook page between July 23 - August 2, 2021.

One of the most telling statement made in Kansas Nebraska Heritage Area Meeting Minutes was on February 25, 2021: "Not worth our while to have public meetings until FS [Feasibility Study] is in motion because they will have to be part of that process."

Is this how the Partnership board perceives the residents in the 49 counties? These residents and jurisdictions are not worth KNHAP's while until they are ready to use them for their own purposes, like a roll of paper towels, toilet paper or paper cups, to be used when desired, then tossed away. But the last to know about the 49 county Kansas Nebraska National Heritage Area initiative that covets the use of their counties for the benefit of an unelected nonprofit organization.

Professor Wilson and a small group of individuals have been pursuing this designation for more than 5 years and have yet to come up with a theme for the 49 County Kansas Nebraska region. How long does it take to become a 501c3? This is what they have produced from all this administrative work: meeting schedules, agendas, minutes, a logo and a map. Four board members resigned and one retired in April 2021 as a result of public opposition. One National Park Service employee has also retired. If KNHAP couldn't manage adversity in 2021, how were they to manage a 49 county NHA coupled with a cumbersome management plan?
