1 AN ACT concerning the distribution of the levy on fire insurance business
2 premiums; relating to the state fire marshal fee fund, the emergency
3 medical services operating fund and the fire training service program
4 fund; modifying the distribution of moneys thereof; amending K.S.A.
5 75-1514 and repealing the existing section.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 75-1514 is hereby amended to read as follows: 75-
9 1514. (a) The commissioner of insurance shall remit all moneys received
10 by the commissioner under ~~subsection (a) of K.S.A. 75-1508, and~~
11 amendments thereto, to the state treasurer in accordance with the
12 provisions of K.S.A. 75-4215, and amendments thereto. The state treasurer
13 shall credit 10% of each such deposit to the state general fund, *up to an*
14 *aggregate amount not to exceed \$100,000 in each fiscal year*; and shall
15 credit the remainder of each such deposit ~~to the fire marshal fee fund as~~
16 *follows:*

17 (1) *64% to the fire marshal fee fund established pursuant to this*
18 *section;*

19 (2) *20% to the emergency medical services operating fund*
20 *established pursuant to K.S.A. 65-6151, and amendments thereto; and*

21 (3) *16% to the fire service training program fund established*
22 *pursuant to K.S.A. 76-327c, and amendments thereto.*

23 (b) There is hereby created the fire marshal fee fund in the state
24 treasury. All expenditures from the fire marshal fee fund shall be made in
25 accordance with appropriation acts upon warrants of the director of
26 accounts and reports issued pursuant to vouchers approved by the state fire
27 marshal or a person or persons designated by the state fire marshal.

28 (c) ~~The commissioner of insurance shall remit all moneys received by~~
29 ~~the commissioner under subsection (b) of K.S.A. 75-1508, and~~
30 ~~amendments thereto, to the state treasurer in accordance with the~~
31 ~~provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of~~
32 ~~each such remittance, the state treasurer shall deposit the entire amount in~~
33 ~~the state treasury to the credit of the emergency medical services board~~
34 ~~operating fund.~~*The amount that is credited to the state general fund*
35 *pursuant to subsection (a) shall be to reimburse the state general fund for*
36 *accounting, auditing, budgeting, legal, payroll, personnel and purchasing*

1 *services and any other governmental services that are performed on*
2 *behalf of the state fire marshal, the emergency services medical board and*
3 *the fire service training program of the university of Kansas by other state*
4 *agencies that receive appropriations from the state general fund to provide*
5 *such services.*

6 ~~(d) The commissioner of insurance shall remit all moneys received by~~
7 ~~the commissioner under subsection (e) of K.S.A. 75-1508, and~~
8 ~~amendments thereto, to the state treasurer in accordance with the~~
9 ~~provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of~~
10 ~~each such remittance, the state treasurer shall deposit the entire amount in~~
11 ~~the state treasury to the credit of the fire service training program fund.~~

12 Sec. 2. K.S.A. 75-1514 is hereby repealed.

13 Sec. 3. This act shall take effect and be in force from and after its
14 publication in the statute book.
