RE: K.S.A. 79-2989—Certification for reimbursement of printing and postage costs

Pursuant to K.S.A. 79-2989, for calendar years 2022 and 2023, if a county clerk incurred printing and/or postage costs pursuant to K.S.A. 79-2988, the county clerk may seek reimbursement by providing documentation of such costs to the Secretary of Revenue. The Secretary of Revenue shall certify the amount of moneys attributable to such costs and shall transmit a copy of such certification to the Director of Accounts and Reports.

Upon receipt of such certification, the Director of Accounts and Reports shall transfer the certified amount from the State General Fund to the Taxpayer Notification Costs Fund of the Department of Revenue.

For calendar year 2022, \$1,087,971 payable to 92 counties has been certified as allowable costs under K.S.A. 79-2989. A list of reimbursements processed by county is attached.
