1 AN ACT concerning emergency communication services; relating to the
2 Kansas 911 act; authorizing counties to contract with other counties to
3 share services of 911 public safety answering points; authorizing
4 distributions of 911 fee moneys to counties for such purposes;
5 amending K.S.A. 12-5364, 12-5368, 12-5374, 12-5375 and 12-5377
6 and repealing the existing sections.
7

8 *Be it enacted by the Legislature of the State of Kansas:*

9 Section 1. K.S.A. 12-5364 is hereby amended to read as follows: 12-
10 5364. (a) (1) There is hereby created the 911 coordinating council which
11 shall monitor the delivery of 911 services, develop strategies for future
12 enhancements to the 911 system and distribute available grant funds to
13 PSAPs *and counties that contract with another county for the provision of*
14 *911 services*. In as much as possible, the council shall include individuals
15 with technical expertise regarding 911 systems, internet technology and
16 GIS technology.

17 (2) (A) The 911 coordinating council shall consist of 13 voting
18 members to be appointed by the governor:

19 (i) Two members representing information technology personnel
20 from government units;

21 (ii) one member representing the Kansas sheriff's association;

22 (iii) one member representing the Kansas association of chiefs of
23 police;

24 (iv) one member representing a fire chief;

25 (v) one member recommended by the adjutant general;

26 (vi) one member recommended by the Kansas emergency medical
27 services board;

28 (vii) one member recommended by the Kansas commission for the
29 deaf and hard of hearing;

30 (viii) two members representing PSAPs located in counties with less
31 than 75,000 in population;

32 (ix) two members representing PSAPs located in counties with
33 greater than 75,000 in population; and

34 (x) one member representing the Kansas chapter of the association of
35 public safety communications officials.

36 (B) At least two of the members representing PSAPs shall be

1 administrators of a PSAP or have extensive prior 911 experience in
2 Kansas.

3 (3) Other voting members of the 911 coordinating council shall
4 include:

5 (A) One member of the Kansas house of representatives as appointed
6 by the speaker of the house;

7 (B) one member of the Kansas house of representatives as appointed
8 by the minority leader of the house;

9 (C) one member of the Kansas senate as appointed by the senate
10 president; and

11 (D) one member of the Kansas senate as appointed by the senate
12 minority leader.

13 (4) The 911 coordinating council shall also include nonvoting
14 members to be appointed by the governor:

15 (A) One member representing rural telecommunications companies
16 recommended by the Kansas rural independent telephone companies;

17 (B) one member representing incumbent local exchange carriers with
18 over 50,000 access lines;

19 (C) one member representing large wireless providers; one member
20 representing VoIP providers;

21 (D) one member recommended by the league of Kansas
22 municipalities;

23 (E) one member recommended by the Kansas association of counties;

24 (F) one member recommended by the Kansas geographic information
25 systems policy board;

26 (G) one member recommended by the Kansas office of information
27 technology services;

28 (H) one member, a Kansas resident, recommended by the Mid-
29 America regional council; and

30 (I) two members representing non-traditional PSAPs, one of whom
31 shall be a representative of tribal government.

32 (b) (1) ~~Except as provided in subsection (b)(2) and (b)(3), the terms~~
33 ~~of office for Voting members of the 911 coordinating council shall~~
34 ~~commence on the effective date of this act and shall be subject to~~
35 ~~reappointment every~~ *serve for a term of three years.* No voting member
36 shall serve longer than two successive three-year terms. A voting member
37 appointed as a replacement for another voting member may finish the term
38 of the predecessor and may serve two additional successive three-year
39 terms. *This paragraph shall not apply to members appointed pursuant to*
40 *subsection (a)(3).*

41 (2) ~~The following members, whose terms began on the effective date~~
42 ~~of this act, shall serve initial terms as follows:~~

43 (A) ~~One member representing information technology personnel from~~

1 government units, one member recommended by the adjutant general, one
2 member representing PSAPs located in counties with less than 75,000 in
3 population and one member representing PSAPs located in counties with
4 75,000 or more in population shall serve a term of two years;

5 ~~(B) one member representing information technology personnel from~~
6 ~~government units, one member recommended by the Kansas emergency~~
7 ~~medical services board, one member representing PSAPs located in~~
8 ~~counties with less than 75,000 in population and one member representing~~
9 ~~PSAPs without regard to size shall serve a term of three years; and~~

10 ~~(C) one member representing a fire chief, one member recommended~~
11 ~~by the Kansas commission for the deaf and hard of hearing, one member~~
12 ~~representing the Kansas association of chiefs of police and one member~~
13 ~~representing PSAPs located in counties with 75,000 or more in population~~
14 ~~shall serve a term of four years.~~

15 ~~(3) The initial term for one member representing the Kansas sheriff's~~
16 ~~association shall begin on July 1, 2014, and be for a period of three years.~~

17 ~~(4) The terms of members specified in this subsection shall expire on~~
18 ~~June 30 in the last year of such member's term.~~

19 (c) (1) The governor shall select the chair of the 911 coordinating
20 council, who shall serve at the pleasure of the governor and have extensive
21 prior 911 experience in Kansas.

22 (2) The chair shall serve as the coordinator of E-911 services and next
23 generation 911 services in the state, implement statewide 911 planning,
24 have the authority to sign all certifications required under 47 C.F.R. part
25 400 and administer the 911 federal grant fund and 911 state maintenance
26 fund. The chair shall serve subject to the direction of the council and
27 ensure that policies adopted by the council are carried out. The chair shall
28 serve as the liaison between the council and the LCPA. The chair shall
29 preside over all meetings of the council and assist the council in
30 effectuating the provisions of this act.

31 (d) The 911 coordinating council, by an affirmative vote of nine
32 voting members, shall select the local collection point administrator,
33 pursuant to K.S.A. 12-5367, and amendments thereto, to collect 911 fees
34 and to distribute such fees to PSAPs *and counties that contract with*
35 *another county for the provision of 911 services* and to distribute 911
36 operations fund moneys and 911 state grant fund moneys as directed by
37 the council. The council shall adopt rules and regulations for the terms of
38 the contract with the LCPA. All contract terms and conditions shall satisfy
39 all contract requirements as established by the secretary of administration.
40 The council shall determine the compensation of the LCPA who shall
41 provide the council with any staffing necessary in carrying out the
42 business of the council or effectuating the provisions of this act. The
43 moneys used to reimburse these expenses shall be paid from the 911

1 operations fund, pursuant to subsection (j).

2 (e) (1) The 911 coordinating council is hereby authorized to adopt
3 rules and regulations necessary to effectuate the provisions of this act,
4 including, but not limited to:

5 (A) Creating a uniform reporting form designating how moneys,
6 including 911 fees, have been spent by the PSAPs *and counties that*
7 *contract with another county for the provision of 911 services*;

8 (B) requiring service providers to notify the council pursuant to
9 subsection (k);

10 (C) establishing standards for coordinating and purchasing
11 equipment;

12 (D) recommending standards for general operations training of PSAP
13 personnel;

14 (E) establishing training standards and programs related to the
15 technology and operations of the NG911 hosted solution;

16 (F) establishing data standards, maintenance policies and data
17 reporting requirements for GIS data; and

18 (G) assessing civil penalties pursuant to subsection (m).

19 (2) The chair of the council shall work with the council to adopt rules
20 and regulations necessary for the administration of this act, but the council
21 shall not adopt any rules and regulations or impose any requirements that
22 creates a mandatory certification program of PSAP operations or PSAP
23 emergency communications personnel.

24 (f) If the 911 coordinating council finds that the GIS data for a PSAP
25 *or county that contracts with another county for the provision of 911*
26 *services* is inaccurate or has not been updated for one year or more, the
27 council shall give written notice to the governing body that oversees the
28 PSAP *or county*. If, within 60 days of providing such notice, the council
29 does not receive an acceptable proposal for the PSAP *or county* to bring
30 the GIS data into compliance, the council may contract with a third party
31 to review and update the GIS data. A PSAP *or county* with GIS data that
32 has not been updated for one year or more may provide a certification
33 attesting that the GIS data has been reviewed and remains accurate. If the
34 council receives such certification and has information that the data may
35 not be accurate, the council shall provide a written notice to the PSAP *or*
36 *county* that describes the areas the council believes to be inaccurate and a
37 deadline of 30 days for the PSAP *or county* to submit updated GIS data. If
38 the updated GIS data is not received within the deadline, the council may
39 contract with a third party to review and update the GIS data. The council
40 shall assess the governing body that oversees the PSAP *or county* for any
41 costs incurred in updating the GIS data.

42 (g) The council may, pursuant to rules and regulations, lower the 911
43 fee established pursuant to K.S.A. 12-5369, and amendments thereto, upon

1 a finding based on information submitted on the uniform reporting forms,
2 that moneys generated by such fee are in excess of the costs required to
3 operate PSAPs in the state.

4 (h) The council may appoint subcommittees as necessary to
5 administer grants, oversee collection and distribution of moneys by the
6 LCPA, develop technology standards, develop training recommendations
7 and other issues as deemed necessary by the council. Subcommittees, if
8 appointed, shall include members of the council and other persons as
9 needed.

10 (i) The council may reimburse independent contractors or state
11 agencies for expenses incurred in carrying out the business of the council,
12 including salaries, that are directly attributable to effectuating the
13 provisions of this act. The moneys used to reimburse these expenses shall
14 be paid from the 911 operations fund, pursuant to subsection (j).

15 (j) All expenses related to the council shall be paid from the 911
16 operations fund. No more than 2.0% of the total receipts from providers
17 and the department received by the LCPA shall be used to pay for
18 administrative expenses of the council. Members of the council and other
19 persons appointed to subcommittees by the council may receive
20 reimbursement for meals and travel expenses, but shall serve without other
21 compensation with the exception of legislative members who shall receive
22 compensation pursuant to K.S.A. 75-3212, and amendments thereto.

23 (k) Every provider shall submit contact information for the provider
24 to the council. Any provider that has not previously provided wireless
25 telecommunications service in this state shall submit contact information
26 for the provider to the council within three months of first offering
27 wireless telecommunications services in this state.

28 (1) (1) Each PSAP *or county that contracts with another county for*
29 *the provision of 911 services* shall file an annual report with the council by
30 March 1 of each year demonstrating how such PSAP *or county* has spent
31 the moneys ~~earned from the 911 fee~~ *distributed by the LCPA to the PSAP*
32 *or county* during the preceding calendar year. The council shall designate
33 the content and form of such report and any associated documentation that
34 is required to finalize such report.

35 (2) If a PSAP *or county that contracts with another county for the*
36 *provision of 911 services* fails to file and finalize an annual report, the
37 council shall provide notice of such failure to the PSAP ~~and~~, the governing
38 body of such PSAP *and, if applicable, to the county*. If such PSAP *or*
39 *county* fails to file or finalize an annual report within 60 days of receiving
40 such notice, 10% of each subsequent distribution of 911 fees to such PSAP
41 *or county* pursuant to K.S.A. 12-5373, and amendments thereto, shall be
42 withheld by the LCPA and only distributed to such PSAP *or county* once
43 the report has been submitted.

1 (m) The council, upon a finding that a provider has violated any
2 provision of this act, may impose a civil penalty. No civil penalty shall be
3 imposed pursuant to this section except upon the written order of the
4 council. Such order shall state the violation, the penalty to be imposed and
5 the right of such person to appeal to a hearing before the council. Any such
6 person may, within 15 days after service of the order, make a written
7 request to the council for a hearing thereon. Hearings under this subsection
8 shall be conducted in accordance with the provisions of the Kansas
9 administrative procedure act.

10 (n) Any action of the council pursuant to subsection (m) is subject to
11 review in accordance with the Kansas judicial review act.

12 (o) Any civil penalty recovered pursuant to this section shall be
13 transferred to the LCPA for deposit in the 911 state grant fund.

14 (p) The 911 coordinating council shall make an annual report, to
15 include a detailed description of all expenditures made from 911 fees
16 received by the PSAPs *and counties*, to the house committee on energy,
17 utilities and telecommunications and the senate committee on utilities.

18 Sec. 2. K.S.A. 12-5368 is hereby amended to read as follows: 12-
19 5368. (a) Upon the approval of the 911 coordinating council, the LCPA
20 shall establish the following funds, which shall not be a part of the state
21 treasury: (1) The 911 state fund for the collection and distribution of 911
22 fees; (2) the 911 operations fund for administrative costs of the 911
23 coordinating council and deployment and maintenance of the statewide
24 NG911 system; and (3) the 911 state grant fund for grants to individual
25 PSAPs. All moneys originating from 911 fees, and any interest accrued on
26 such fees, shall be paid to the LCPA for deposit in the 911 state fund or
27 911 operations fund pursuant to subsection (b). All unobligated federal
28 moneys, and any interest accrued on such moneys, shall be transferred to
29 the 911 federal grant fund.

30 (b) (1) Except as provided for in paragraph (2), prior to the
31 ~~distribution to the PSAPs~~ *distributions* pursuant to K.S.A. 12-5374, and
32 amendments thereto, the LCPA shall withhold \$.23 from every 911 fee
33 remitted pursuant to K.S.A. 12-5369, and amendments thereto, and shall
34 deposit such amount in the 911 operations fund for the deployment and
35 maintenance of the statewide NG911 system and standardized
36 functionality upgrades to that system.

37 (2) If the funds withheld from distribution pursuant to paragraph (1)
38 exceed 15% of the total receipts received by the LCPA from providers and
39 the department over the prior three years, such funds in excess of that 15%
40 total shall be deposited in the 911 state grant fund and used for PSAP
41 grants based on demonstrated need pursuant to subsection (d).

42 (3) If the balance in the 911 state grant fund is less than \$2,000,000,
43 prior to the ~~distribution to the PSAPs~~ *distributions* pursuant to K.S.A. 12-

1 5374, and amendments thereto, the LCPA shall withhold \$.01 from every
2 911 fee remitted pursuant to K.S.A. 12-5369, and amendments thereto, and
3 shall deposit such amount in the 911 state grant fund. If the balance in the
4 911 state grant fund exceeds \$2,000,000, the LCPA shall not withhold such
5 amount.

6 (c) The council shall be responsible for ensuring that the 911
7 operations fund and the 911 state grant fund and any interest earned on
8 money credited to the fund is only expended for the following purposes:
9 (1) Projects involving the development and implementation of next
10 generation 911 services; (2) costs associated with PSAP consolidation or
11 cost-sharing projects; (3) expenses related to the 911 coordinating council;
12 (4) costs of audits conducted pursuant to K.S.A. 12-5377, and amendments
13 thereto; and (5) other costs pursuant to K.S.A. 12-5375, and amendments
14 thereto.

15 (d) The council shall develop criteria ~~for PSAPs~~ for eligible
16 purchases and for grant applicants and make the final determination as to
17 the distribution of grant funds. Such criteria shall promote the procurement
18 of equipment that meets open architecture and national technical
19 standards. Distribution of grant funds shall not include expenditures to
20 procure, maintain or upgrade subscriber radio equipment.

21 (e) The LCPA shall be authorized to maintain an action to collect any
22 funds owed by any providers in the district court in the county of the
23 registered office of such provider or, if such provider does not have a
24 registered office in the state, such an action may be maintained in the
25 county where such provider's principal office is located. If such provider
26 has no principal office in the state, such an action may be maintained in
27 the district court of any county in which such provider provides service.

28 Sec. 3. K.S.A. 12-5374 is hereby amended to read as follows: 12-
29 5374. (a) (1) Except for the amounts withheld by the LCPA pursuant to
30 K.S.A. 12-5368(b), and amendments thereto, and any amounts withheld
31 pursuant to K.S.A. 12-5364(l), and amendments thereto, not later than 30
32 days after the receipt of ~~moneys~~ 911 fees from providers pursuant to
33 K.S.A. 12-5370 ~~and 12-5371~~, and amendments thereto, and *prepaid*
34 *wireless 911 fees* from the department pursuant to K.S.A. 12-5372, and
35 amendments thereto, the LCPA shall distribute such moneys to the PSAPs
36 *or to counties pursuant to this section*. The amount of money distributed to
37 the PSAPs in each county, *or to any county that does not have a PSAP*
38 *located in such county and contracts with a PSAP for the provision of 911*
39 *services*, shall be based upon the amount of 911 fees collected from service
40 users located in that county, based on place of primary use information
41 provided by the providers, by using the following distribution method:

 8 (2) ~~There shall be a minimum county distribution of \$60,000 and no~~
 9 ~~county shall receive less than \$60,000 of direct distribution moneys~~*If the*
 10 *calculated amount for distribution within a county is less than \$60,000,*
 11 *then \$60,000 shall be distributed for services within that county.*

12 (3) *If there is a single PSAP providing services within a county, such*
 13 *PSAP shall receive the county's distribution. If there is more than one*
 14 *PSAP in a county, then ~~the direct distribution allocated to that county by~~*
 15 *population shall be deducted from the minimum county distribution and*
 16 *the difference distributions to each PSAP shall be proportionately divided*
 17 *between the PSAPs in the county based on the population of the area each*
 18 *PSAP serves.*

19 (4) *A county may contract with another county for the provision of*
 20 *some or all of a county's PSAP services. If a county serves as the provider*
 21 *of PSAP services for another county, both counties shall enter into a*
 22 *contract or memorandum of agreement that addresses contingency plans*
 23 *and overflow arrangements. Any such contract or memorandum of*
 24 *agreement shall be approved by the council prior to the effective date of*
 25 *the contract or memorandum of agreement. Any county contracting with*
 26 *another county to have such other county provide all PSAP services for*
 27 *the county shall request the LCPA to distribute a portion of not less than*
 28 *50% of such county's direct distribution amount to the county with which*
 29 *it is contracting for services.*

30 (5) All moneys remaining after distribution, moneys withheld
 31 pursuant to K.S.A. 12-5368(b)(1), and amendments thereto, and any
 32 moneys that cannot be attributed to a specific PSAP *or county* shall be
 33 transferred to the 911 operations fund.

34 (b) All fees remitted to the LCPA shall be deposited in the 911 state
 35 fund and for the purposes of this act be treated as if they are public funds,
 36 pursuant to article 14 of chapter 9 of the Kansas Statutes Annotated, and
 37 amendments thereto.

38 (c) All moneys in the 911 state fund that have been collected from the
 39 prepaid wireless 911 fee shall be deposited in the 911 operations fund
 40 unless \$3 million of such moneys have been deposited in any given year,
 41 then all remaining moneys shall be distributed to the counties in an amount
 42 proportional to each county's population as a percentage share of the
 43 population of the state. ~~For each PSAP within~~ *If there is more than one*
 44 *PSAP in a county, such moneys shall be distributed to each PSAP in an*
 45 *amount proportional to the PSAP's population as a percentage share of the*

1 population of the county. If there is no PSAP within a county, then such
 2 moneys shall be distributed to the ~~PSAP providing service to such county~~
 3 *that contracts with a PSAP for the provision of 911 services pursuant to*
 4 *K.S.A. 12-5375, and amendments thereto.* ~~Such~~ Moneys distributed to
 5 counties and PSAPs *pursuant to this section* only shall be used for the uses
 6 authorized in K.S.A. 12-5375, and amendments thereto.

7 (d) The LCPA shall keep accurate accounts of all receipts and
 8 disbursements of moneys from the 911 fees.

9 (e) ~~Information~~Records provided by ~~providers~~ *any provider* to the
 10 ~~local collection point administrator~~ LCPA or to the 911 coordinating
 11 council pursuant to this act ~~will~~ *shall* be treated as proprietary records ~~that~~
 12 ~~will and shall~~ be withheld from the public upon request of the ~~party~~
 13 *provider* submitting such records.

14 Sec. 4. K.S.A. 12-5375 is hereby amended to read as follows: 12-
 15 5375. (a) (1) The ~~proceeds of the 911 fees imposed pursuant to this act~~
 16 *moneys distributed to counties and PSAPs pursuant to K.S.A. 12-5374,*
 17 *and amendments thereto,* and any interest earned on revenue derived from
 18 such ~~fee moneys~~, shall be used only for necessary and reasonable costs
 19 incurred or to be incurred by PSAPs for:

- 20 ~~(A)~~(A) Implementation of 911 services;
- 21 ~~(B)~~(B) purchase of 911 equipment and upgrades;
- 22 ~~(C)~~(C) maintenance and license fees for 911 equipment;
- 23 ~~(D)~~(D) training of personnel, not to include salaries;
- 24 ~~(E)~~(E) monthly recurring charges billed by service suppliers;
- 25 ~~(F)~~(F) installation, service establishment and nonrecurring start-up
 26 charges billed by the service supplier;
- 27 ~~(G)~~(G) charges for capital improvements and equipment or other
 28 physical enhancements to the 911 system; or
- 29 ~~(H)~~(H) the original acquisition and installation of road signs designed
 30 to aid in the delivery of emergency service.

31 (2) Such costs shall not include expenditures to lease, construct,
 32 expand, acquire, remodel, renovate, repair, furnish or make improvements
 33 to buildings or similar facilities. Such costs shall also not include
 34 expenditures to purchase, procure, maintain or upgrade subscriber radio
 35 equipment.

36 (b) The 911 coordinating council shall, pursuant to rules and
 37 regulations, establish a process for a PSAP *or county*, at the discretion of
 38 the PSAP *or county*, to seek pre-approval of an expenditure. The council
 39 shall respond in writing to any pre-approval request within 30 days and
 40 inform the PSAP *or county* if the requested expenditure is approved or
 41 disapproved. If the expenditure is disapproved, the written notification
 42 shall state the reason for the disapproval and such PSAP *or county* may,
 43 within 15 days after service of the notification, make a written request to

1 the council to appeal the council's decision and for a hearing to be
2 conducted in accordance with the provisions of the Kansas administrative
3 procedure act.

4 (c) The 911 coordinating council shall annually review expenditures
5 of 911 ~~funds~~ *moneys* reported on the annual report for each PSAP *and*
6 *county* and shall appoint a committee to review such expenditures. If the
7 committee determines that a reported expenditure was not authorized by
8 this act, the committee shall request that the expenditure be refunded by
9 the PSAP to the PSAP's *or county's* 911 *fee fund* account. If a PSAP *or*
10 *county* does not concur with the finding of the committee, the PSAP *or*
11 *county* may request a review of the decision of the committee before the
12 911 coordinating council. If the 911 coordinating council, based upon
13 information obtained from an audit of ~~the PSAPs~~ *any PSAP or county*,
14 determines that any PSAP *or county* has used any 911 fees for any purpose
15 other than those authorized in this act, the governing body for such PSAP
16 *or county* shall repay all such moneys used for any unauthorized purposes
17 to the 911 fee fund *account* of such PSAP *or county*. Upon a finding that
18 the expenditure was made intentionally from the 911 fee fund *account* of
19 such PSAP *or county* for a purpose clearly established as an unauthorized
20 expenditure, the 911 coordinating council may require such PSAP *or*
21 *county* to pay the lesser of \$500 or 10%, of such misused moneys, to the
22 LCPA for deposit in the 911 state grant fund. No such repayment of 911
23 fees shall be imposed pursuant to this section except upon the written
24 order of the council. Such order shall state the unauthorized purposes for
25 which the funds were used, the amount of funds to be ~~repayed~~ *repaid* and
26 the right of such PSAP *or county* to appeal to a hearing before the Kansas
27 office of administrative hearings. Any such PSAP *or county* may, within
28 15 days after service of the order, make a written request to the council for
29 a hearing thereon. Hearings under this subsection shall be conducted in
30 accordance with the provisions of the Kansas administrative procedure act.

31 (d) Any final action of the council pursuant to subsection (b) or (c) is
32 subject to review in accordance with the Kansas judicial review act.

33 Sec. 5. K.S.A. 12-5377 is hereby amended to read as follows: 12-
34 5377. (a) The receipts and disbursements of the LCPA shall be audited
35 yearly by a licensed municipal accountant or certified public accountant.

36 (b) The LCPA may require an audit of any provider's books and
37 records concerning the collection and remittance of fees pursuant to this
38 act. The cost of any such audit shall be paid from the 911 operations fund.

39 (c) (1) On or before December 31, 2018, and at least once every five
40 years thereafter, the division of post audit shall conduct an audit of the 911
41 system to determine:

42 (A) Whether the moneys received by PSAPs *and counties* pursuant to
43 this act are being used appropriately;

1 (B) whether the amount of moneys collected pursuant to this act is
2 adequate; and

3 (C) the status of 911 service implementation.

4 (2) The auditor to conduct such audit shall be specified in accordance
