## **2024 Session Deadlines**

The following dates are the deadlines for introduction and consideration of bills for the 2024 session. These deadlines were adopted as part of the Joint Rules of the Senate and House of Representatives for the 2023-24 biennium.

#### Monday, January 29<sup>th</sup>

Last day for member or members to REQUEST bill drafts from Revisor's office.

# Monday, February 5th

Last day for <u>non-exempt Committees</u> to REQUEST bill drafts from the Revisor's office. NOTE: This is the last day requests for introduction can be on non-exempt committee agendas.

#### Wednesday, February 7<sup>th</sup>

Last day for <u>Individuals</u> to INTRODUCE bills in originating chamber. NOTE: Bills must be submitted to chamber staff during daily session for Introduction.

## Friday, February 9<sup>th</sup>

Last day for <u>non-exempt Committees</u> to INTRODUCE bills in originating chamber. NOTE: Bills must be submitted to chamber staff during daily session for Introduction.

# Friday, February 23rd (Turnaround Day)

Last day to CONSIDER NON-EXEMPT BILLS IN HOUSE OF ORIGIN.

## Thursday, March 28<sup>th</sup> (Second Chamber Consideration)

Last day to CONSIDER non-EXEMPT BILLS NOT IN ORIGINATING CHAMBER.

## Friday, April 5<sup>th</sup> (First Adjournment)

No bills considered after this date except BILLS VETOED BY GOVERNOR, OMNIBUS APPROPRIATIONS ACT AND OMNIBUS RECONCILIATIONS SPENDING LIMIT BILL. Note: Subject to suspension motion pursuant to Joint Rule 4(k).

**Veto session** is anticipated to begin on April 29<sup>th</sup>. The House Appropriations and Senate Ways and Means committees will meet April 25<sup>th</sup> and 26<sup>th</sup>.

#### \*\*\*\*\*

**Exempt committees:** House and Senate Federal and State Affairs, Senate Ways and Means, Senate Assessment and Taxation, House committees on Calendar and Printing, Appropriations, Taxation or select committees of either house when so authorized. **Exempt bills** are those sponsored by, referred to or acted upon by an exempt committee.
